PERSONAL PROPERTY:

STEC is not responsible for any personal belongings brought to camp. If your child is bringing personal items to camp, please be sure to label items. If some items are necessary for your child's comfort during the day, please consult our staff.

Children need to be aware that toys from home may get broken at the center. STEC is not responsible for toys that break, get lost or stolen. If toys cause a problem, children will be asked to keep them in their bags. Weapons, including toy weapons, are not allowed during camp.

Outdoor Weather Safety Procedures:

In order to protect your child from the sun and insects, we ask that you apply sunscreen/bug spray before arriving. Staff will re- apply sunscreen/bug spray as needed. Parents should supply their own sunscreen/bug spray on if a child has skin sensitivity or allergies. We spend a lot of time outside!

Please make sure children are dressed appropriately for the weather. No sandals or open-toe shoes. Drinking water is always available. We also incorporate water into daily activities at most programs especially on really hot days. Please provide extra cloths for that purpose.

Visiting:

Parents are welcomed to visit anytime during operation hours.

Permission slip for release of child to authorized pick up.

It is a requirement that each child must be signed in and out by a parent or authorized parent representative every day in the Sign-in /Sign-out located on the entrance desk. The time and a full legal signature are required.

Children will be released only to individuals authorized on this form. **Any changes** in persons authorized to pick up your child must be submitted to the center **IN WRITING by the Parent**. Due to licensing regulations, a parent signature is required for changes. Phone and/or email authorizations will NOT be accepted.
