Mr. Hinojosa: "We picked up - I think there's a list there, Commissioner, on the backup."

Commissioner Sanchez: "Right. So, I mean how many people signed this versus the total of number of people that lived there is my question."

Mr. Hinojosa: "I don't have that amount Commissioner, but there's at least twenty on that street that have agreed to the reduction in speed limit."

Commissioner Sanchez: "But the twenty that live there..."

Mr. Hinojosa: "It's just for that road or that..."

Commissioner Sanchez: "How many people have to go through that road from other areas?"

Mr. Hinojosa: "Those are just the residents in the immediate..."

Judge Pro-Tem Dominguez: "Is this the area behind Titan?"

Mr. Hinojosa: "Yes, correct. We didn't pick them up for the whole, but the majority of the residents are requesting .... "

Commissioner Garza: "So, basically the Cities on both sides of this road?"

Mr. Hinojosa: "Correct. If the Court chooses to we'll reduce the speed from 30 to 20, but the surrounding

areas, I think, they're already 20 if I recollect correct."

Judge Pro-Tem Dominguez: "Only on Pine Falls Drive?"

Mr. Hinojosa: "Only on Pine Falls Drive and that's the way it's posted in the Public Hearing. So this is not for the entire Subdivision nor the areas; only for that request for that road and, again, because they do have children in the neighborhood and they have a safety concern, people driving too fast there and so their concerns are that. They believe that the, slowing down of the traffic benefits their residents in that road."

Judge Pro-Tem Dominguez: "They could also ask for speed bumps if they think that would help."

Mr. Hinojosa: "Well at this time that's what the request is and the Court can decide and if they would like to do that."

Judge Pro-Tem Dominguez: "I don't have a problem with this."

Mr. Charles Hoskins: "I do have a comment. I'm a resident of the area."

Judge Pro-Tem Dominguez: "Yes, sir."

Mr. Hoskins: "And on my street they actually put in a speed bump when some of the residents requested it, to reduce the speed. There is a subdivision on the other side and people coming through that subdivision - through our subdivision to get through theirs, or egress out of their subdivision, going through the streets and there are small children. I think it's relevant."

Judge Pro-Tem Dominguez: "What's your name, sir?"

Mr. Hoskins: "In the Pine Wood Subdivision. I think it's relevant."

Commissioner Sanchez: "Your name for the record? We are in a Public Hearing."

Mr. Hoskins: "Charles Hoskins. 925 Pine Bluff."

Judge Pro-Tem Dominguez: "That's on the list."

Mr. Hoskins: "Thank you."

Commissioner Sanchez: "This is a Public Hearing."

Mr. Mario Vicencio: "This request..."

Commissioner Sanchez: "Your name for the record?"

Mr. Vicencio: "I'm sorry, Mario Vicencio, sir. I live on Pine Falls Drive Street and thank you for holding this meeting here. I just want to add to my fellow neighbors that are here that this is just to protect or have some ordinance in the neighborhood, you know, to reduce speeders and to protect not only the speeders, but ourselves because ourselves tend to speed through there too. I wanted to add to that. It's not only for Pine Falls Drive. For me, I live in that street, but if you can or want you can put it on all streets. It's only about three streets. It's a start where we're at and this is where we're. Thank you."

Judge Pro-Tem Dominguez: "Thank You."

Commissioner Garza: "What do you recommend, Ernesto? Are you recommending just one street or because the Public Hearing is posted for the Subdivision."

Mr. Hinojosa: "Correct and I think the petition, and if you read the letter, says specifically for the residents of that street."

Commissioner Garza: "Pine Falls."

Judge Pro-Tem Dominguez: "Correct."

Mr. Hinojosa: "Yes, air, and I think we can come back if additional residents would want to have the same

request. We always come back and do that."

Commissioner Sanchez: "Well, but that's going to cost us money to post it again."

Mr. Hinojosa: "Well, that's correct."

Mr. David Garcia, Deputy County Administrator: "This is a Public Hearing for roads."

Commissioner Sanchez: "Within the Subdivision; so we can do the whole Subdivision."

Mr. Hinojosa: "Well it's up to the Court, but the way it's there it's for that particular road."

Judge Pro-Tem Dominguez: "What are the names of the other roads that are there?"

Commissioner Benavides: "Pine Bluff."

Mr. Hinojosa: "Well the Court can decide on that on the next Item."

Commissioner Sanchez: "Move to CLOSE Public Hearing if we don't have any other comments."

Commissioner Benavides: "Second."

Ms. Dylbia Jeffries-Vega, Legal Counsel: "Judge and Commissioners, the Notice does say - the Notice that was published does say for roads within the Subdivision."

Commissioner Benavides: "So we would be safe to do that."

Commissioner Garza: "What do you want Alex? Do you want one road or all of them?"

Judge Pro-Tem Dominguez: "I'm trying to look at the map here. So folks come in on Pineda Boulevard. Is that correct? And then from there they diverge to the different streets; Pine More, Pine Bluff, Pine Lake Circle and Pine Falls Drive."

Commissioner Sanchez: Are there children that live on all the roads or just this one?"

Mr. Hinojosa: "I don't know all the residences there."

Commissioner Garza: "Charles (Hoskins) does."

Mr. Hinojosa: "Probably he can speak to the persons that live in the neighborhood."

Commissioner Garza: "There's families. I'm sure."

Commissioner Sanchez: "I mean, of all the roads is the one we did a thoroughfare thru or..."

Mr. Hoskins: "The only road that would not be in question would be Pineda because that is an entry and there's only one lot there that has residents and it's a trailer and there's no children on that one, but once you enter the Subdivision itself, which would be the Pine Bluff, Pine More, etc., that's where the issue resides; where the children are. All streets have small children."

Judge Pro-Tem Dominguez: "Ernesto, is Pineda Boulevard part of that Subdivision, prior to it hitting Pine More Drive?"

Mr. Hoskins: "I could not tell you. The sign for the Subdivision does not show up until you get to almost where Pine More starts.

Judge Pro-Tem Dominguez: "I've been told by the residents there – I've gone out to go speak with them – they say that Pineda becomes 'drag race central' occasionally, but if it's not part of the Subdivision then we won't address that."

Mr. Hoskins: "If you drive up and down it, you'll see where people have been spinning their tires."

Judge Pro-Tem Dominguez: "And going in circles and it's a very wide street."

Mr. Hoskins: "It would be equivalent to like a six or seven lane highway. It's so wide across."

Commissioner Sanchez: "But it doesn't fall within this Subdivision?"

Mr. Hoskins: "I don't think so. It just feeds the Subdivision."

Judge Pro-Tem Dominguez: "If we were to address Pineda Boulevard, which we think is outside of this Subdivision, we could do that without having a Public Notice. Is that correct?"

Mr. Alex Sanchez, Assistant Staff Engineer: "That would be a separate Agenda Item that would be needed."

Commissioner Sanchez: "You have to Public Notice all these changes, right?"

Mr. Alex Sanchez: "Yes."

Commissioner Sanchez: "It would require a different Public Notice."

Mr. Alex Sanchez: "And part of it might be inside City limits."

Commissioner Garza: "Pineda? Part of it is inside?"

Mr. Alex Sanchez: "Yes."

Judge Pro-Tem Dominguez: "Part of it is."

Commissioner Sanchez: "What you can do though, if it's your Precinct, is go throw a road bump in there."

Commissioner Garza: "On the County side."

Judge Pro-Tem Dominguez: "In regards to the four streets that are within the Subdivision - Pine More

Drive, Pine Bluff Drive, Pine Lake Circle, Pine Falls Drive - of the representatives that are here to speak in the

Public Hearing, is it your wish that all of these streets be reduced to 20 mph? If not, that's fine too."

Mr. Hoskins: "Yes, it is."

Judge Pro-Tem Dominguez: "Is there any opposition to that?"

Sensing no public comments, Commissioner Sanchez motioned to CLOSE the Public Hearing.

The motion was seconded by Commissioner Benavides and carried unanimously.
