(V) HEARING ON THE APPEAL OF RICARDO HERRERA FROM THE SHERIFF'S DEPARTMENT APPEAL # 09-44-10-560.

Attorney Bruce Hodge appeared on behalf of the Sheriff's Department and Attorney John Curtis appeared on behalf of Ricardo Herrera. Serving as witnesses for this case were: Ricardo Herrera, Raul Enriquez, and Carlos Garza. The Commission allowed both parties to present their case, after consideration of the testimonial and documentary evidence presented by both parties the commission went into executive session at 1:15 p.m. to deliberate. After due deliberation of all materials presented during the hearing, the Commission gaveled back into open session at 2:35 p.m. Chairman Javier De Leon asked if there is a motion on the floor, Commissioner Mancha made a motion that the Commission find as follows: 1) that the misconduct as charged by the Sheriff's Office is true; 2) that the punishment imposed is excessive; 3) that the Appellant be reinstated effective the next appropriate pay period. Commissioner Garcia seconded the motion and Chairman De Leon asked for a vote. The motion was approved unanimously. It is therefore ORDERED that the allegations of misconduct be upheld as true, but that the discipline be modified to provider for reinstatement and with no award of back-pay as the appropriate level of discipline.

After consideration of the testimonial and documentary evidence, and arguments of counsel, the commission went into executive session to deliberate the case at 5:55 p.m. After due deliberation of all materials the Commission gaveled back into open session at 6:05 p.m. Chairman De Leon asked for a motion, Commissioner Garcia made a motion to uphold the termination to deny the appeal and to deny the jurisdictional issue raised by verbal motion. Commissioner Mancha seconded the motion, Chairman De Leon then called for a vote. The motion was approved unanimously, it is therefore ORDERED that the appeal of Deputy Rene Lara be DENIED in its entirety and the termination APPROVED. It is further ORDERED that the oral motion by Appellant Lara's counsel challenging the jurisdiction of the Commission is also DENIED. With no further business to come before the BOARD the meeting adjourned at 6:10 p.m.
