NOTICE TO CAMERON COUNTY RV GUESTS REGARDING 2020 - 2021 WINTER RESERVATIONS FOR ISLA BLANCA, ANDY BOWIE & ADOLPH THOMAE JR. COUNTY PARK STARTING ON FEBRUARY 19, 2020.

The Cameron County Parks & Recreation Department is pleased to announce that it will be accepting 2020 – 2021 Winter reservations (October thru April) starting on February 19, 2020. Reservations for Isla Blanca, Andy Bowie & Adolph Thomae Jr. County Park will now be available online at <https://reservations.go2gov.net/parks/go/CameronParks> starting at 8:00 p.m. Reservations by phone or in-person will be accepted the following day during normal business hours. Please find listed below the office hours and telephone numbers for each park along with some helpful tips for making an online reservation.

Helpful Online Reservation Tips:

- Making a reservation is as simple as entering the range of dates intended for your stay and selecting search. The park's map will then populate with the available sites for the selected dates. Once you choose your site you will be prompted to enter required fields of information followed by an option to secure your reservation with payment. When finished a transaction receipt will be sent to the email you've provided.
- For guests who know what site they desire, they can enter the date range of their intended stay and site number then select search. If the site is available the site will populate on

the parks map for selection. Follow the prompts to complete your reservation (see instructions above).

- For guests reserving a month or longer, it is important to note that 30 consecutive days constitutes a month, and is required to obtain the monthly rate. Anything less than 30 days will revert to a weekly rate, if a weekly rate applies. If a weekly rate does not apply, it will revert to the daily rate.
- Monthly reservations require full payment for the entire month. Multiple month reservations also require payment for one full month. Daily and weekly reservations require full payment for the entire stay.
- Please note that in order to make a reservation during the months of January & February; guests must reserve a minimum of 30 consecutive days in order for the reservation to be accepted. A weekly rate will NOT be available for these two months.
- Monthly or multiple month reservations spanning two seasons will be pro-rated to include the rates from each season.

20 RV sites have been set aside at Isla Blanca Park dedicated solely to daily rentals for the months of January and February only. These sites will be available for a maximum stay of two weeks. Because the availability of these sites is during the months of January and February, only a daily rate will apply to these sites. The following sites have been reserved for daily rental only:
