BID TABULATION COMMENTS/CLARIFICATIONS:

VALLEY CARPENTER: The Base Bid amount (\$113,068.00) entered on page 9 of the Bid Packet includes Add Alternate #1.

The correct Base Bid amount that should have been entered is \$79,448.00.

TEXAS ICON CONSTRUCTION: The Base Bid amount (\$153,538.00) entered on page 9 of the Bid Packet includes Add Alternate #1, and is calculated incorrectly.

The correct amount for the Base Bid plus Add Alternate #1 should have been \$153,583.00. The correct Base Bid amount that should have been entered is \$127,648.00.

DAVILA CONSTRUCTION, INC.: The Base Bid amount (\$203,056.00) entered on page 9 of the Bid Packet includes Add Alternate #1.

The correct Base Bid amount that should have been entered is \$159,306.00.

ARIZA GENERAL CONSTRUCTION: After careful review, it is our recommendation NOT to award Ariza Construction with the project. When compared to our preliminary estimates, Ariza's bid is nearly half of the estimated total. The 14-day timeline to complete is also drastically underestimated.
