OCTOBER TAX DISCOUNT EXTENDED UNTIL NOVEMBER 2, 2020

BROWNSVILLE, TEXAS — Cameron County Tax Assessor-Collector Antonio "Tony" Yzaguirre Jr. announced today that his offices will be accepting payments on November 2, 2020 with October 2020 effective dates.

Yzaguirre, stated, "October 31 happens to fall on a Saturday this year, this means Cameron County Taxpayers will have until the end of the following business day to pay their property taxes and receive the October effective date. This means any account receiving a 3% discount if paid in full October has until November 2, 2020 to pay or mail their payment and receive credit for October." In order to receive the discount the mail-in payment must be postmarked no later than Monday, November 2, 2020. Lone Star National Bank is also accepting payments for current Cameron County Tax Bills. A copy of your current 2020 Consolidated Tax Bill is required to utilize this service for the payment of current taxes only. Lone Star has six banking centers in Cameron County at the addresses located below that are also open on Saturday until 1:00 pm.

Taxpayers have been doing their part to pay their property taxes. The Cameron County Tax Office has collected over 128 million dollars of property taxes for the 2020 Tax Year. Our largest payments from mortgage companies have yet to post, and we expect a large amount of payments to be mailed by today. We are on track to have another great collection year.

Any taxpayer that doesn't take advantage of the extra day to pay will receive a two percent (2%) tax discount if paid in November, and one percent (1%) if paid in December. "All property taxes are due in January 2021 and become delinquent and subject to penalties and interest if not paid in full by February 1st, 2021," Yzaguirre said.
