### **NOTICE TO CAMERON COUNTY RV GUESTS REGARDING 2021 - 2022 WINTER RESERVATIONS FOR ISLA BLANCA, ANDY BOWIE & ADOLPH THOMAE JR. COUNTY PARK**

The Cameron County Parks & Recreation Department is pleased to announce that it will be accepting 2021 – 2022 Winter reservations (October '21 - April '22) starting on February 15, 2021. Reservations for Isla Blanca, Andy Bowie & Adolph Thomae Jr. County Park will first open-up online at <https://reservations.go2gov.net/parks/base/CameronParks/publicSite/taskSelection.faces> starting at 8:00 p.m. Reservations by phone or in-person will be accepted the following day during normal business hours. Due to COVID-19 restrictions, offices will only be able to process a limited amount of reservations in-person, so we strongly urge guests to make their reservations on-line or by phone. Please find listed below the office hours and telephone numbers for each park along with some helpful tips for making an online reservation.

#### Helpful Online Reservation Tips:

- Making a reservation is as simple as entering the range of dates intended for your stay and selecting search. Please keep in mind your checkout date does not occur until the following day after the “Last Night” of your reservation. The park’s map will then populate with the available sites for the selected dates. Once you choose your site you will be prompted to enter required fields of information followed by an option to secure your reservation with payment. When finished a transaction receipt will be sent to the email you’ve provided.

- For guests who know what site they desire, they can enter the date range of their intended stay and site number then select search. If the site is available the site will populate on the parks map for selection. Follow the prompts to complete your reservation (see instructions above).
- Please note that in order to make a reservation during the months of January & February, guests must reserve a minimum of 30 consecutive days in order for the reservation to be accepted. Weekly and/or daily reservations will NOT be available for these two months via the online reservation system.
- For guests reserving a month or longer, it is important to note that 30 consecutive days constitutes a month, and is required to obtain the monthly rate. Anything less than 30 days will revert to a weekly rate, if a weekly rate applies. If a weekly rate does not apply, it will revert to the daily rate, except for January and February.
- Monthly reservations require full payment for the entire month. Multiple month reservations also require payment for one full month. Daily and weekly reservations require full payment for the entire duration of the stay.
- Monthly or multiple month reservations spanning two seasons will be pro-rated to include the rates from each season.

12 RV sites have been set aside at Isla Blanca Park dedicated solely to daily rentals for the months of January and February. These sites will be available for a maximum stay of two weeks. Because the availability of these sites is during the months of January and February, only a daily rate will apply to these sites. The following sites have been reserved for daily rental only:

C-300 | C-301 | C-377 | C-378 | C-379 | C-380 | C-381 | C-382 | C-383 | C-384 | C-408 | C-409
