The 21 cases reported today raises the total number of COVID-19 cases to 41,309 in Cameron County. There have also been an additional 42 individuals who have recovered, raising the total number of recovered individuals to 38,790.

Cameron County Public Health has received notification of three (3) additional COVID-19 related deaths of Cameron County residents. This raises the total number of COVID-19 deaths in Cameron County to 1,665.
