## (2A) CONSIDERATION AND APPROVAL OF MINUTES FOR THE PREVIOUS SPECIAL MEETINGS

Commissioner Uhles motioned to approve the minutes as written and was seconded by Commissioner Alegria. Chairman De Leon asked for a vote and all voted "AYE". Therefore, the minutes for Special Meetings of June, 29 2020, were approved.

## (2B) HEARING ON THE APPEAL OF TERESITA MARTINEZ 21-114-10-560

Chief Deputy Robert Gracia appeared on behalf of Sheriff Eric Garza and Teresita appeared on behalf of herself. Serving as witnesses were Chief Deputy Robert Gracia and Teresita Martinez. Both parties presented their evidence and testimonies and after all was presented to the Civil Service Commission, the Commission went into executive session at 2:26 p.m. and gaveled back into open session at 3:01 p.m. Chairman De Leon asked for a motion and Commissioner Alegria motioned that the discipline be reversed and Ms. Martinez be reinstated effective July 26, 2021, which is consistent with a 75-day suspension to be written up as a "level 2 suspension" based on a evidence of a serious but not major offense. The reinstatement is not to include back pay and not interfere with longevity of employment with Cameron County. Chairman De Leon asked for second and Commissioner Uhles seconded the motion. Chairman De Leon asked for a vote; all voted "AYE" and the motion carried. With no further business to come before the Commission, the meeting adjourned at 3:02 p.m.
