

DANCY BUILDING, 1100 E. MONROE STREET, SECOND FLOOR, BROWNSVILLE, TEXAS.

1. CONSIDERATION AND AUTHORIZATION TO HOLD A PUBLIC HEARING OF THE CAMERON COUNTY HEALTHCARE FUNDING DISTRICT COMMISSION WITH THE INTENT OF REVIEWING A MANDATORY PAYMENT RATE FOR FISCAL YEAR 2025 AND TO ASSESS HOW THE MANDATORY PAYMENT REVENUE COLLECTED BY THE DISTRICT IS TO BE SPENT. (DJV-LEGAL)

2. CONSIDERATION AND POSSIBLE APPROVAL OF THE ANNUAL MANDATORY PAYMENT RATE, WHICH WILL BE COLLECTED QUARTERLY AS PER STATUTORY OPTION THAT WILL BE ASSESSED ON ALL INSTITUTIONAL HEALTHCARE PROVIDERS AND WILL BE BASED ON THE NET PATIENT REVENUE OF EACH INSTITUTIONAL HEALTHCARE PROVIDER AND HOW THE REVENUE DERIVED FROM THOSE PAYMENTS ARE TO BE SPENT.
