This proposal allows Child Nutrition Program - South Texas Cooperative (CNP-STC) members the ability to procure competitively solicited goods and/or services from vendors to provide food items, beverages, paper products, plastic goods, and other goods and/or services not available through other procurement means directly from manufacturers. Item descriptions, specifications and/or technical requirements and estimated quantities and pricing were competitively solicited and awarded. Region One ESC and its cooperative members are required to conduct a cost or price analysis for the procurement of goods and/or services not listed in the items tab, and within the scope of services offered with this bid solicitation. Cooperative members are responsible for the selection of goods and/or services available to meet their individual menu needs, nutrition goals, storage capabilities, and student preferences.

On May 25, 2022 Region One Education Service Center Purchasing Department, acting on behalf of its CNP-STC members, received twenty-four (24) responses to Manufacturer Direct Ship to District Warehouse Commercial Products RFP 23-AGENCY-000107. Proposals were evaluated to select the best qualified vendors based on the established criteria. Twenty-one (21) vendors were recommended for award. Vendors recommended for awarded had complete request for proposal submissions with an evaluation score of 70 or greater. Three (3) vendors are not recommended for award because the proposal submission was incomplete and/or had a score of less than 70. The term of this proposal is effective July 1, 2022 – June 30, 2023 with four (4) one-year extension options if all parties are in agreement.

On June 21, 2022 the Region One ESC Board of Directors met to review and approve the recommendations of the CNP-STC for award of Manufacturer Direct Ship to District Warehouse Commercial Products RFP 23-AGENCY-000107; effective July 1, 2022 through June 30, 2023 with the option to extend up to four (4) additional one-year periods if all parties are in agreement.

On April 18, 2023 the Region One ESC Board of Directors met to review and approve the recommendations of the CNP-STC for award of Manufacturer Direct Ship to District Warehouse Commercial Products RFP 23-AGENCY-000107, Extension 1 of 4; effective July 1, 2023 through June 30, 2024 with the option to extend up to three (3) additional one-year periods if all parties are in agreement.

On behalf of the CNP-STC membership, the current awarded vendors were offered the opportunity to utilize the second of four (4) one-year extension options for CNP-STC Manufacturer Direct Ship to District Warehouse Commercial Products RFP 23-AGENCY-000107, effective July 1, 2024 through June 30, 2025 with two (2) one-year extension options remaining if all parties are in agreement. All twenty-one (21) vendors agreed to the extension option and were recommended for award.

June 18, 2024, the Region One ESC Board of Directors met to review and approve the recommendations of the CNP-STC Manufacturer Direct Ship to District Warehouse Commercial Products RFP 23-AGENCY-000107, Extension 2 of 4.
