  manufactured homes shall be the responsibility of vendor/contractor.
- Specify the ramp and restrooms must comply with ADA requirements for both homes Both manufactured homes (2 or 4 bedroom) shall be build and comply with ADA (Handicap) requirements for restroom (shower) and entrance ramp.
