WRITTEN NOTICE TO THE PUBLIC AS REQUIRED BY SECTION 551.041

On May 31, 2016, Cameron County entered into an Owner/Architect/Engineer Agreement with Halff Associates Inc., wherein Halff Associates Inc. agreed to provide architecture and engineering services for the designs at Isla Blanca Park ("Project"). In a similar time period, Gignac & Associates agreed to provide architectural services for the design of the Project. On or about October 17, 2017, Cameron County entered into a written Standard Form of Agreement (Contract No. 2017C10319) with Noble Texas Builders to serve as the Contractor for the construction of the Project. Furthermore, the mentioned design professionals and contractor entered into contracts with additional parties to assist with the design and construction of the Project.

On August 15, 2022, WJE performed a site visit to investigate issues reported by Cameron County throughout the Project and to document existing conditions, including damage at the amphitheater area.

Cameron County and its consultants have determined the Project has sustained damage as the result of design and construction deficiencies. Cameron County seeks to pursue recovery of all damages from all responsible parties stemming from design and construction deficiencies at the Project. Cameron County's interest is in procuring properly designed and constructed buildings and related structures for use by the public in the Cameron County Parks system.

The subject matter concerns specialized capabilities with respect to construction litigation are outside the ordinary areas of practice of the attorneys with the Cameron County Civil Legal Division. Myles Garza, an attorney employed with Cameron County, suggested the law firm of Hamilton & Lucio, PC be retained due to his prior knowledge of their focus on representing clients in complex commercial litigation. Myles Garza was also aware that Erick Lucio, of Hamilton & Lucio, PC, is Board Certified in Construction Law by the Texas Board of Specialization. Myles Garza is also personally familiar with Erick Lucio's work ethic and reputation as an attorney in the legal community.

Hamilton & Lucio, P.C., has successfully handled several construction defect cases involving multimillion-dollar damages and employs a Texas Board of Legal Specialization — Construction Law attorney. The hourly rates ordinarily associated with work of this type has not been budgeted for and the risk associated with undertaking the representation justifies the contingency fee arrangement.

For all the above reasons, Cameron County finds that it is in the best interest of the residents of the County to enter into a contingency fee contract with Mr. Erick Lee Lucio, with Hamilton & Lucio, P.C., subject to review and approval by the Texas Attorney General's Office. Mr. Lucio is the only Texas Board Certified attorney in

Cameron County, Texas, for Construction Law that demonstrates the competence, qualifications, and experience necessary to litigate the Project. The relationship shall be limited in scope to an attorney-client relationship. This is also in compliance with Texas Government Code § 2254.1032.

This Written Notice to the Public is made on February 25, 2025, contemporaneous with potential action to be taken with respect to approval of a contingency fee contract with Mr. Erick Lee Lucio and shall be made part of the public record and attached to the minutes of the Cameron County Commissioners Court meeting of this date.
