1.- Request for clarification and/or questions:

- If I cannot bid on one or two, do I just leave that page blank and only quote what I have? Will my bid be considered if I only quote what I can deliver, and not all the vehicles listed? ANSWER: Vendors will be allowed to submit partial bids. Make sure you mark the categories you do not want to submit a bid with "N/A"
- Bed size for trucks just says standard and long, what is considered standard or long? 2. ANSWER: Standard means the "Regular Bed-Size" and the other option is the "Long-Bed" (Industry standards)
- 3. The tow package does not include the receiver and ball, because I do not know what size of ball you need, I am not sure which one to order and quote. ANSWER: Submit bid with "multi-size" receiver and ball.
- On page 22 "Public Works Signed Shop" there is verbiage that reads, "Includes service body on a flatbed". Which is the department wanting a Service Body OR a Flat Bed? ANSWER: As specified on page 21 of 71, "Service Body on a Flat-Bed"
