INFORMATION ON CIVIL SUITS

The Rules of Judicial Ethics prohibits this office from giving legal advice or hearing your case without the presence of the defendant or plaintiff. If you need legal counseling, we highly recommend any licensed Texas attorney. Your first meeting with the attorney is usually (but not always) free because the lawyer is trying to determine if they can be of service to you.

To begin your lawsuit:

- You need to complete the Civil Suit forms with the total dollar amount \$146.00
 (\$56.00 filing fee+ \$90.00 service fee) add \$90.00 for additional defendants. The first three forms need to be NOTARIZED.
 (CHECK, MONEY ORDER & EXACT CASH ACCEPTED/ CREDIT or DEBIT CARD A 5% IS ADDED)
- 2. Once the Civil Suit is filed, a citation is created and the defendant will be served. Defendant will have fourteen (14) day to file an answer to the court.
- 3. A hearing will approximately be between 60 to 90 days after the defendant is served with lawsuit.
- 4. In a civil suit any CORPORATION MUST BE REPRESENTED BY AN ATTORNEY.
- 5. Make sure to include court costs fees if you wish for them to be added to the remedy.
- 6. PROVIDE PHONE NUMBER & E-MAIL FOR all parties, Hearings will be done in person

REMEMBER, IT IS YOUR JOB TO PRESENT ANY EVIDENCE (RECEIPTS, JOURNALS, RECORDS, POLICE REPORTS, WITNESSES, ETC) TO PROVE YOUR CASE.

Any case involving an AUTO ACCIDENT in which damages were incurred, should have three (3) estimates of repair.
