ANSWER: Please see the attached specifications for glass clad polycarbonate type 60 and type 30

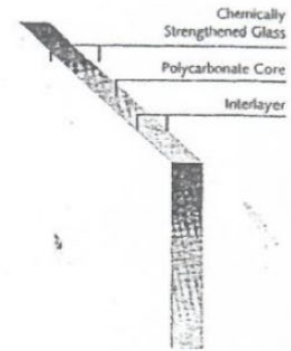

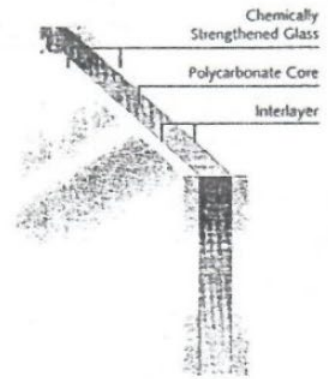
