(III) CONSIDERATION AND APPROVAL OF MINUTES FOR THE PREVIOUS SPECIAL MEETING.

Chairman De Leon asked if there is a motion to approve the minutes for the meeting held on March 13, 2017. Commissioner Uhles motioned to approve the minutes as written and was seconded by Commissioner Alegria. Chairman De Leon asked for a vote and all voted "AYE". (VI) RE-HEARING ON SANDRA ARMAS' MOTION TO HEAR APPEAL

Cameron County Attorney Juan Gonzalez appeared on behalf of Cameron County and moved to dismiss Sandra Armas' appeal for lack of jurisdiction. Roberto Mendoza represented Sandra Armas. Attorneys for each side presented their jurisdictional evidence and arguments. Serving as witnesses were the Civil Service Director, Gilberto Elizondo, Jr. and Civil Service Coordinator, Anthony Lopez. After each side rested, the Commission went into executive session at 3:00 p.m. and gaveled back into open session at 4:09 p.m. Chairman De Leon asked for a motion and Commissioner Uhles moved that the case be dismissed for lack of jurisdiction. Commissioner Alegria seconded the motion. Chairman De Leon asked for a vote and all voted "AYE". The Commission unanimously ordered the appeal dismissed for lack of jurisdiction.
