(1) PUBLIC COMMENTS

(1A) CIVIL SERVICE DIRECTOR'S REPORT

Gilberto Elizondo, Jr., Civil Service Director, informed the Commission of four pending appeals beginning with docket #17-94-10-560, #18-95-10-552, #18-96-10-512 and #18-97-10-512. No docket entries have been administratively dismissed since the last meeting of the Civil Service Commission on May 29, 2018.

(2A) CONSIDERATION AND APPROVAL OF MINUTES FOR THE PREVIOUS SPECIAL MEETING Commissioner Uhles asked if there is a motion to approve the minutes for the meetings held on May 25, 2018, and May 29, 2018.
