Bids are invited for several items and quantities of work as follows:

New Work – install new asphalt parking lot, cast-in-place concrete approach to a concrete boat ramp, timber boarding piers, articulated concrete block mat (ACBM) shore protection, clearing and grubbing, quarry spalls slope protection, rip-rap edge and toe protection, cast-in-place concrete abutments and fish cleaning stations, timber bollards, striping, concrete curb and drains.
