PART 1 GENERAL

1.01 SCOPE

- A. The work under this section includes the furnishing of all labor, material, equipment, supervision and services necessary for the execution and completion of all items necessary to provide a complete and functioning Outdoor Digital Marquee Sign, delivery and installation as herein specified.
- B. If a Bidder is unable to comply with any of the following specifications, the Bidder shall submit in writing the reason for noncompliance. Noncompliance with any specification is grounds for rejection of the entire bid. The buyer reserves the right to reject any bid which does not meet these specifications.
- C. Bids shall include all shipping, handling, delivery and installation fees and will have no hidden costs.
- D. Bids shall include explicit technical information regarding electrical requirements or special structural considerations or other accommodations required for the proper installation and operation of specified equipment.
- E. All Owner's materials, software, manuals, guides or other supplied information shall be presented in a neat, orderly, and professional manner using binders, folders or other devices as necessary.

1.02 RELATED DOCUMENTS:

- A. All provisions of the Specifications apply to the work of this section.

1.03 SUBMITTALS:

- A. Submit for approval; shop drawings and product data, including but not limited to:
 - 1. Provide diagrams, example photos, engineering drawings, and details as are available to properly illustrate the appearance and function of the proposed Outdoor Digital Marquee Sign.
 - 2. Electrical requirements, diagrams and specifications including specific detail regarding required power supply and final connections.
- B. Upon completion Outdoor Digital Marquee Sign vendor shall provide three (3) sets of equipment manuals and warranty documents for all equipment.

1.04 QUALITY ASSURANCE:

- A. Deliver, handle, store and install the Outdoor Digital Marquee Sign in accordance with manufacturer's approved printed instructions.

PART 2 PRODUCTS

2.01 MATERIALS

Cameron County is soliciting proposals of a Double Faced Illuminated Marquee, the design, product, wiring/cabling, and full installation for an outdoor LED digital marquee sign at the Cameron County San Benito Annex Building. The basic requirements for the sign are as follows:

- A. Electronic message board shall be 8' X 12' wide double faced, full color, illuminated wireless communications marquee visible from both sides of Expressway - both North & Southbound 20 feet tall, must include 2' X 12' aluminum illuminated sign with designated entity name and minimum 5 year warranty on parts and 2 years labor.
- B. Final Marquee Completion, installation, training and any software associated with this marquee must be completed no later than September 30th, 2018.
- C. Electronic message board shall be double-sided and include two full color electronic message centers with 281 trillion shades of color. The name panel is a 2'x12' Internally illuminated Embossed Lexan name sign finished in Black Blue and White with stylized lettering to read Cameron County San Benito Annex Building.
- D. Software shall be compatible and include still pictures and animated graphics with periodic graphics updates.
- E. Sign shall be internally illuminated with LED lighting and power supplies
- F. Time and temperature sensor shall be included.
- G. Communication shall be broadband with a data plan.
Provide for wireless communication system including hardware and software from the office to the sign.
- H. Resolution type shall be at least 16mm
- I. Design shall incorporate the Cameron County logo
- J. Entire structure shall be constructed to withstand up to meet Cameron County Coastal Zone windstorm requirements per Code, Windstorm inspections and certification of compliance must be included in the bid. Concrete foundation shall be determined as necessary relating to the height, weight, and size of the structure to be constructed as the manufacturing recommendation.

- K. Sign and structure shall be certified 100% weather proof
- L. Proposal shall include all necessary wiring, cabling, installation, start up, and training on use of software for the electronic sign
- M. Warranty shall include at a minimum 5 years on sign, sign components, structure, and 2 years labor.
- N. Proof of Insurance, bid bond, performance and payment bonds will be required
- O. Cameron County permit fee shall be included in proposal.
- P. An engineered foundation design is required and must be part of the proposal.
- D. Exposed structural steel must be painted.
- E. Clearing and grubbing, temporary construction fence, final clean, removal and disposal of all material, site grading, concrete, structural steel, electrical permitting should all be included in the bid.
- F. A complete turnkey working system is expected from the County, no exclusions in the proposal.
- G. Sales tax exemption certificate will be provided by Cameron County.

2.02 Warranty and Maintenance

- A. The double faced, illuminated LED sign shall come with a minimum of five (5) year parts and service warranty and a minimum of two (2) year labor warranty. Pricing for a five (5) year warranty should be included in the response. With the detailed warranty information, please include any maintenance program that is available from the proposing firm. Estimated response time for service and repairs should also be included.

Bidders shall include a rendering of the proposed design, detailed specifications on the type of electronic marquee sign being proposed, and total cost of project.
Sign shall be installed and fully operable.
Cameron County will evaluate proposals based on overall quality of the electronic Sign, software capabilities, design for displaying sign, ability to comply with Specifications outlined above and overall costs of project.

PART 3 EXECUTION

3.01 DELIVERY, STORAGE AND HANDLING

B. Contractor shall:

1. Provide labor and materials for electrical service, and final connections to Outdoor Digital Marquee Sign.
2. Provide instruction, specifications and supervision for all final electrical connections to be all equipment operational.
3. Install Outdoor Digital Marquee Sign per manufacturer's instructions in a professional, neat and timely manner.
4. Provide all accessories, controls and appurtenances to provide a fully functioning system.
5. All equipment shall be provided in the manufacturer's original sealed packaging and shall be clearly marked with the project name and number;
