



CAMERON COUNTY INVITATION FOR COMPETITIVE SEALED PROPOSALS

The County of Cameron will receive Competitive Sealed Proposals (CSP) for, **Public Works Precinct #1, #2, #3, #4, and Vehicle Maintenance Buildings Project**. CSPs must be received in the County Purchasing Department for each of the CSP **SEPARATE** packages as follows:

CSP # 170601 (Public Works Precinct #1 and Precinct #2) no later than **July 12, 2017 at 11:00am** (as per Purchasing Dept. time clock).

CSP # 170602 (Public Works Precinct #4 and Commissioners Office.) no later than **July 18, 2017 at 11:00am** (as per Purchasing Dept. time clock).

CSP # 170603 (Public Works Precinct #3 and Vehicle Maintenance Building) no later than **July 26, 2017 at 11:00am** (as per Purchasing Dept. time clock).

Attention is called to the fact that not less than, the federally determined prevailing (Davis-Bacon and Related Acts) wage rate, as issued by the Texas Department of Rural Affairs and contained in the contract documents, must be paid on this project. In addition, the successful proposer must ensure that employees and applicants for employment are not discriminated against because of race, color, religion, sex, age, or national origin. Cameron County reserves the right to reject any or all CSPs or to waive any informalities in the proposing. CSPs may be held by Cameron County for a period not to exceed (ninety) 90 days from the date of the CSP opening for the purpose of reviewing the CSPs and investigating the proposer's qualifications prior to the contract award.

All contractors/subcontractors that are debarred, suspended or otherwise excluded from or ineligible for participation on federal assistance programs may not undertake any activity in part or in full under this project.
