I. PURPOSE

III. GENERAL

Work on County premises by other than County employees is not to start prior to the suppliers providing proof of Insurance (as approved by County's Civil Legal Dept. – see attached) and attached to the Purchase Order form. Civil Legal Department will verify the insurers listed on the certificate is active in Texas and have a good rating, will also verify this information through Texas Department of Insurance and A.M. Best Ratings and Analysis Center, will verify that the date is current and Cameron County is listed as the certificate holder. Civil legal will e-mail Purchasing Department with the approval or rejection of Insurance prior to Purchase Order processing.
