THIS IS THE ONLY APPROVED INSTRUCTION FOR USE ON YOUR RFQ. ITEMS BELOW APPLY TO AND BECOME A PART OF TERMS AND CONDITIONS OF RFQ. ANY EXCEPTIONS THERETO MUST BE IN WRITING.

1. **ORIGINAL AND SIX (6) COPIES OF RFO's MUST BE SUBMITTED.** Each RFQ shall be placed in a separate envelope completely and properly identified with the name and number of the RFQ. RFQ's must be in the Purchasing Department BEFORE the hour and date specified.
2. RFQ's MUST give full firm name and address of the Proposer. Failure to manually sign RFQ will disqualify it. Person signing RFQ should show TITLE or AUTHORITY TO BIND THE FIRM IN A CONTRACT.

5. Written and verbal inquires pertaining to RFQ's must give RFQ Number and Company.
6. NO substitutions or cancellations permitted without written approval of Purchasing Agent.
7. The County reserves the right to accept or reject all or any part of any RFQ, waiver minor technicalities. The County of Cameron reserves the right to award by item category or by total RFQ. Prices should be itemized. County also reserves the right to award either with or without trade-in, if applicable. Cameron County retains the option to re-bid at any time if in its best interest and is not automatically bound to renewal or re-bid. The County reserves the right to add additional County Departments (at a later time during this bid award) as the need arises. The County also reserves the right to consider CO-OP Interlocal Agreements.
8. RFQ unit price on quantity specified – extend and show total. In case or errors in extension, UNIT prices shall govern. RFQs subject to unlimited price increase will not be considered.
9. This is a RFQ inquiry only and implies no obligation on the part of Cameron County.
10. Acceptance of and final payment for the item will be contingent upon satisfactory performance of the product received by Cameron County.
10. Partial RFQ's will not be accepted unless awarded by complete category or line item. **To be awarded by total RFQ.**
12. It is expected that the Proposer will meet all state and federal safety standards and laws in effect on the date of the RFQ for the item(s) being specified, and the particular use for which they are meant.

13. It is the responsibility of the Proposer or proposer to ask any and all questions the bidder or proposer feels to be pertinent to the RFQ or proposal. Cameron County shall not be required to attempt to anticipate such questions for bidders or proposers. Cameron County will endeavor to respond promptly to all questions asked.

PURCHASE ORDER AND DELIVERY: The successful Proposer shall not deliver products or provide services without a Cameron County Purchase Order, signed by an authorized agent of the Cameron County Purchasing Department.

INVOICES AND PAYMENTS: (a) Seller shall submit separate invoices, in duplicate, on each purchase order after each delivery. Invoices shall indicate the purchase order number, shall be itemized. Mail to: Cameron County, ATTN: Auditor's Office, 1100 East Monroe St., Brownsville, Texas 78520. Payment shall not be due until the above instruments are submitted after delivery or services rendered. Suppliers should keep the Finance Department advised of any changes in your remittance addresses. (b) Buyer's obligation is payable only and solely from funds available for the purpose of the purchase. Lack of funds shall render this contract null and void to the extent funds are not available and any delivered buy unpaid for goods will be returned to Seller by Buyer. (c) Do not include Federal Excise, State or City Sales Tax. County shall furnish tax exemption certificate if required.

Any invoice, which cannot be verified by the contract price and/or is otherwise incorrect, will be returned to the Proposer for correction. Under term contracts, when multiple deliveries and/or services are required, the Proposer may invoice following each delivery and the County will pay on invoice. Contracts providing for a monthly charge will be billed and paid on a monthly basis only. Prior to any and all payments made for good and/or services provided under this contract, the Proposer should provide his Taxpayer Identification Number or social security number as applicable. RFQ 1360

Energy Consultant Services

1. Section 1 – General

Cameron County is soliciting qualifications from energy consultants to provide professional electricity consulting services related to the procurement and delivery of electricity for its facilities. Cameron County will be preparing an RFQ for energy to Cameron County and seeks the services of a consultant to assist with the details of the RFP, to evaluate the proposals and to assist the Commissioner's Court during the decision making process. The County's current contract expires on December 11, 2015.

The term of this agreement will begin on December, 2015 for two (2) years with option to renew. This agreement may be renewed by Cameron County for additional term(s). This agreement may be terminated by Cameron County upon a 30 day written notice to other party.

2. Section II – Statement of Work

A. The independent consultant will assist the county with the following:

1. Assist in the development of the specifications for an RFP (Request for Proposal) for to the procurement of electrical power to the facilities operated by the County of Cameron. Creating RFP to Obtain Price Quotes from REP's prior to the current contract expiration.
2. Review current electrical billings, meters and identify current contract requirements and/or terms that are of concern to Cameron County.
3. Inputting the electric bills on a customized excel spreadsheet for energy quote comparison.
4. Assist in the evaluation of the RFP's for delivery of electricity to Cameron County facilities.
5. Assist the County Energy Committee in reviewing RFP's submitted to the county. Negotiating and reviewing energy contracts and quotes from Retail Electric Providers.
6. Meet with county officials to review electrical RFP details such as company references, financial stability, pricing; pass thru fees, gross receipts tax, and other contract terms, etc..
7. Assist in making a recommendation of the proposals to the Commissioner's Court and/or answer any questions the Commissioner's Court may have during the decision making process. Making a presentation of findings to the Cameron County staff and Commissioner's Court.
8. Provide an analysis/comparison/assessment of prices, products and contract business terms of the County's electric providers and work with the county attorney to negotiate preferred business terms with electric providers.
9. Be available for presentations to the Cameron County Commissioner's Court during the procurement of the energy contract and during the length of the contract with an energy provider.
10. Make presentation to the Commissioner's Court as needed.

- B. The independent consultant will perform the following services during the term of the contract (after the selection of the electric service provider and during the term of the electric service provider contact).
1. Evaluate the electrical consumption of the County and make recommendations to reduce energy consumption.
 2. Analyze peak hours of electricity usage.
 3. Monitor and audit utility bills on a monthly basis. Providing monthly electric utility bill audit analysis and yearly budget reports starting December , 2015.
 4. Provide engineering support for energy cost reductions, meter consolidation and comply with HB 3693. Provide information needed to conform with SB 12 and HB 3693.
 5. Assist with the addition and deletion of new buildings.
 6. Resolve billing issues with REP or TDSP and dispute and provide support for bill error credits and corrections and meter additions and deletions.
 7. Make suggestions on how to reduce or consolidate the number of meters and meter cost at the County facilities.
 8. Advice on energy reduction projects for County facilities.
 9. Make recommendations during construction projects/renovation projects on the possible energy reduction measures.

3. Section III – Qualifications Information

- A. Before a consultant is considered for selection as the energy consultant the qualifier must show independence.
1. The qualifier or his/her firm does not engage in the sale of energy.
 2. The qualifier must disclose any potential conflict of interest with participating in the recommendation of an energy provider.
 3. The qualifier must show experience and knowledge of the industry yet independence.
 4. All responders must have a section in their response package that addresses the issue of independence/conflict of interest. Failure to address this issue will be cause for non-consideration.
- B. Qualifications will be evaluated using the following criteria
1. Experience – 50 points
 - a. Experience in negotiating electricity contracts for counties, cities, schools other entities with at least 15,000,000 kwh load; identify the entities you have done this business for.
 2. Capacity to perform – 30 points
 - a. Consultant should have a proven record in providing competitive assessment and procurement advisory services for the procurement of electricity.

- b. Provide resumes on key personnel that have more than 3 years experience working in deregulated energy markets.
 - c. Identification of who will be assigned to the County's account; include the qualifications; agree to notify the county of any changes.
 - d. List of 3 references with contact information where the proposed consultant has assisted in obtaining a retail electricity contract.
 - 3. Knowledge of rules, regulations, codes and other information – 10 points
 - a. Knowledge of utility rate schedules, TDSP tariffs.
 - b. Provide written information communicating your knowledge of rules, regulations, codes and other information.
 - 4. Understanding and capacity to bring suggestions and ideas for energy saving within the county energy use – 10 points
 - a. Identify some of the more traditional savings efforts you can coordinate with Cameron County.
- C. The Cameron County Evaluation Committee will review RFQ's submitted and score RFQ's.
 - 1. The Cameron County Evaluation Committee will evaluate the firms. Interviews and presentations may be scheduled.
 - 2. Price will be negotiated after Committee has ranked the qualifiers.
 - 3. Responders to this request must submit one (1) original and six (6) copies in sealed envelope to the Cameron County Purchasing Department within the due time.
 - 4. Qualifiers information must appear in the information sheet provided by the County and be signed.
 - 5. Qualifiers will be asked to interview with the Cameron County Evaluation Committee. Any cost associated with the preparation of the RFQ's or for the interview process is the sole responsibility of the consultant
 - 6. Qualifiers should review the check list and identify if all requirements have been met.
- 4. Section V – Price Consideration
 - a. Cameron County requires that an independent contractor fees are paid through the retail electric provider contract.
 - b. Cameron County expects to negotiate a fee structure with the consultant after the consultants have been ranked by the court and after a complete list of deliverables is agreed upon. Fee would be paid by the selected Retail Electric Provider after the contract is awarded and the accounts are switched to the selected provider.

3. For purposes of this Order, a person includes an individual, sole proprietorship, corporation, nonprofit corporation, partnership, joint venture, limited liability company, and any other entity that proposes or otherwise seeks to enter into a contract or other transaction with Cameron County requiring approval by the Commissioners Court.

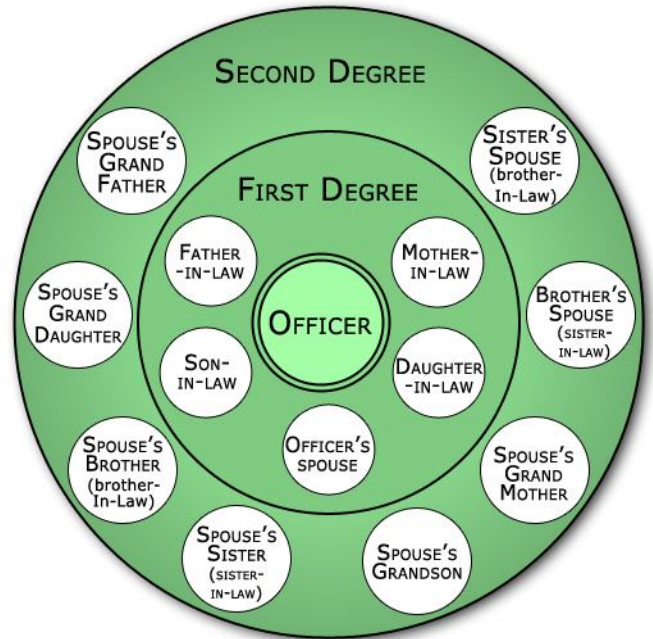

NEPOTISM CHART

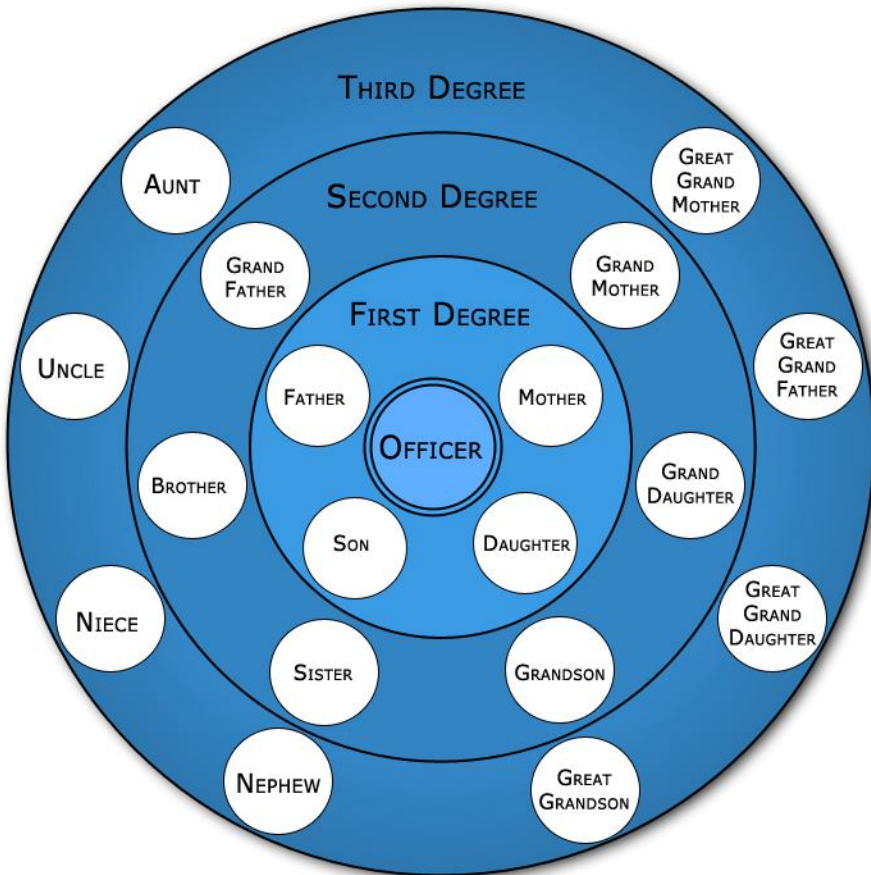

MAINTENANCE: Maintenance required for equipment RFP/RFQ should be available in Cameron County by a manufacturer authorized maintenance facility. If Cameron County opts to include maintenance, it shall be so stated in the purchase order and said cost will be included. Service will commence only upon expiration of applicable warranties and should be priced accordingly.

Pricing on all transportation, freight, drayage and other charges are to be prepaid by the contractor and included in the RFP/RFQ prices. If there are any additional charges of any kind, other than those mentioned above, specified or unspecified, Proposer MUST indicate the items required and attendant costs or forfeit the right to payment for such items. PROTESTS: All protests should be coordinated through the Purchasing Office prior to award recommendation to Commissioners Court.

SCANNED RE-TYPED RESPONSE – FLOPPY DISK: If in its RFP/RFQ response, Proposer either electronically scans, re-types, or in some way reproduces the County’s published RFP/RFQ package, then in event of any conflict between the terms and provisions of the County’s published RFP/RFQ specifications, or any portion thereof, and the terms and provisions of the RFP/RFQ response made by Proposer, the County’s RFP/RFQ specifications **as published** shall control. Furthermore, if an alteration of any kind to the County’s published RFP/RFQ specifications is only discovered after the contract is executed and is or is not being performed, the contract is subject to immediate cancellation.

SILENCE OF SPECIFICATIONS: The apparent silence of specifications as to any detail, or the apparent omission from it of a detailed description concerning any point, shall be regarded as meaning that only the best commercial practice is to prevail and that only material and workmanship of the finest quality are to be used. All interpretations of specifications shall be made on the basis of this statement. The items furnished under this contract shall be new, unused of the latest product in production to commercial trade and shall be of the highest quality as to materials used and workmanship. Manufacturer furnishing these items shall be experienced in design and construction of such items and shall be an established supplier of the item RFP/RFQ. **Substitute items will not be accepted unless approved (in advance).**

SUPPLEMENTAL MATERIALS: Proposers are responsible for including all pertinent product data in the returned RFP/RFQ package. Literature, brochures, data sheets, specification information, completed forms requested as part of the RFP/RFQ package and any other facts which may affect the evaluation and subsequent contract award should be included. Materials such as legal documents and contractual agreements, which the Proposer wishes to include as a condition of the RFP/RFQ, must also be in the returned RFP/RFQ package. Failure to include all necessary and proper supplemental materials may be cause to reject the entire RFP/RFQ.

TITLE TRANSFER: Title and Risk of Loss of goods shall not pass to Cameron Count until Cameron County actually receives and takes possession of the goods at the point or points of delivery. Receiving times may vary with the using department. Generally, deliveries may be made between 8:30 a.m. and 4:00 p.m., Monday through Friday. Proposers are advised to consult the using department for instructions. The place of delivery shall be shown under the “Special Requirements/Instructions” section of this RFP/RFQ package and/or on the Purchase Order as a “Deliver To:” address.

USAGE REPORTS: Cameron County reserves the right to request, and receive at no additional cost, up to two (2) times during the contract period, a usage report detailing the products and/or services furnished to date under a contract resulting from this ITB. The reports must be furnished no later than five (5) working days after written request and itemize all purchases to date by Cameron County department, description of each item purchased, including manufacturer, quantity of each item purchased, per unit and extended price of each item purchased, and total amount and price of all items purchased.

WARRANTY PRICE: (a) The price to be paid by the Buyer shall be that contained in Seller’s bid which Seller warrants to be no higher than Seller’s current prices on orders by others for products of the kind and specification covered by this agreement for similar quantities under similar or like conditions and methods of purchase. In the event Seller breaches this warranty, the prices of the items shall be reduced to the Seller’s current prices on orders by others, or in the alternative, Buyer may cancel this contract without liability to Seller for breach or Seller’s actual expense. (b) The Seller warrants that no person or selling agency has been employed or retained to solicit or secure this contract upon an agreement or understanding for commission, percentage, brokerage, or contingent fee excepting bona fide employees of bona fide established commercial or selling agencies maintained by the Seller for the purpose of securing business. For breach or violation of this warranty, the Buyer shall have the right in addition to any other right or rights to cancel this contract without liability and to deduct from the contract price, or otherwise recover the full amount of such commission, percentage, brokerage or contingent fee. Offerors shall furnish all data pertinent to warranties or guarantees which may apply to items in the bid. Offerors may not limit or exclude any implied warranties. Offeror warrants that product sold and services provided to the County shall conform to the standards and laws established by the U.S. Department of Labor, U.S. Department of Homeland Security, Occupational Safety and Health Administration and O.S.H.A. Act of 1970. In the event product does not conform to OSHA Standards, where applicable, Cameron County may return the product for correction or replacement at the offeror’s expense. If offeror fails to make the appropriate correction within a reasonable time, Cameron County may correct at the offeror’s expense.

Offeror warrants that product sold and services provided to the County shall conform to the standards and laws established by the U.S. Department of Homeland Security, Occupational Safety and Health Administration and O.S.H.A. Act of 1970.

WARRANTY PRODUCTS: Seller shall not limit or exclude any implied warranties and any attempt to do so shall render this contract voidable at the option of the Buyer. Seller warrants that the goods furnished will conform to the specifications, drawings and descriptions listed in the RFP/RFQ invitation and to the sample(s) furnished by Seller, if any. In the event of a conflict between the specifications, drawings and descriptions, the specifications shall govern.

SAFETY WARRANTY: Seller warrants that the product sold to Buyer shall conform to the standards promulgated by the U.S. Department of Labor under the Occupational Safety and Health Act of 1970. In the event the product does not conform to OSHA standards, Buyer may return the product for correction or replacement at the Seller's expense. In the event Seller fails to make the appropriate correction within a reasonable time, correction made by Buyer will be at Seller's expense. APPLICABLE LAW

This agreement shall be governed by the Uniform Commercial Code. Wherever the term "Uniform Commercial Code" is used, it shall be construed as meaning "the Uniform Commercial Code" as adopted in the State of Texas as effective and in force on the date of this agreement.

ASSIGNMENT DELEGATION: No right or interest in this contract shall be assigned or delegation of any obligation made by Seller without the written permission of the Buyer. Any attempted assignment or delegation by Seller shall be wholly void and totally ineffective for all purposes unless made in conformity with this paragraph. Any contract entered into pursuant to this request is not assignable, nor the duties thereunder, by either party, without the written consent of the other party in the contract County Judge and County Auditor.

CONTRACT OBLIGATION: Cameron County Commissioners Court must award the contract and the County Judge or other person authorized by the Cameron County Auditor must sign the contract before it becomes binding on Cameron County or the Proposers. Department heads are NOT authorized to sign agreements for Cameron County. Binding agreements shall remain in effect until all products and/or services covered by this purchase have been satisfactorily delivered and accepted.

ERRORS AND OMISSIONS: Errors and Omissions in the RFP/RFQ of any provision herein described will not be construed as to relieve the Vendor of any responsibility or obligation, requisite to the complete and satisfactory implementation, operation, and support of any and all equipment, systems or services.

FORCE MAJEURE: If, by reason of Force Majeure, either party hereto shall be rendered unable wholly, or in part, to carry out its obligations under this agreement, then such party shall give notice and full particulars of Force Majeure in writing to the other party within a reasonable time after occurrence of the event or cause relied upon, and the obligation of the party giving such notice, so far as it is affected by such Force Majeure, shall be suspended during the continuance of the inability then claimed, except as hereinafter provided, but for no longer period, and such party shall endeavor to remove or overcome such inability with all reasonable dispatch. The term "Force Majeure" as employed herein, shall mean acts of God, strikes, lockouts, or other industrial disturbances, act of public enemy, orders of any kind of government of the United States or the State of Texas or any civil or military authority, insurrections, riots, epidemics, landslides, lightning, earthquakes, fires, hurricanes, storms, floods, washouts, droughts, arrests, restraint of government and people, civil disturbances, explosions, breakage or accidents to machinery, pipelines or canals, or other causes not reasonably within the control of the party claiming such inability. It is understood and agreed that the settlement of strikes and lockouts shall be entirely with the discretion of the party having the difficulty, and that the above requirement that any Force Majeure shall be remedied with all reasonable dispatch shall not require the settlement of strikes and lockouts by acceding to the demands of the opposing party or parties when such settlement is unfavorable in the judgement of the party having the difficulty.

HOLD HARMLESS AGREEMENT: Contractor, the successful Proposer, shall indemnify and hold Cameron County harmless from all claims for personal injury, death and/or property damage resulting directly or indirectly from contractor's performance. Contractor shall procure and maintain, with respect to the subject matter of this RFP/RFQ, appropriate insurance coverage including, as a minimum, public liability and property damage with adequate limits to cover contractor's liability as may arise directly or indirectly from work performed under terms of this RFP/RFQ. Certification of such coverage must be provided to the County upon request.

INFRINGEMENTS: There will be no warranty by buyer against infringements. As part of this contract for sales, Seller agrees to ascertain whether goods manufactured in accordance with the specifications attached to this agreement will give rise to the rightful claim of any third person by way of infringement or the like. Buyer makes no warranty that the production of goods according to the specification will not give rise to such a claim, and in no event shall Buyer be liable to Seller for indemnification in the event that Seller is sued on the grounds of infringement or the like. If Seller is of the opinion that an infringement or the like will result, he will notify Buyer to this effect in writing within two (2) weeks after the signing of this agreement. If Buyer does not receive notice and is subsequently held liable for the infringement or the like, Seller will hold Buyer harmless. If Seller in good faith ascertains that production of the goods in accordance with the specifications will result in infringement or the like, this contract shall be null and void, except that Buyer will pay Seller the reasonable cost of his/her search as to infringement. The contractor agrees to protect the County from claims involving infringement of patents or copyrights.

INTERPRETATION PAROLE EVIDENCE: This writing is intended by the parties as a final expression of their agreement and is intended also as a complete and exclusive statement of the terms of their agreement. No course of prior dealings between the parties and no usage of the trade shall be relevant to supplement or explain any term used in the agreement. Acceptance or acquiescence in a course of performance rendered under this agreement shall not be relevant to determine the meaning of this agreement, even though the accepting or acquiescing party has knowledge of the performance and opportunity for objection. Whenever a term defined by the Uniform Commercial Code is used in this agreement, the definition contained in the Code is to Control.

MODIFICATIONS: This contract can be modified or rescinded only by a writing signed by both of the parties or their duly authorized agents.

O.S.H.A: Proposer must meet all Federal and State OSHA requirements.

RIGHT TO ASSURANCE: Whenever one (1) party to this contract in good faith has reason to question the other party's intent to perform, he/she may demand that the other party give written assurance of their intent to perform. In the event that a demand is made, and no assurance is given within five (5) days the demanding party may treat this failure as an anticipatory repudiation of the contract.

SEVERABILITY: If any section, subsection, paragraph, sentence, clause, phrase or word of these requirements or the specifications shall be held invalid, such holding shall not affect the remaining portions of these requirements and the specifications and it is hereby declared that such remaining portions would have been included in these requirements and the specifications as though the invalid portion had been omitted.

VENUE: Both parties agree that venue for any litigation arising from this contract shall lie in Cameron County, Texas.
