Cameron County is an Equal Employment Opportunity Employer.

Carefully read all instructions, requirements and specifications. Fill out all forms properly and completely. Submit your RFP with all appropriate supplements and/or samples. Prior to returning your sealed RFP response / submittal, all Addendums - if issued - should be reviewed and downloaded by entering the County Purchasing web site at www.co.cameron.tx.us/purchasing/specs.htm – Addendums Column (updated Addendums). These Addendums must be signed and returned with your RFP in order to avoid disqualification. All Tabulations can also be viewed and downloaded at this site.

Review this document in its entirety. Be sure your RFP is complete, and double check your RFP for accuracy.

GOVERNING FORMS: In the event of any conflict between the terms and provisions of these requirements and the specifications, the specifications shall govern. In the event of any conflict of interpretation of any part of this overall document, Cameron County's interpretation shall govern. 2. RFP's **MUST** give full firm name and address of the Proposer. Failure to manually sign RFP will disqualify it. Person signing RFP should show **TITLE** or **AUTHORITY TO BIND THE FIRM IN A CONTRACT.**

5. Any Catalog, brand name or manufacturer's reference used in a RFP invitation is descriptive-NOT restrictive-it is to indicate type and quality desired. RFP's on brand of like nature and quality will be considered. If RFP is based on other than reference specifications, proposal must show manufacturer, brand or trade name, lot number, etc., of article offered. If other than brand(s) specified is offered, illustrations and complete descriptions should be made part of the RFP. If Proposer takes no exception to specifications or reference data, he will be required to furnish brand names, numbers, etc. as specified.

9. This is a RFP inquiry only and implies no obligation on the part of Cameron County.
10. Partial RFP's will not be accepted unless awarded by complete category or line item. **To be awarded by Total RFP.**
11. It is expected that the Proposer will meet all state and federal safety standards and laws in effect on the date of the RFP for the item(s) being specified, and the particular use for which they are meant.
12. It is the responsibility of the proposer to ask any and all questions the proposer feels to be pertinent to the proposal. Cameron County shall not be required to attempt to anticipate such questions for proposers. Cameron County will endeavor to respond promptly to all questions asked.

You are invited to submit a Proposal for providing **AUTOMATED PAYMENT SYSTEM to Cameron County Clerk's, District Clerk's, Tax Dept. for (6) County locations.** This proposal is strictly for **AUTOMATED PAYMENT SYSTEM.**

A. SCOPE:

The County of Cameron County requests Proposals from responsible proposers interested in providing AUTOMATED PAYMENT SYSTEM as described herein. Cameron County is requesting proposals for a product and corresponding services for Interactive Self- Service Kiosks to be utilized by various departments throughout the County. The objective of the Interactive Self Service Kiosk is to include but not be limited to end users having the capability to pay fines/ costs/ fees/ court ordered payments, etc., for monies due and owing to Cameron County. The Kiosk shall have the ability to interact with systems of the various County Department to allow the end users to access their specific information from the Kiosks before making a payment via cash / debit or credit card and the system must be able to provide a receipt at the time of payment to the end user, as well as a receipt to the department utilizing the system.

B. PERIOD OF CONTRACT:

This contract is from **February 1, 2014.** This contract may be terminated by either party for any reason by giving thirty (30) days written notice of the intent to terminate.

This contract is for **3 years with option to renew for two (2) additional years with the 3 year period ending January 31, 2017.** This contract may be terminated by either party for any reason by giving thirty (30) days written notice of the intent to terminate.

C. CONTRACTUAL OBLIGATIONS:

This request for Proposal, response and associated documentation, any negotiations and final contract, when properly accepted by Cameron County, shall constitute a contract equally binding between the proposer and Cameron County.

D. EVALUATION FACTORS:

Contract award will be made to the responsible proposer whose quote is determined to be the best evaluated offer resulting from negotiations, taking into consideration the relative importance of price and other evaluation factors set forth in this RFP.

- 25 - Ability of proposer to provide grade of service
- 20 - Availability of Technical Support and Services

E. RFP SUBMISSION REQUIREMENTS:

1. Proposer's standard contract.
2. Preparation of RFP:

Proposals must be in correct format and complete. Respondents are expected to address all items in as much detail as necessary for Cameron County representatives to make a fair evaluation of the company and the Proposal.

Proposals should also address each objective specifically and describe in detail how the successful Firm will achieve the objective, or how the Firm will enable Cameron County to achieve the objective.

Cameron County reserves the right to modify the specific requirements, based on changed circumstances (such as change in business or technical environments), the proposal selection process, and contract negotiations with the Applicant(s) selected for negotiations, and to do so with or without issuing a revised RFP. Proposers must provide a detailed proposed scope of work showing how they will meet the project requirements stated below.

Cameron County will oversee the daily operation of the Kiosk(s). However, it is expected that the successful Firm shall be solely responsible for the proper performance of the Kiosk(s).

3. State the full name of the proposer, principal office address, telephone number and contact person and title.
4. The identity of the organization submitting the proposal with the name, address, phone and fax number of the person or persons authorized to contractually obligate your organization with the proposal.
5. Please submit detailed profiles of the company's executive leadership and board members making sure to disclose any contingent liability issues that would require disclosure in audit financial statements following the guidelines of the AICPA for standards requirements.
6. The names, titles, and phone numbers of the persons Cameron County may contact for proposal clarifications.
7. Indicate acceptance to the general requirements and contract terms as described within this Request for Proposal.
8. Acknowledge receipt of all addendum to this Request for Proposal.
9. State the length of time the proposer has been in the AUTOMATED PAYMENT SYSTEM business.
10. State location of the business office closest to Cameron County and the number of persons employed in the Cameron County area.

11. Provide a brief history and description of your firm and its title transaction experience. Include the location of offices and the number of professionals in each office. Include a discussion of the specific expertise and services that distinguish your firm.
12. The proposal must contain the following:
Description of the provider's business, its history and future plans. (one to two paragraphs).
13. List of past or current projects of similar scope in size, including contact information for the recipient of the service.
14. Provide the names, proposed roles, background and experience, office location and availability of the personnel that would work on the County's account, or simply the number of employees who will be available on County business.
15. Provide a narrative statement regarding your understanding of and ability to provide services related to the issues of title services.
16. Provide a detailed description of a) any litigation or administrative proceeding in which the firm was a party in any matter related to the professional activities of the firm during the five (5) years prior to the date of this RFP; b) litigation, investigation, or proceeding in which a court or administrative agency is addressing any question relating to the professional activities of the firm or its members; and c) any notice of official action, administrative inquiries of formal SEC, MSRB or IRS challenges pertaining to any public finance transactions, or relating to any public finance matter in which the firm served as bond counsel, underwriters counsel, or other form of special counsel in a municipal financing transaction.
17. Identify any relationships or activities that might present a conflict of interest if your firm is selected for public transactions issued by the County or related boards or agencies. Provide a detailed description of your firm's existing system for identifying conflicts of interest. A conflict would include, without being limited to, the representation of any party in a matter adverse to the County to which a waiver had not been previously granted by the County. Provide sufficient facts, legal implications, and possible effects so that the County may evaluate the significance of each potential conflict. Describe how the firm proposed to resolve the conflicts.
18. Please provide proof that the company is in good standing with all applicable codes and laws of your jurisdiction, e.g. proof of good standing with the state's comptroller of public accounts, or SEC statements have been filed on-time and nothing is delayed as of the submission of this RFP, etc..
19. Explain your company's position in dealing with a data breach or reported suspected data breach and what actions you would take, include any supporting procedures adopted by your company as standard operating or contingency procedures.
20. Please submit for confidential review, your company's operating redundancy plans, aka disaster recovery plans.

21. ***CUSTOMER SERVICE:***

Each proposer shall provide in writing, procedures Cameron County may follow for reporting problems or trouble to their firm including the following customer service policies:

- a) Describe the procedure for handling customer complaints. Include the average length of time for complaint resolution. In detail explain the process related to customer submitted problem resolution requests and include timeframes and responsibilities with regard to each payment type.
 - b) Describe the procedure for reimbursing the County and Non-County customers for incorrect billing, including average length of time to receive reimbursements.
22. The successful proposer shall provide the following services to include but not be necessarily limited to:
- i. Kiosk management and coordination;
 - ii. System design;
 - iii. Kiosk(s) installation, configuration, interface and integration;
 - iv. System testing and training
 - v. Warranty and maintenance;
 - vi. Operations and maintenance services; and
 - vii. Payment processing.
 - viii. Payments (transactions) records, reports, routing, access.

23. ***MISCELLANEOUS REQUIREMENTS:***

- a) Awarded Firm shall obtain all permits and licenses necessary for operation.
- b) Required Wired or Wireless Internet Services
- c) Static IP for each location
- d) All traffic from Kiosk to vendor's Central Office must be secured as to prevent eaves-dropping and compromise. Kiosk(s) must comply with Texas state and Federal laws to insure that all information supplied by Cameron County or Cameron County's customers is gathered, maintained, and protected in a secure manner to protect consumer data privacy and all related financial transactions and not disclose said information to third parties without the prior written consent of Cameron County or Cameron County's customer.
- e) Kiosk(s) must meet all requirements of the Americans with Disabilities Act (ADA) requirements. In addition, Kiosk(s) must be able to implement any future requirements proposed by legislation relative to changes in the ADA.

- f) Vendor's Central Office must supply a secure VPN / IPsec Tunnel or Point to Point circuit to Cameron County for data update.
- g) Vendor will be responsible for Turn-Key integration into the current system(s) to which it will accept payments.
- h) The vendor must supply a dedicated high speed internet connection with as close as possible to a minimum speed of 1 Mbps upload and download for each location's transactions.
- i) Proposer must have a current Money Transmittal License for State of Texas.
- j) System, all Equipment and all services will be at NO CHARGE to Cameron County
- k) All Machines to be installed indoors. At some future point in time outdoor ready equipment installs may be required.
- l) Awarded firm must pay all costs (turn-key) Power hook-ups (required electrical wiring, conduit, materials, and all labor associated with bringing power) to the Kiosk locations as determined by the County Departments & Comm Court. All must meet the County's Building Maintenance Dept. Director's requirements and final approval.
- m) Awarded firm must pay all costs (turn-key) Internet wiring hook-ups (required wiring, conduit, materials, and all labor associated with bringing connectivity to the locations as determined by the County Departments & Comm Court. All must meet the County's I.T Dept. Director's requirements and final approval.
- n) Awarded firm must pay all costs (turn-key) associated with Interface for all Firms required, Cameron County will not pay any costs associated with these requirements.
- o) Touch Screen required
- p) Machines must accept Cash and Credit / Debit Cards
- q) Must provide 100% funding guarantee. Awarded firm assumes the risk of loss to Cameron County for funds received by vendor from Cameron County's customers until all monies are received in Cameron County's designated bank account. Awarded Firm shall guarantee payment to Cameron County without the necessity of demand of ALL funds collected by vendor in the amount displayed on receipts generated by the vendor for Cameron County's customers, regardless of the counterfeit nature of monies accepted, embezzlement, stolen, mishandled, misdirected or lost funds.

- r) Must provide real time transactions, reporting and customer support services with a toll free customer assistance phone number provided (on Kiosk) in English & Spanish.
- s) Resolve bill payment issues arising from the services provided by awarded firm. These disputes shall be resolved to Cameron County's satisfaction.
- t) The proposer who wins the Proposal for the interactive self-service kiosk(s) will be responsible for providing the technology and services that allow various departments of Cameron County to collect cash, credit and debit payments directly from various payers. The self-service kiosks will provide records to the payer and the County for each transaction.
- u) The self-service kiosks will provide customers with a paper receipt, to display at a minimum, the account number, payment amount, date and time paid, form of payment, and location of the payment agency;
- v) The Kiosk(s) shall be used by the public for payment processing and account management by various departments within Cameron County. Therefore the kiosk(s) must be able to process monies, costs, court-ordered payments and fees as well as issue receipts related thereto.
- w) The selected company shall be responsible for providing the technology and maintaining the Kiosk(s) which includes but is not limited to formatting the Kiosk(s) so the kiosk is responsive to the particular department's processing needs.
- x) The awarded Company must issue a written commitment to Cameron County that complies with this scope of services, no later than 21 days after the County's notice to proceed.
- y) The awarded Company shall successfully test all components to be implemented within 90 days from the contract effective date as directed by Cameron County and to its satisfaction. Vendor will not provide an interactive self-service payment kiosk(s) until successful completion of test.
- z) Describe in detail the method used for disaster recovery of the following items. Indicate if these alternatives have built-in monitoring and backup for routing of AUTOMATED PAYMENT SYSTEM:
 - 1. Gateway recovery.

An **interactive Automated Payment System kiosk** is a kiosk featuring specialized hardware and software designed within a public exhibit that provides capability and access to pay specific bills.

Integration of technology allows kiosks to perform a wide range of functions, evolving into interactive kiosk. For example, kiosks may enable users to enter a public facility, enter an account number, case # etc. in order to perform an online transaction, as means to pay fines & costs.

NOW THEREFORE, BE IT ORDERED by the Commissioners Court of Cameron County, that the following rules be adopted regarding Cameron County and persons interested in doing business with Cameron County:

- 1. Cameron County may refuse to enter into a contract or other transaction with a person with a past due debt to Cameron County, including delinquent ad valorem taxes, even if the person is the lowest successful proposer; and
2. For purposes of this Order, a debt is past due if it is not received in the County Treasurer's Office by the due date in a written agreement or notice, and ad valorem taxes are past due if not received in the County Tax Assessor/Collector's Office by February 1st following the January 1st on which the ad valorem taxes are due.
3. For purposes of this Order, a person includes an individual, sole proprietorship, corporation, nonprofit corporation, partnership, joint venture, limited liability company, and any other entity that proposes or otherwise seeks to enter into a contract or other transaction with Cameron County requiring approval by the Commissioners Court.

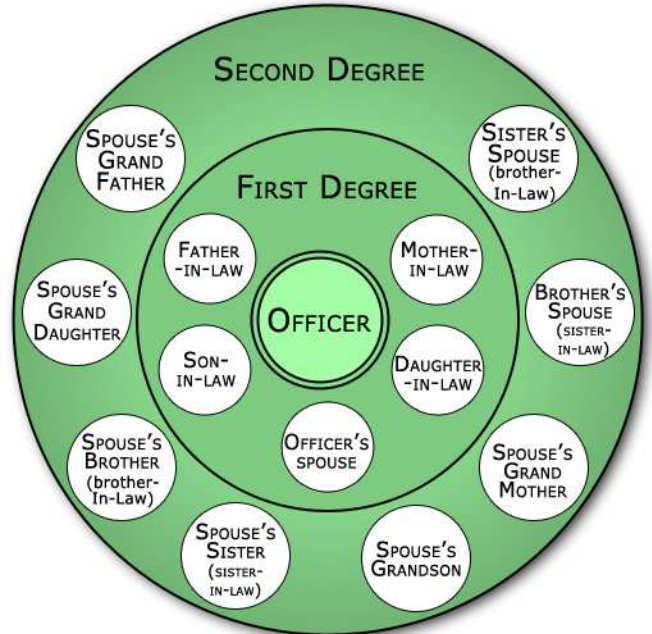

NEPOTISM CHART

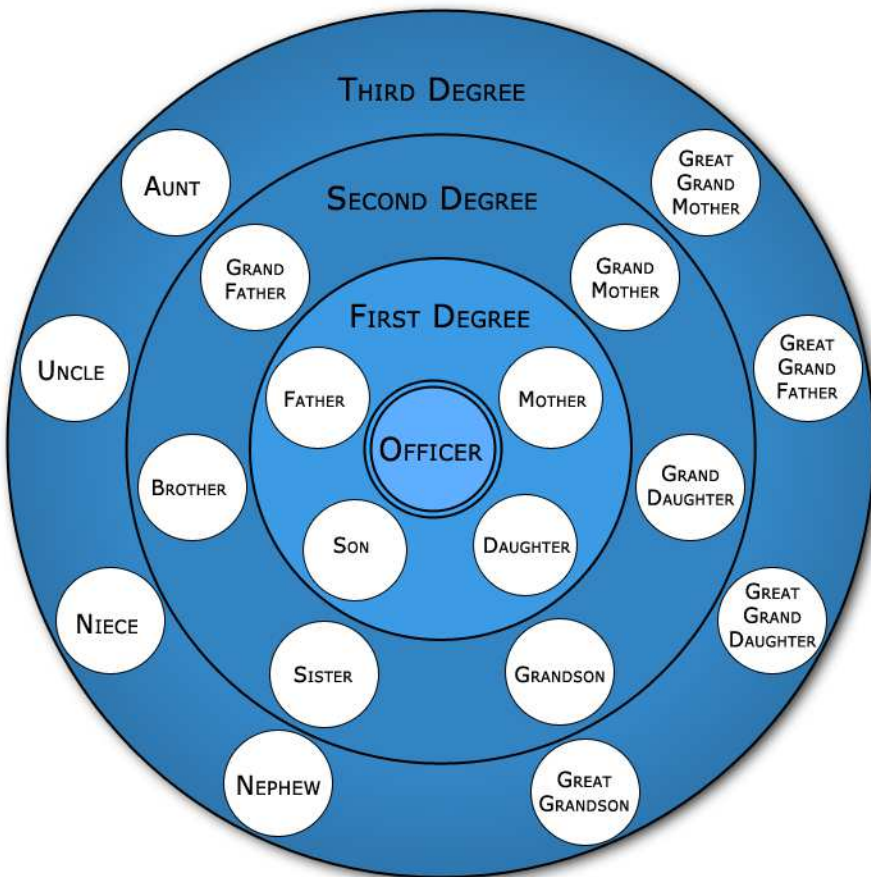

If Cameron County opts to include maintenance, it shall be so stated in the purchase order and said cost will be included. Service will commence only upon expiration of applicable warranties and should be priced accordingly.

MATERIAL SAFETY DATA SHEETS: Under the “Hazardous Communication Act”, commonly known as the “Texas Right To Know Act”, an proposer must provide to the County with each delivery, material safety data sheets which are applicable to hazardous substances defined in the Act. Failure of the proposer to furnish this documentation will be cause to reject any RFP/RFQ applying thereto.

NAME BRANDS: Specifications may reference name brands and model numbers. It is not the intent of Cameron County to restrict these RFP/RFQs in such cases, but to establish a desired quality level of merchandise or to meet a pre-established standard due to like existing items. Proposers may offer items of equal stature and the burden of proof of such stature rests with proposers. Cameron County shall act as sole judge in determining equality and acceptability of products offered.

PRICING: Prices for all goods and/or services shall be firm for the duration of this contract and shall be stated on the Pricing/Delivery Information form. **Prices shall be all inclusive: No price changes, additions, or subsequent qualifications will be honored during the course of the contract.** All prices must be written in ink or typewritten. Pricing on all transportation, freight, drayage and other charges are to be prepaid by the contractor and included in the RFP/RFQ prices. If there are any additional charges of any kind, other than those mentioned above, specified or unspecified, proposer MUST indicate the items required and attendant costs or forfeit the right to payment for such items. Where unit pricing and extended pricing differ, unit pricing prevails.

RECYCLED MATERIALS: Cameron County encourages the use of products made of recycled materials and shall give preference in purchasing to products made of recycled materials if the products meet applicable specifications as to quantity and quality. County will be the sole judge in determining product preference application.

SCANNED RE-TYPED RESPONSE – FLOPPY DISK: If in its RFP/RFQ response, proposer either electronically scans, re-types, or in some way reproduces the County's published RFP/RFQ package, then in event of any conflict between the terms and provisions of the County's published RFP/RFQ specifications, or any portion thereof, and the terms and provisions of the RFP/RFQ response made by proposer, the County's RFP/RFQ specifications as published shall control. Furthermore, if an alteration of any kind to the County's published RFP/RFQ specifications is only discovered after the contract is executed and is or is not being performed, the contract is subject to immediate cancellation.

SILENCE OF SPECIFICATIONS: The apparent silence of specifications as to any detail, or the apparent omission from it of a detailed description concerning any point, shall be regarded as meaning that only the best commercial practice is to prevail and that only material and workmanship of the finest quality are to be used. All interpretations of specifications shall be made on the basis of this statement. The items furnished under this contract shall be new, unused of the latest product in production to commercial trade and shall be of the highest quality as to materials used and workmanship. Manufacturer furnishing these items shall be experienced in design and construction of such items and shall be an established supplier of the item RFP/RFQ. **Substitute items will not be accepted unless approved (in advance).**

SUPPLEMENTAL MATERIALS: Proposers are responsible for including all pertinent product data in the returned RFP/RFQ package. Literature, brochures, data sheets, specification information, completed forms requested as part of the RFP/RFQ package and any other facts which may affect the evaluation and subsequent contract award should be included. Materials such as legal documents and contractual agreements, which the proposer wishes to include as a condition of the RFP/RFQ, must also be in the returned RFP/RFQ package. Failure to include all necessary and proper supplemental materials may be cause to reject the entire RFP/RFQ.

TITLE TRANSFER: Title and Risk of Loss of goods shall not pass to Cameron County until Cameron County actually receives and takes possession of the goods at the point or points of delivery. Receiving times may vary with the using department. Generally, deliveries may be made between 8:30 a.m. and 4:00 p.m., Monday through Friday. Proposers are advised to consult the using department for instructions. The place of delivery shall be shown under the "Special Requirements/Instructions" section of this RFP/RFQ package and/or on the Purchase Order as a "Deliver To:" address.

USAGE REPORTS: Cameron County reserves the right to request, and receive at no additional cost, up to two (2) times during the contract period, a usage report detailing the products and/or services furnished to date under a contract resulting from this RFP. The reports must be furnished no later than five (5) working days after written request and itemize all purchases to date by Cameron County department, description of each item purchased, including manufacturer, quantity of each item purchased, per unit and extended price of each item purchased, and total amount and price of all items purchased.

WARRANTY PRICE: (a) The price to be paid by the Buyer shall be that contained in Seller's RFP which Seller warrants to be no higher than Seller's current prices on orders by others for products of the kind and specification covered by this agreement for similar quantities under similar or like conditions and methods of purchase. In the event Seller breaches this warranty, the prices of the items shall be reduced to the Seller's current prices on orders by others, or in the alternative, Buyer may cancel this contract without liability to Seller for breach or Seller's actual expense. (b) The Seller warrants that no person or selling agency has been employed or retained to solicit or secure this contract upon an agreement or understanding for commission, percentage, brokerage, or contingent fee excepting bona fide employees of bona fide established commercial or selling agencies maintained by the Seller for the purpose of securing business. For breach or violation of this warranty, the Buyer shall have the right in addition to any other right or rights to cancel this contract without liability and to deduct from the contract price, or otherwise recover the full amount of such commission, percentage, brokerage or contingent fee. Offerors shall furnish all data pertinent to warranties or guarantees which may apply to items in the bid. Offerors may not limit or exclude any implied warranties. Offeror warrants that product sold and services provided to the County shall conform to the standards and laws established by the U.S. Department of Labor, U.S. Department of Homeland Security, Occupational Safety and Health Administration and O.S.H.A. Act of 1970. In the event product does not conform to OSHA Standards, where applicable, Cameron County may return the product for correction or replacement at the offeror's expense. If offeror fails to make the appropriate correction within a reasonable time, Cameron County may correct at the offeror's expense.

Offeror warrants that product sold and services provided to the County shall conform to the standards and laws established by the U.S. Department of Homeland Security, Occupational Safety and Health Administration and O.S.H.A. Act of 1970.

WARRANTY PRODUCTS: Seller shall not limit or exclude any implied warranties and any attempt to do so shall render this contract voidable at the option of the Buyer. Seller warrants that the goods furnished will conform to the specifications, drawings and descriptions listed in the RFP/RFQ invitation and to the sample(s) furnished by Seller, if any. In the event of a conflict between the specifications, drawings and descriptions, the specifications shall govern.

SAFETY WARRANTY: Seller warrants that the product sold to Buyer shall conform to the standards promulgated by the U.S. Department of Labor under the Occupational Safety and Health Act of 1970. In the event the product does not conform to OSHA standards, Buyer may return the product for correction or replacement at the Seller's expense. In the event Seller fails to make the appropriate correction within a reasonable time, correction made by Buyer will be at Seller's expense. Have you attached the required warranty information to the RFP/RFQ (if applicable)? Yes, No.

APPLICABLE LAW

This agreement shall be governed by the Uniform Commercial Code. Wherever the term "Uniform Commercial Code" is used, it shall be construed as meaning "the Uniform Commercial Code" as adopted in the State of Texas as effective and in force on the date of this agreement.

ASSIGNMENT DELEGATION: No right or interest in this contract shall be assigned or delegation of any obligation made by Seller without the written permission of the Buyer. Any attempted assignment or delegation by Seller shall be wholly void and totally ineffective for all purposes unless made in conformity with this paragraph. Any contract entered into pursuant to this request is not assignable, nor the duties thereunder, by either party, without the written consent of the other party in the contract County Judge and County Auditor.

CONTRACT OBLIGATION: Cameron County Commissioners Court must award the contract and the County Judge or other person authorized by the Cameron County must sign the contract before it becomes binding on Cameron County or the proposers. Department heads are NOT authorized to sign agreements for Cameron County. Binding agreements shall remain in effect until all products and/or services covered by this purchase have been satisfactorily delivered and accepted.

ERRORS AND OMISSIONS: Errors and Omissions in the RFP / RFQ of any provision herein described will not be construed as to relieve the Proposer of any responsibility or obligation, requisite to the complete and satisfactory implementation, operation, and support of any and all equipment, systems or services.

FORCE MAJEURE: If, by reason of Force Majeure, either party hereto shall be rendered unable wholly, or in part, to carry out its obligations under this agreement, then such party shall give notice and full particulars of Force Majeure in writing to the other party within a reasonable time after occurrence of the event or cause relied upon, and the obligation of the party giving such notice, so far as it is affected by such Force Majeure, shall be suspended during the continuance of the inability then claimed, except as hereinafter provided, but for no longer period, and such party shall endeavor to remove or overcome such inability with all reasonable dispatch. The term "Force Majeure" as employed herein, shall mean acts of God, strikes, lockouts, or other industrial disturbances, act of public enemy, orders of any kind of government of the United States or the State of Texas or any civil or military authority, insurrections, riots, epidemics, landslides, lightening, earthquakes, fires, hurricanes, storms, floods, washouts, droughts, arrests, restraint of government and people, civil disturbances, explosions, breakage or accidents to machinery, pipelines or canals, or other causes not reasonably within the control of the party claiming such inability. It is understood and agreed that the settlement of strikes and lockouts shall be entirely with the discretion of the party having the difficulty, and that the above requirement that any Force Majeure shall be remedied with all reasonable dispatch shall not require the settlement of strikes and lockouts by acceding to the demands of the opposing party or parties when such settlement is unfavorable in the judgement of the party having the difficulty.

HOLD HARMLESS AGREEMENT: Contractor, the successful proposer, shall indemnify and hold Cameron County harmless from all claims for personal injury, death and/or property damage resulting directly or indirectly from contractor's performance. Contractor shall procure and maintain, with respect to the subject matter of this RFP/RFQ, appropriate insurance coverage including, as a minimum, public liability and property damage with adequate limits to cover contractor's liability as may arise directly or indirectly from work performed under terms of this RFP/RFQ. Certification of such coverage must be provided to the County upon request.

INFRINGEMENTS: There will be no warranty by buyer against infringements. As part of this contract for sales, Seller agrees to ascertain whether goods manufactured in accordance with the specifications attached to this agreement will give rise to the rightful claim of any third person by way of infringement or the like. Buyer makes no warranty that the production of goods according to the specification will not give rise to such a claim, and in no event shall Buyer be liable to Seller for indemnification in the event that Seller is sued on the grounds of infringement or the like. If Seller is of the opinion that an infringement or the like will result, he will notify Buyer to this effect in writing within two (2) weeks after the signing of this agreement. If Buyer does not receive notice and is subsequently held liable for the infringement or the like, Seller will hold Buyer harmless. If Seller in good faith ascertains that production of the goods in accordance with the specifications will result in infringement or the like, this contract shall be null and void, except that Buyer will pay Seller the reasonable cost of his/her search as to infringement. The contractor agrees to protect the County from claims involving infringement of patents or copyrights.

INTERPRETATION PAROLE EVIDENCE: This writing is intended by the parties as a final expression of their agreement and is intended also as a complete and exclusive statement of the terms of their agreement. No course of prior dealings between the parties and no usage of the trade shall be relevant to supplement or explain any term used in the agreement. Acceptance or acquiescence in a course of performance rendered under this agreement shall not be relevant to determine the meaning of this agreement, even though the accepting or acquiescing party has knowledge of the performance and opportunity for objection. Whenever a term defined by the Uniform Commercial Code is used in this agreement, the definition contained in the Code is to Control.

MODIFICATIONS: This contract can be modified or rescinded only by a writing signed by both of the parties or their duly authorized agents.

O.S.H.A: Proposer must meet all Federal and State OSHA requirements.

RIGHT TO ASSURANCE: Whenever one (1) party to this contract in good faith has reason to question the other party's intent to perform, he/she may demand that the other party give written assurance of their intent to perform. In the event that a demand is made, and no assurance is given within five (5) days the demanding party may treat this failure as an anticipatory repudiation of the contract.

SEVERABILITY: If any section, subsection, paragraph, sentence, clause, phrase or word of these requirements or the specifications shall be held invalid, such holding shall not affect the remaining portions of these requirements and the specifications and it is hereby declared that such remaining portions would have been included in these requirements and the specifications as though the invalid portion had been omitted.

VENUE: Both parties agree that venue for any litigation arising from this contract shall lie in Cameron County, Texas.
