Automobile Liability: Coverage for automobiles in an amount not less than One Million Dollars (\$1,000,000.00) combined single limit (CLS).

TO:

To be in compliance with the FMCSA, vendors are required to carry Automobile Liability:

If transporting in a vehicle rated for 15 passengers or less, minimum coverage of one million five hundred thousand dollars (\$1,500,000) per occurrence combined single limit for automobile liability and property damage; and/or: If transporting in a vehicle rated for 16 passengers or more, minimum coverage shall be five million dollars (\$5,000,000) per occurrence combined single limit for automobile liability and property damage.
