The meeting was called to order by Judge Antonio O. Garza, Jr. He then asked Ms. Susan Cowen and Ms. Sylvia Mancillas, Leadership Brownsville Class VII, to lead the Court and the Audience in reciting the Pledge of Allegiance to the Flag.

The Court considered the following matters as posted and filed for Record in the County Clerk's Office on March 27, 1992, at 8:28 A. M.

Upon motion by Commissioner Rosenbaum, seconded by Commissioner Cascos and carried unanimously, the County Claims were approved as presented and on the recommendation by the County Auditor, noting that none required "Affidavits".

Upon motion by Commissioner Cascos, seconded by Commissioner Rosenbaum and carried unanimously, this Item was TABLED.

APPROVAL TO INCREASE LINE ITEM NO. 10-499 BY \$3,780.00 (TEMPORARY PART TIME HELP FOR TAX OFFICE)

Mr. Tony Yzaguirre, County Tax Assessor-Collector, explained that funds for the "temporary part-time help" for the Tax Office would be exhausted the following day, and he was requesting additional funding for the balance of the Fiscal Year. He said that the part-time help is for the Bookkeeping for the Automobile Division.

Judge Garza questioned why the Part-time Budget Line Item would be expended in March 1992, and Mr. Yzaguirre responded that two (2) positions were budgeted through the end of December, 1991, and the other position through March 31, 1992, and he was requesting the extension of this part-time position until the end of the Fiscal Year.

Commissioner Cascos moved to draw \$3,780.00 from Lapsed Salaries to increase Line Item No. 10-499 for the temporary part-time help for the Tax Office.

The motion was seconded by Commissioner Rosenbaum and carried the following vote:

Upon motion by Commissioner Rosenbaum, seconded by Commissioner Valencia and carried unanimously, the Mobile Vendor's Permit Application for James Vendetti/Lina Fakhry, dba Lemon Ice of Texas at Andy Bowie Park area was approved.

(6) CONSIDERATION AND ACTION TO APPROVE CHANGE ORDER NO. 2 TO MCALLEN CONSTRUCTION ON LOS INDIOS INTERNATIONAL BRIDGE

Mr. Jack Brown, Project Manager, explained that the Change Order would add certain Items to the McAllen Construction Contract, and that those Items would ultimately be deleted from the South Texas Construction Contract. He said that it would be more expeditious to have the McAllen Construction do the work because of the timing, and that the net increase would be approximately \$6,000.00.
