The meeting was called to order by Judge Antonio O. Garza, Jr. He then asked the entire Court to lead the Audience in reciting the Pledge of Allegiance to the Flag.

The Court considered the following matters as posted and filed for Record in the County Clerk's Office on April 3, 1992, at 12:16 P. M.

(16) APPROVAL OF VARIANCE TO THE BUILDING SETBACK LINES AT FM 802 AND CENTRAL BOULEVARD BY VICC

Ms. Jane Brasch, Attorney-at-Law, representing the owners of Maverick Market Stores, appeared before the Court

requesting a variance from the County's Subdivision Ordinance to allow the installation of fuel pumps within the building set back

lines. She stated that the Texas Water Commission required the removal of the fuel pumps from the current location for safety

reasons.

She explained that the owners of the store wanted to move the fuel pumps to allow more "swing" for the vehicles as they

backed out, and added that the owners were very concerned about the safety and the liability because they were sued in

Brownsville in 1989, for the very same reason.

Mr. Jeff Coleman, Certified Building Designer, stated that moving the fuel pumps closer to the property lines and away

from the building would increase the level of safety.

At this time, Mr. Andy Cueto, County Engineer, stated that the new location would not fall within the County's

Subdivision Ordinance requirement of having a forty-five (45) set back line on Farm to Market Roads. However, he added that

the new location would meet Texas Highway Department's twelve (12) foot set back requirement, that it is a Commercial

Building and that he had no objections to the variance.

Upon motion by Commissioner Valencia, seconded by Commissioner Rosenbaum and carried unanimously, the

variance to the Building set-back lines at FM 802 and Central Boulevard by the Valley Inn and Country Club (VICC), was

approved.

Commissioner Valencia moved that the low bid meeting specification of Rio Radio Supply, McAllen, Texas, for the 800 MHZ radios and antennas for the various Departments, be accepted.

(6) AUTHORIZATION TO OPEN BIDS FOR ONE (1) 1.34 GB DISK STORAGE SYSTEM FOR DATA PROCESSING DEPARTMENT

Upon motion by Commissioner Rosenbaum, seconded by Commissioner Valencia and carried unanimously, approval was given to open bids as received for one (1) 1.34 Giga Byte (GB) Disk Storage System for the Data Processing Department.

(7) APPROVAL OF REQUEST BY THE AMERICAN LEGION TO USE BOCA CHICA BEACH TO CONDUCT FUND RAISING FISHING TOURNAMENT ON AUGUST 16, 1992

Upon motion by Commissioner Cascos, seconded by Commissioner Rosenbaum and carried unanimously, the request by the American Legion to conduct a Fund Raising Fishing Tournament at the Boca Chica Beach, on August 16, 1992, was approved.

(8) APPROVAL OF CONTRACT AMENDMENT FOR TDH DOCUMENT NO. C2000348, CHANGE NO. 4

Mr. Rolando Martinez, Health Administrator, explained that the Change Order would increase the Contract amount by \$4,845.00, said funds to be provided by the Texas Department of Health.

Upon motion by Commissioner Valencia, seconded by Commissioner Cascos and carried unanimously, the Contract Amendment for the Texas Department of Health (TDH) Document No. C2000348, Change No. 4, was approved.

The Change Order is as follows:

(9) APPROVAL OF REQUEST FROM TSC STUDENT ACTIVITIES OFFICE TO USE TWO VOTING MACHINES TO HOLD BOUGAINVILLEA ELECTIONS ON APRIL 15, 1992

Upon motion by Commissioner Cascos, seconded by Commissioner Rosenbaum and carried unanimously, Texas Southmost College (TSC) Student Activities Office's request to use two (2) voting machines for the April 15, 1992 Bougainvillea Elections was approved, subject to the standard agreement.

(10) APPROVAL OF REQUEST BY PORTER HIGH SCHOOL STUDENT COUNCIL TO USE FOUR VOTING MACHINES TO CONDUCT STUDENT ELECTIONS ON APRIL 24, 1992

Upon motion by Commissioner Cascos, seconded by Commissioner Rosenbaum and carried unanimously, the request of Porter High School Student Council to use four (4) voting machines to conduct the Student Elections on April 24, 1992, was approved, subject to the standard agreement.

(11) RATIFICATION OF ACTION TAKEN ON MARCH 30, 1992, IN REGARD TO APPROVAL OF VOTING MACHINE LEASE AGREEMENT WITH DEMOCRATIC PARTY OF CAMERON COUNTY FOR 64 VOTING MACHINES

Commissioner Cascos moved that the approval given for Lease Agreement with the Democratic Party of Cameron County for the use sixty-four (64) voting machines, be ratified.

(12) AUTHORIZATION FOR COUNTY JUDGE TO EXECUTE ENGAGEMENT LETTER WITH ARTHUR ANDERSON FOR EVALUATION OF DATA PROCESSING DEPARTMENT

Commissioner Cascos moved that the County Judge be authorized to execute the "Engagement Letter" with Mr. Arthur Anderson for the evaluation of the Data Processing Department.

The motion was seconded by Commissioner Rosenbaum and carried unanimously.

(13) AUTHORIZATION TO REINSTATE AND APPROPRIATE FUNDS FOR COUNTY JUDGE'S ADMINISTRATIVE ASSISTANT POSITION

Judge Garza explained that the position of an Administrative Assistant has been in and out of his Budget several times and that the position had never been filled. He requested that the position be reinstated with a salary range up to \$43,000.00 annually, that funds be allocated from Lapsed Salaries initially, and if funds were not available, then funds to be allocated from the General Fund.

Commissioner Cascos moved that the County Judge's Administrative Assistant position be reinstated and that the annual salary range in the amount up to \$43,000.00 be appropriated, initially from Lapsed Salaries, and if funds are not available, then funds to be allocated from the General Fund.

The motion was seconded by Commissioner Valencia and carried unanimously.

(14) APPROVAL TO OPEN BIDS SUBMITTED FOR THE LOS INDIOS AND GATEWAY INTERNATIONAL BRIDGES TOLL EQUIPMENT

Upon motion by Commissioner Valencia, seconded by Commissioner Cascos and carried unanimously, approval was given to open bids as received for the Los Indios and Gateway International Bridges Toll Equipment.

The bid received and opened is as follows:

Upon motion by Commissioner Cascos, seconded by Commissioner Valencia and carried unanimously, the bid was referred to the Project Manager, County Auditor, and County Engineer for tabulation and recommendation to the Court.

(15) CONSIDERATION AND ACTION ON DRAINAGE OF LEVENS WAY

Mr. Andy Cueto, County Engineer, explained that a landowner had leveled his land in the Levens Way area of the Adams Gardens Subdivision and that in the process of leveling, the natural drainage was blocked causing a flood situation to the neighboring properties and roadway.

Commissioner Valencia expressed concerned with the flooding situation created and the problems associated because the property is located within an existing Irrigation and Drainage District (Adams Gardens).

Mr. Cueto stated that there appeared to be sufficient Right-of-Way to construct a small drainage ditch which could be tied to an existing ditch by using Adams Gardens' Right-of-Way. He said that funding would be a concern and that he did not know how much it would cost. He suggested that his Department conduct a "Drainage Feasibility Study" of the area and work with the Adams Gardens Irrigation District to recommend a solution.

Commissioner Valencia moved to direct the County Engineer to work with the Adams Gardens Irrigation District for a resolution of the problem, not only with respect to Levens Way but also Tam Lane and Bass Boulevard, to present the recommendations to the Court and to encourage the participation of the Irrigation District, in particular with funding.

The motion was seconded by Commissioner Cascos and carried unanimously.

(17) REQUEST FOR PRELIMINARY APPROVAL

Upon motion by Commissioner Valencia, seconded by Commissioner Cascos and carried unanimously, preliminary approval was given to the following subdivision, on the recommendation of the County Engineer:

a)L & I Subdivision - being a 1.201 acre subdivision out of a certain 3.469 acre parcel, out of block 34, Pomelo Subdivision, Cameron County, Texas.

(18) REQUEST FOR PRELIMINARY AND FINAL APPROVAL

Upon motion by Commissioner Cascos, seconded by Commissioner Valencia and carried unanimously, preliminary and final approval was given to the following subdivision, on the recommendation of the County Engineer:

a)Carricitos Subdivision No. 4 - being 6.288 acres of land comprising 2.591 acres out of Block 229 and 3.697 acres out of Block 231, San Benito Land and Water Company Subdivision, (Volume 1, Page 6, Maps and Records) Concepcion de Carricitos Grant, Cameron County, Texas.

(19) APPROVAL OF TRAVEL EXPENSE

Upon motion by Commissioner Valencia, seconded by Commissioner Cascos and carried unanimously, the following travel expenses were approved subject to availability of funds in their budget:
a)Tax Assessor-Collector and Chief Deputy to attend Annual Conference on April 7-9, 1992, in Odessa, Texas;

- b)Javier Mendez, County Building Inspector, and Jim Gomez, Building Inspector, to attend Building Codes Inspection Course in San Antonio, Texas, on April 21-23, 1992;
- c)Yvette Salinas, Health Department employee, Women, Infants, and Children (WIC), to Navasota, Texas, to attend Implementation Meeting on May 18-21, 1992; and
- d)Judge A. G. Betancourt to attend Seminar in Houston, Texas, on April 9-10, 1992.

(20) EXECUTIVE SESSION

Upon motion by Commissioner Cascos, seconded by Commissioner Rosenbaum and carried unanimously, the Court met in Executive Session at 2:15 P. M. to discuss the following matters:

- a) Discuss condemnation of Parcel Nos. 6, 10, 14, and 15 within Loop 590, Section III, pursuant to Section 2(f) of Article 6252-17 (of the Texas Revised Civil Statutes);
- b) Confer regarding the resale and value of real property held by Cameron County through delinquent tax judgment/ sale, pursuant to Section 2(f) of Article 6252-17 (of the Texas Revised Civil Statutes); and
- c) Evaluate applications for the Safety and Risk Coordinator and designation of candidates for the interview for position, pursuant to Section 2(g) of Article 6252-17 (of the Texas Revised Civil Statutes).

Upon motion by Commissioner Cascos, seconded by Commissioner Rosenbaum and carried unanimously, the Court reconvened in Regular Session at 3:00 P. M.

Commissioner Cascos moved that the condemnation proceeding on Parcel Nos. 6, 10, 14, and 15 within Loop 590, Section III, be authorized and that the Court be directed to execute the "Orders of Condemnation" in Regular Session.

The motion was seconded by Commissioner Rosenbaum and carried unanimously.
