The meeting was called to order by Judge Antonio O. Garza, Jr. He then asked members of the Audience wearing the Red Ribbons in recognition of the Red Ribbon Week for the "Just Say No-Drug Free Campaign," to lead the Court and the Audience in reciting the Pledge of Allegiance to the Flag.

The Court considered the following matters as posted and filed for Record in the Office of the County Clerk on  
October 22, 1992, at 3:10 P. M.

At this time, Commissioner Thomae expressed his objections to the remarks in a newspaper by Judge Garza that stated the approval of the Sheriff's Contract for the security of the Gateway Bridge was playing "partisan" politics and added that partisan politics was not an "issue" with him.

Commissioner Valencia moved that all the County Claims be approved as presented and on the recommendation by the County Auditor.

Commissioner Valencia moved that the 1993 Budget Amendment No. 2 and the Salary Schedules for the Sheriff's Department, Department No. 90-560, and the Adult Probation Department, Department No. 91-575, No. 91-578, No. 91-579, No. 91-580, No. 92-576, and No. 96-576 be approved as recommended by the County Auditor.

The motion was seconded by Commissioner Cascos and carried unanimously.

Upon motion by Commissioner Cascos, seconded by Commissioner Rosenbaum and carried unanimously, this

Item was TABLED for one (1) week.

(4) **IN THE MATTER OF REQUEST FOR EARLY RENEWAL AND EXTENSION OF CURRENT DELINQUENT TAX COLLECTION CONTRACT BY AND BETWEEN CAMERON COUNTY AND THE LAW FIRM OF HEARD, GOGGAN, BLAIR AND WILLIAMS FOR AN ADDITIONAL FOUR YEAR PERIOD, SAID CONTRACT IS TO EXPIRE IN JULY OF 1993 (DENIED)**

Commissioner Valencia moved that current Delinquent Tax Collection Contract by and between Cameron County and the Law Firm of Heard, Goggan, Blair and Williams be renewed and extended for an additional four (4) year period, said Contract to expire July 1993.

The motion was seconded by Commissioner Thomae and the vote was as follows:

AYE: Commissioners Thomae and Valencia

NAY: Commissioners Rosenbaum, Cascos and Judge Garza.

At this time, Judge Garza pointed out that 1) it would be an early extension and that he would prefer to let the Contract run it's course until it terminated, and that 2) a four (4) year term, in addition to the current number of years that the Firm of Heard and Goggan had been with the County, would be excessive unless the County went out for proposals in July. He said he was not suggesting that the Firm had done a poor job, but it would be in the best interest of the public to have the competitive process.

(5) **AUTHORIZATION TO OPEN BIDS FOR ONE (1) PICK-UP TRUCK FOR SHERIFF'S DEPARTMENT**

Upon motion by Commissioner Thomae, seconded by Commissioner Rosenbaum and carried unanimously, approval was given to open bids as received for one (1) pick-up truck for the Sheriff's Department.

**The bids received and opened are as follows:**

Upon motion by Commissioner Thomae, seconded by Commissioner Rosenbaum and carried unanimously, the bids were referred to Purchasing Agent and the Sheriff's Department for tabulation and recommendation to the Court of the best bid in one (1) week.

(4) **APPROVAL OF REQUEST FOR EARLY RENEWAL AND EXTENSION OF CURRENT DELINQUENT TAX COLLECTION CONTRACT BY AND BETWEEN CAMERON COUNTY AND THE LAW FIRM OF HEARD, GOGGAN, BLAIR AND WILLIAMS FOR AN ADDITIONAL FOUR YEAR PERIOD, SAID CONTRACT IS TO EXPIRE IN JULY OF 1993**

At this time, Commissioner Valencia stated that some members of the audience wanted to address the Court regarding Item No. 4.

Mr. Christopher Phippe, Attorney with the Firm of Heard, Goggan, Blair and Williams, explained to the Court, they were seeking an early renewal and extension to the Contract because of some business decisions that needed to be made and briefly reported on their collection efforts. He stated that they were willing to work with the Tax Office to best serve the County and added that they had requested a four (4) year extension but a two (2) year extension would be satisfactory.

Commissioner Valencia expressed his support to the Firm adding that it was based on the response by the many citizens that have expressed their satisfaction with the help extended by that Office. He asked that the Court reconsider the Item for an additional two (2) years.

At this time, Judge Garza remarked that he was not concerned with the relationship between the Firm and the Tax-Assessor Collector, rather his reservations regarding the extension were based on the fact that 1) the Contract was eight (8) months early and that the Firm would have the same transitional problems anytime that the Contract renewed, 2) that it was "good and healthy" for the County to solicit proposals and 3) that the public interests dictated the most competitive environment as possible.

Judge Garza stated that he was not implying that the Firm was not receptive to the Court and added that he had experienced a good working relationship with them. He suggested that he would prefer to evaluate proposals for the benefit of all concerned and the tax-payers of the County.

Commissioner Cascos stated that he would not support a four (4) year extension but would support a two (2) year extension.

Commissioner Valencia moved to rescind the prior action on Item No. 4.

At this time, Commissioner Cascos questioned whether that action could be taken and County Counsel responded that the Court would have to rescind the action and reconsider (the Item) and suggested that the Court vote to do that before action was taken.

The motion was seconded by Commissioner Thomae and carried the following vote:

AYE: Commissioners Cascos, Thomae and Valencia

NAY: Commissioner Rosenbaum and Judge Garza.

Commissioner Valencia moved that the current Delinquent Tax Collection Contract by and between Cameron County and the Law Firm of Heard, Goggan, Blair and Williams be renewed and extended for an additional two (2) year period, said Contract to expire July 1993.

The motion was seconded by Commissioner Thomae.

At this time, Judge Garza requested that his reservations be noted, that being that it was not the precedent that the Court should be trying to set in order to serve the best interest of the County and that it should be opened to the competitive process.

Commissioner Cascos remarked that he did want to solicit proposals but that doing it now would not afford the law firms the opportunity to respond, and that it took time and money to set up a Firm of the caliber of Heard and Goggan. He said that the solicitation of proposals should be done a year in advance to the termination of the Contract and that was the reason for supporting a two (2) year extension. He stressed the need to seek proposals in advance to allow the County plenty of time to review the proposals and to give every law firm, that had the desire to provide the service, enough time to do the necessary work.

Judge Garza clarified that there were still eight (8) months before the termination of the Contract and it would purport plenty of opportunity to seek proposals and plenty of opportunity to be competitive in the process. He stated that he felt that the extension would be setting a bad precedent and added that there were probably just a handful of firms that were in a position to provide the service.

Upon motion duly made by Commissioner Valencia and seconded Commissioner Thomae for the two (2) year extension period, the vote carried as follows:

AYE: Commissioners Cascos, Thomae and Valencia

NAY: Commissioner Rosenbaum and Judge Garza.

At this time, Mr. Doug Wright, Cameron County Counsel, clarified that the two (2) year extension would be from the termination date of the Contract, that being July 1993.

Upon motion by Commissioner Thomae, seconded by Commissioner Valencia and carried unanimously, approval was given to open bids as received for one (1) tractor for the Parks Department and one (1) tractor for Precinct No. 4.

Upon motion by Commissioner Thomaе, seconded by Commissioner Valencia and carried unanimously, the bids were referred to the Purchasing Agent and the respective Departments for tabulation and recommendation to the Court of the best bid in one (1) week.

The motion was seconded by Commissioner Valencia and carried unanimously.

At this time, Mr. Doug Wright, Cameron County Counsel, stated that the name should be corrected to read: Gulf Coast Trades Center, Inc.," instead of "Shoreline, Inc."

Upon motion by Commissioner Thomaе, seconded by Commissioner Rosenbaum and carried unanimously, the Contract between Cameron County and Gulf Coast Trade Center, Inc., for Residential Services for Chemical Dependent Youth was approved, with the Level III Placements per diem cost in the amount of \$51.00 and Level IV Placements per diem cost in the amount of \$74.00.

Commissioner Thomae moved that the Fourth Quarter Summary Report of the Parks Ranger Activities for the Cameron County Park Ranger Division be acknowledged.

The motion was seconded by Commissioner Valencia.

At this time, Commissioner Thomae stated that he had received numerous complaints from persons that had requested that the Rangers provide some surveillance to the parking area of the boat ramp at the Island because of the high theft incidents and that they were told that "it was not their job" and he suggested that the job descriptions be revised to include that responsibility.

The Parks Director responded that the area was not Parks System land and that the Court had directed his Department to expand funds only in the Parks Systems but that he would do as the Court directed.

At this time, Judge Garza suggested that the Parks Director confer with the County Counsel and the County Auditor to determine the latitude for the Parks System to provide the protection to the public in the recreational settings.

Upon motion duly made by Commissioner Thomae, seconded by Commissioner Valencia and carried unanimously, the Report is as follows:

**AUTHORIZATION TO EXECUTE RENEWAL OF SERVICES AGREEMENT BETWEEN JOHN STONE AND CAMERON COUNTY PARK SYSTEM FOR PROVIDING RECREATION PROGRAMS AT ISLA BLANCA PARK NOVEMBER 1992 THROUGH MARCH 1993**

Upon motion by Commissioner Thomae, seconded by Commissioner Cascos and carried unanimously, the Service Agreement between Mr. John Stone and Cameron County Parks System was renewed, to provide Recreation Programs at Isla Blanca Park from November 1992, through March 1993.

- a) Dilworth Estates Subdivision, being a 5.04 acre tract of land out of the South portion of Block 12, Stuart Place Subdivision, Survey 294.

### **Location:**

The proposed subdivision, within Precinct No. 4, is located on the West side of Dilworth Road approximately .6 of a mile South of Mayfield Road. It is a five (5) acre tract of land being subdivided into one (1) residential lot. Potable water will be furnished by the City of Harlingen Water Works and sanitary sewer will be by individual septic system. Dilworth Road has a sixteen foot wide concrete surface.

Commissioner Rosenbaum moved that preliminary approval be given to the following subdivision, on the recommendation of the County Engineer:

- b) Hondo Acres Subdivision, being the East of twenty (20) acres of Block 413, San Benito Land and Irrigation Company Subdivision. NO ACTION TAKEN

### **Location:**

The proposed subdivision, within Precinct No. 3, is located on the Southwest corner at the Intersection of FM 2925 or East Browne Tract Road and Fernando East Road. It is a twenty (20) acre tract of land being subdivided into twelve (12) residential lots. Potable water will be furnished by East Rio Hondo Water Supply Corporation and sanitary sewer will be by individual septic system. FM 2925 and Fernando East Road have asphalt pavement and all proposed lots front the roads.

At this time, Commissioner Thomae questioned whether the proposed subdivision passed all the flood requirements and the County Engineer responded that, according to the most current FEMA Flood Zone Maps, the proposed subdivision was in Flood Zone "C", that being a non-flooding zone area.

Potable water will be furnished by El Jardin Water Supply Corporation and sanitary sewer will be by individual septic system. Calle Barcelona has a caliche surface.
