# (3) APPROVAL OF MINUTES' OF MARCH 5 AND 8, 1993

At this time, Commissioner Matz noted corrections to the Minutes of March 8, 1993 on Item No. 2 and requested that his comments regarding "the very fine job that Ms. Tammy Atkinson was doing as Director of the Boys and Girls Club of Port Isabel-South Padre Island" be included on Item No. 14.

Commissioner Cascos stated that Commissioner Rosenbaum's and his vote should be corrected to reflect their vote as "Abstain" instead of "Nay" on Item No. 29 "f".

### (9) APPROVAL OF REQUEST BY SAN BENITO I.S.D. FOR THE USE OF FOUR (4) VOTING MACHINES FOR STUDENT COUNCIL CLASS OFFICERS ELECTION ON APRIL 6TH, 7TH, AND POSSIBLY THE 8TH, IF THERE IS A RUN-OFF

Commissioner Rosenbaum moved that the San Benito Independent School District's request for the use of four (4) voting machines for the Student Council Class Officers Election on April 6, and 7, 1993, and on April 8, 1993, should there be a run-off, be approved.

The motion was seconded by Commissioner Valencia and carried unanimously.

## (8) AUTHORIZATION TO OPEN BIDS FOR MAVERICK ROAD PAVING IMPROVEMENTS

Upon motion by Commissioner Rosenbaum, seconded by Commissioner Matz and carried unanimously, approval was

given to open bids as received for the Maverick Road Paving improvements.

The bids received and opened are as follows:

Upon motion by Commissioner Rosenbaum, seconded by Commissioner Matz and carried unanimously, the bids were referred to Commissioner Rosenbaum and the County Engineer's Office for tabulation and recommendation to the Court of the best bid.

APPROVAL FOR ONE PAID DEPUTY AND CAR ALLOWANCE FOR PRECINCT 5 CONSTABLE, APPROXIMATELY \$14,000 SALARY, PLUS FRINGE AND APPROXI-MATELY \$4,500 NEW EQUIPMENT. FUNDING TO BE DETERMINED

At this time, Mr. Javier Loredo, Constable Precinct No. 5, described the increased work being performed by his Precinct and the need for one (1) paid Deputy.

Judge Pro-tem Cascos asked if Constable Loredo was recommending the \$14,000.00 salary and questioned the amount of car allowance, and Constable Loredo responded that he was making the salary recommendation and that the car allowance would be \$500.00 a month.

Ms. Rosemary Martinez, Administrative Assistant to the County Judge, explained that the annual base salary of \$13,500.00, in line with the size of that particular Precinct, would include an additional \$6000.00 for the car allowance and added that the \$14,000.00 was the amount needed for the balance of the Fiscal Year. She stated that the amount of \$4,500.00 for the "New Equipment" was composed of the Items previously approved by the Court.

Judge Pro-tem Cascos asked for the current amount in Lapsed Salaries and Ms. Martinez responded that the amount was \$27,494.00, after considering Budget Amendment No. 17.

Commissioner Valencia moved that one (1) paid Deputy, with car allowance, for the Precinct No. 5 Constable be approved, with an annual salary of approximately \$14,000.00 plus fringe benefits, and approximately \$4,500.00 for new equipment, said funding to be allocated from Lapsed Salaries.

The motion was seconded by Commissioner Rosenbaum and carried the following vote: AYE: Commissioners Rosenbaum, Valencia and Judge Pro-tem

Cascos

NAY: None

ABSTAIN: Commissioner Matz.

At this time, Commissioner Matz remarked that he was well aware of the fine job that the Constable was doing and of the need for a Deputy Constable, especially after the opening of the Los Indios Bridge; however, he was concerned by the number of decisions the Court had made involving money which, in effect, represented significant changes in the Budget. He stated that the Court discussed a mid-year Budget Review to study the significant changes in the Budget and a number of budgetary concerns which would be better for the Court to review as a whole rather than on a piecemeal basis, and added that that was the reason he "abstained". He stated that he supported a new position, but would prefer that it be done within the context of an overall Budget Review. Commissioner Valencia expressed favorable comments concerning Constable Loredo's performance, and added that he had received many calls from the community expressing their satisfaction and support for him.

Judge Pro-tem Cascos remarked, as a point of clarification, that although Commissioner Matz indicated that the Budget was being affected, that the Budget was not being affected by the use of Lapsed Salaries because those salaried Items had been budgeted but not utilized.

Ms. Martinez stated that the use of Lapsed Salaries would not affect the current Budget but it would affect next year's Budget, because those positions were not in the current year's Budget.

## (11) AUTHORIZATION FOR STAFF TO BEGIN PREPARATION OF T.D.O.C. INFRA-STRUCTURE GRANT APPLICATION FOR IMPROVEMENTS TO THE HARLINGEN WASTE WATER TREATMENT PLANT NO. 2

Mr. Ed Theriot, City of Harlingen's Planning Director, explained that the City of Harlingen was in the process of a \$4.5 million expansion to the Wastewater Treatment Plant No. 2, in order to deliver the required amount of processed water to the adjacent Fruit of the Loom facility. He stated that the City of Harlingen received the following Commitment Letter from Fruit of the Loom for the creation of new jobs and added that the City was proposing to fund the improvements as explained in the following:

Commissioner Valencia moved that staff be directed to begin the preparation of the Texas Department of Commerce (TDOC) Infrastructure Grant Application for improvements to the Harlingen Waste Water Treatment Plant No. 2.

At this time, Commissioner Matz remarked that Commissioner Valencia and he met with Mr. Theriot and other City of Harlingen representatives and discussed the matter in some detail, and he commended Mr. Theriot for "the very fine briefing packet" provided to the Court. He added that "Fruit of the Loom had done a fine job of increasing the jobs and lowering the unemployment rate of this County."

The motion was seconded by Commissioner Matz and carried unanimously.

### (12) ACTION RELATIVE TO A RESOLUTION IN SUPPORT OF LEGISLATIVE BILL RELATING TO THE CONSOLIDATION OF AD-VALOREM TAXES

Mr. Felix Muñoz, Tax Office First Assistant and Chief Deputy, explained that House Representative Jim Solis filed House Bill 2746 on Friday, March 12, 1993, concerning the consolidation of ad-valorem taxes and that the County Tax-Assessor was requesting the Court's support for said House Bill.

Commissioner Matz moved that the Resolution in support of the Legislative Bill relating to the Consolidation of Ad-

- c) Tax Assessor-Collector and four (4) Deputies to attend 39th Annual Tax Assessor Collectors' Conference in Galveston, Texas, on June 6-10, 1993, and to Austin, Texas, on March 14-15, 1993, to attend Jurisprudence Committee Meeting dealing with Legislative Issues;
- d) County Engineer to Austin, Texas, to deliver Plans and Specifications to the Texas Water Commission for the South Dakota Road Collection Systems on March 17, 1993; (DELETED)
- e) Two (2) Deputy Constables from Precinct No. 8 to attend five (5) day Intoxilyzer School in San Antonio, Texas, beginning on April 12, 1993; and
