The meeting was called to order by Judge Antonio O. Garza, Jr. He then asked Mr. Ray Rodriguez, Health Department Chief Sanitarian, to lead the Court and the audience in reciting the Pledge of Allegiance to the Flag.

The Court considered the following matters as posted and filed for Record in the Office of the County Clerk on July 16, 1993 at 11:28 A. M.

**(18) AUDIENCE WITH RESIDENTS OF COLONIA LEAL
REGARDING THEIR CONCERNS IN THE AREA**

At this time, Ms. Josephine Salinas, Leader of Valley Interfaith, appeared before the Court to express the concerns of the residents of Colonia Leal with respect to the law enforcement efforts. She stated that the Community had experienced gang related violence for the past two (2) years and that the Sheriff's Department had not been responsive to their needs. She added that the group had met with the Sheriff's Department and the Commissioner from that Precinct but that the residents had not experienced a solution to their problems.

At this time, the following residents explained in detail their personal experiences concerning the violent conditions in the Community and the effect of those problems on their families:

Ms. Lucila Gutierrez, resident;

Ms. Ernestina Perez, resident; and

Ms. Cruz Escobedo, resident

Ms. Elvira Lara, Valley Interfaith leader, proposed that the Court create a "Task Force" to develop strategies to deal with the violence and to formulate long-term solutions to the problems in the neighborhood.

Judge Garza suggested that the focus should be on "preventive" initiatives and to coordinate the efforts with groups involved with the youth, such as the Sheriff's Department, Juvenile Department, Valley Interfaith and the School Systems, in order to address those needs and formulate long-term solutions.

Commissioner Matz stated that he met with the residents of Colonia Leal and that the problems were serious and that they needed assistance from the Law Enforcement community. He added that he would support the creation of a "working group" to focus on the problems and to formulate solutions that would be "models" for other communities.

Upon motion by Commissioner Valencia, seconded by Commissioner Matz and carried unanimously, the audience with the residents of Colonia Leal, regarding their concerns, was acknowledged.

At this time, Mr. Joe Galvan, Bridge Systems Director, introduced Mr. Joel Rincones, Gateway Bridge Manager, and then briefly reviewed the Personnel, Operations and Budgetary needs of the County Bridge Systems as outlined in the following **"Memorandum" to the Court:**

Mr. Galvan stated that the Equipment Repair and Property Insurance Line Items had experienced cost over-runs and if the expenditures were limited to personnel related areas, the expenses for the year would still be over the budgeted amount. He added that the requested items were basically to improve the operations at both Bridges and asked the Court for direction on whether to address those needs now or at Budget time.

Ms. Rosemary Martinez, Budget Officer, explained that the necessary Budget Amendments would be prepared to cover the Budget Line Items for the Bridge System and added that the payment for the Bridge Maintenance caused the expenses to go over the budgeted amount.

Upon motion by Commissioner Cascos, seconded by Commissioner Rosenbaum and carried unanimously, the Report regarding the immediate County Bridge System needs was acknowledged.

The motion was seconded by Commissioner Cascos and carried unanimously.

There being no further business to come before the Court, upon motion by Commissioner Matz, seconded by Commissioner Rosenbaum and carried unanimously, the meeting was adjourned.
