The meeting was called to order by Judge Antonio O. Garza, Jr. He then asked Mr. Frank Bejarano, Program Development & Management Director, to lead the Court and the audience in reciting the Pledge of Allegiance to the Flag.

The Court considered the following matters as posted and filed for Record in the Office of the County Clerk on September 3, 1993 at 9:27 A. M.

NOT ON AGENDA CONSIDERATION AND ACTION CONCERN-

ING THE FUNDING FOR "PEOPLE AGAINST

VIOLENT CRIMES" AND JUVENILE LAW EN-

FORCEMENT

At this time, Judge Garza stated that there appeared to be some confusion concerning two (2) Programs that are

being funded through Grants that were not included in the Budget for the Fiscal Year 1994 Budget. He stated that the

"People Against Violent Crime" Grant was funded on a Grant Cycle ending November 30, 1993 and the other Grant was

the "Detention Center Juvenile Law Enforcement" Grant being funded through October 31, 1993.

Judge Garza stated that the Court would support funding the two (2) Projects at the conclusion of the Grant

Cycle, that being November 30, 1993 for People Against Violent Crime and October 31, 1993 in the case of Juvenile

Law Enforcement, with those funds not being budgeted on the Budget that has been filed, but from the Surplus Fund or

Lapsed Salaries, whichever Fund has the available monies.

Upon motion by Commissioner Rosenbaum, seconded by Commissioner Cascos and carried unanimously, the

committment to fund "People Against Violent Crime" and "Juvenile Law Enforcement" at the conclusion of their Grant

cycle was approved, said Programs to be funded from the Surplus Fund or Lapsed Salaries, whichever has the available

funds.

At this time, Mr. Woody Peables, People Against Violent Crime, thanked the Court for their Support, explained

the efforts to obtain additional Funds for next year, and questioned whether they should continue to promote fund raisers

and Judge Garza responded that they should consider to continue the fund raising.

At this time, Ms. Rosemary Martinez, Budget Officer, explained that current funding for the People Against

Violent Crimes Grant was approximately \$30,000.00, that being the State Grant and the local contributions, and added

that they had been raising between \$4,000.00 and \$5,000.00 to assist them in their operations. She explained that Mr.

Peables had requested \$61,000.00 from the Fiscal Year 1994 Budget but that the funding level was up to the Court. She

added that the current level of operation funding would be \$30,000.00 plus the fund raising of \$5,000.00 or \$35,000.00 a

year.

Judge Garza stated that it was his understanding that the Court would fund at the same level as the Grant and

that the Organization would remain engaged in fund raising efforts, unless the Court entertained adding \$5,000.00 to the

commitment. Commissioner Valencia moved that the commitment be made for the \$35,000.00 instead of \$30,000.00.

The motion was seconded by Commissioner Rosenbaum and carried the unanimously.

(12) APPROVAL OF REQUEST BY MR. P. G. CAVAZOS, CHAIRMAN OF THE SUB-COMMITTEE HISTORIC ROADS AND SITES REVIEW OF THE CAMERON COUNTY HISTORICAL COMMISSION

At this time, Mr. P. G. Cavazos, Chairman of the Historical Committee, requested that the name of "El Carmen

Boulevard" be restored due to the long historical significance, and he briefly reviewed some of the history associated with the name as detailed in the following information:

Judge Garza clarified that some time ago the Court adopted a Policy that all changes and additions to any of the existing roads in Cameron County would not only be channeled through the County Engineer's Office but would include

the Historical Commission before any decisions are made.

At this time, Commissioner Cascos recommended that someone be designated to contact the Historical

Commission, such as the County Engineer's Office, and that they be a part of the mailing list in order to make them aware

of the changes.

Upon motion by Commissioner Valencia, seconded by Commissioner Cascos and carried unanimously, the

request by Mr. P. G. Cavazos, Chairman of the Historical Roads and Sites Review Sub-Committee of the Cameron

County Historical Commission, was approved to: a) restore the name of (El) Carmen Boulevard, b) replace (El) Carmen

Highway Markers, and c) relocate the (Villa) Cavazos Highway Marker.

(10) CONSIDERATION AND ACTION GRANTING DAVEWAY ELECTRONICS, INC., A LICENSE TO

OPERATE BORDER GUARD AT THE COUNTY'S

INTERNATIONAL TOLL BRIDGES

Mr. Joe Galvan, Bridge Systems Director, stated that approximately two (2) weeks ago the Court authorized the

negotiations for the licensing of Daveway Electronics, Inc. Brownsville, Texas, to locate "Border Guards" at the

International Bridges, and added that Legal Counsel had prepared and reviewed the Licensing Agreement for approval by

the Court.

Mr. Douglas Wright, County Counsel, stated that he did not review the original proposals received but he added

the language to include the "Cameron County Bridge Systems".

Commissioner Valencia moved that Daveway Electronics, Inc., Brownsville, Texas, be granted a License to

operate the "Border Guards" at the County's International Toll Bridges.

The motion was seconded by Commissioner Rosenbaum and carried the following vote:

(16) IN THE MATTER OF REQUEST FROM LAGUNA MADRE HUMANE SOCIETY FOR ENHANCED ANIMAL CONTROL AND FOR FUNDING ASSISTANCE TO BUILD AN ANIMAL SHELTER IN PORT ISABEL (ACKNOWLEDGED)

Ms. Linda Stafford, Director of the Laguna Madre Humane Society and Chairman of the Animal Control Advisory Board, appeared before the Court to explain the animal control problems in Laguna Heights and to request financial assistance to build an animal shelter in the area. She stated that there were large numbers of stray animals and frequently being hit by vehicles and remained on the roadways for long periods before the County Animal Control Officer responded to the calls for assistance.

Ms. Stafford reported that the City of Port Isabel had recently set aside \$25,000.00, to be matched by donations, in order to build an animal shelter that would be central to South Padre Island, Port Isabel and Laguna Heights, in order to address the need for animal control. She stated that they were \$15,000.00 short of the estimated cost of \$50,000.00 for the shelter and requested assistance from the County.

At this time, the following individuals presented their concerns for the lack of animal control in the area:

- a) Chris Thompkins, resident,
- b) Mr. Kirk Thompson, resident, and
- c) Ms. Hazel Urie, Port Isabel.

At this time, Mr. Manuel Hinojosa, Port Isabel City Manager, explained that the City of Port Isabel was committed to the animal control in the area but needed financial assistance from all communities and the County. He added that the estimated cost of the designed facility was approximately \$50,000.00 and that the City of Port Isabel could only afford a \$25,000.00 committeent towards the facility, and added that it was only for the construction and not the operation and maintenance of the facility. He stated that pledges were being matched by the members of the Humane Society and the Animal Control Board in order to start the Building.

Commissioner Cascos questioned whether the School District had been contacted, since it was also a part of their community, and whether a Budget had been prepared as to the cost to operate the facility and the source of funding, and Mr. Hinojosa responded that they were working on a Budget.

Commissioner Matz explained that the City of Harlingen had a City-owned facility which was turned over to the Humane Society to operate and had been quite successful, and suggested that the group contact the facility for guidance.

Judge Garza stated that he would be very reluctant to add another expenditure item due to the fact that the Budget had not been adopted. He stated that the Court was committed to Animal Control and had invested about \$70,000.00 for a County Facility.

There was a lengthy discussion concerning the needs of the Community for Animal Control, and the problems associated with limited resources at the County level.

Commissioner Cascos moved that the request from the Laguna Madre Humane Society for enhanced animal control and for funding assistance to build an animal shelter in Port Isabel be acknowledged.

The motion was seconded by Commissioner Matz and carried unanimously.

(18) AUTHORIZATION TO SET A \$5.00 FEE TO COURT COSTS TO A DEFENDANT CONVICTED OF A FELONY OFFENSE IN A DISTRICT COURT; A \$3.00 FEE TO COURT COSTS TO A DEFENDANT CONVICTED OF A MISDEMEANOR OFFENSE IN A COUNTY COURT; A \$5.00 FEE TO BE COLLECTED AT THE TIME OF FILING IN A CIVIL CASE FILED IN COUNTY COURT OR DISTRICT COURT IN EACH CIVIL CASE FILED; \$1.00 FEE FOR FILING ANY DOCUMENT NOT SUBJECT TO THE SECURITY FEE

Ms. Rosemary Martinez, Budget Officer, explained that Legislation was created that would allow the Court to impose a "Courthouse Security Fee" on Court cases and documents filed in order to increase the security services at the Courthouse, said fees to be designated for said purpose.

Upon motion by Commissioner Valencia, seconded by Commissioner Matz and carried unanimously, the Courthouse Security Fee was established as follows:

- \$5.00 Court Costs to a defendant convicted of a Felony Offense in a District Court;
- \$3.00 Court Costs to a defendant convicted of a misdemeanor offense in a County Court;
- \$5.00 Fee to be collected at the time of filing in a Civil Case filed in a County Court or District Court in each Civil Case filed; and
 - \$1.00 Fee for filing any document not subject to the Security Fee.

(19) BUDGET HEARING ON THE PROPOSED FISCAL YEAR 1994 BUDGET FOR CAMERON COUNTY, AS REQUIRED BY CHAPTER 111.067 VERNON'S ANNOTATED CIVIL STATUTES, LOCAL GOVERNMENT

Upon on motion by Commissioner Matz, seconded by Commissioner Valencia and carried unanimously, the Budget Hearing was opened for public comment.

Ms. Rosemary Martinez, Budget Officer, presented the overview of the General Fund as detailed in the proposed Fiscal Year 1994 Budget as follows:

At this time, Judge Garza solicited public comments and Mr. Joe G. Rivera, County Clerk, remarked that he would have preferred that the Budget reflect a four (4) to five (5) percent salary increase for the employees, instead of the three (3) percent salary increase.

Mr. Frank Bejarano, Planning and Development Director, stated that the position of "Human Resource Director" was not included as had been discussed and Ms. Martinez responded that the Budget did not contain any new positions and that the three percent (3%) salary increase was be funded from Surplus Fund. She recommended that the Department Heads be allowed the latitude to decide how to distribute the increase among the Department.

There was some discussion concerning the latitude in establishing the salary increases, the need for the latitude to shift "lapsed salaries" prior to the Budget year and the need for proper documentation concerning salaries in order to avoid conflicts.

At this time, Mr. Joe Galvan, Bridge Systems Director, presented his Budget concerns which related to the Action Plan previously presented which reflected the request for additional staff and monies for maintenance and operations.

At this time, Ms. Martinez recommended that the Court aggressively address the Health Insurance issues, that the revenues be monitored as closely as the expenses and that appropriations that impact future Budgets be reviewed very closely.

Upon motion by Commissioner Valencia, seconded by Commissioner Cascos and carried unanimously, the Public Hearing was closed.

(20) AUTHORIZATION TO SET THE SALARIES OF THE ELECTED OFFICIALS FOR FISCAL YEAR 1994 AS PUBLISHED

At this time, Commissioner Matz stated that he felt it was not appropriate, considering the tight Budget, to accept the three (3) percent raise, but if approved, he requested that the amount of the increase be transferred to the Constable for Precinct No. 8 for his equipment needs.

Upon motion by Commissioner Cascos, seconded by Commissioner Rosenbaum and carried unanimously, the Salaries of the Elected Officials for Fiscal Year 1994 were authorized as published.

Commissioner Cascos moved that the proposed Fiscal Year Budget be adopted.

The motion was seconded by Commissioner Rosenbaum.

At this time, Commissioner Matz expressed his concerns for additional funding for the County Airport and presented the follow Road Miles" and the percent of fund distribution per **Precincts as follows:**

Upon motion duly made by Commissioner Cascos, seconded by Commissioner Rosenbaum and carried unanimously, the proposed 1994 Fiscal Year Budget was adopted.

(22) AUTHORIZATION TO ADOPT ORDER SETTING THE 1993 TAX RATE

Upon motion by Commissioner Cascos, seconded by Commissioner Matz and carried unanimously, the Order setting the 1993 Tax Rate was adopted.

(23) AUTHORIZATION TO OPEN ANNUAL BIDS 1993/1994 FOR VOTING SUPPLIES

Upon motion by Commissioner Cascos, seconded by Commissioner Rosenbaum and carried unanimously, approval was given to open bids for 1993/1994 for Voting Supplies.

At this time, Mr. Michael Forbes, Purchasing Agent, was directed to open the bids received and to report to the Court prior to the end of the Meeting.

(25) ACTION REGARDING ESTABLISHMENT OF MONTHLY RENTAL RATES FOR RESIDENTS, PARK MANAGER AND RESIDENTS PARK RANGER AT ANDY BOWIE COUNTY PARK

Mr. Kenneth Conway, Parks Director, explained that he research the matter concerning the value of time of the Park Manager and Parks Ranger and his estimated that the rent, combined with the time value in providing off-duty night watch activities, was equal to or comparable to the rent for a one (1) bed-room apartment, and he recommended that the rent for a one (1) bedroom be set at \$150.00 per month, plus utilities, and \$175.00 per month, plus utilities, for a two (2) bedroom apartment.

Upon motion by Commissioner Matz, seconded by Commissioner Valencia and carried unanimously, the monthly rental rates for the Resident Parks Manager and the Residents Parks Ranger at Andy Bowie County Park were approved, as outlined by the Parks Director.

(26) AUTHORIZATION TO TRAVEL AND/OR APPROVAL OF TRAVEL EXPENSES

Upon motion by Commissioner Cascos, seconded by Commissioner Valencia and carried unanimously, the following travel and/or travel expenses were approved, subject to the availability of funds in their budget:

- b) Mr. and Mrs. Woody Peables, People Against Violent Crimes, to attend the Texas Crime Victim Clearinghouse Conference in Austin, Texas, on September 14 17, 1993;
- c) Three (3) Health Department Employees to attend the Symposium in Managing the IUD Patient Conference on September 9-11, 1993 in Dallas, Texas;
- d) Ms. Maria San Pedro, Health Department, to attend Immunization Program Managers and Symposium on Managing the IUD Patient on September 9 11, 1993 in Dallas, Texas;
- e) Mr. Juan Montoya, Precinct No. 1, to attend the Colonias Conference on September 7, 1993, at the Holiday Inn in Harlingen, Texas; and
- f) Ms. Josefa Rodriguez, Women Infant and Children Immunization LVN, to attend Nutrition and Cardiovascular Disease Seminar on September 12, 1993 in McAllen, Texas.

Upon motion by Commissioner Rosenbaum, seconded by Commissioner Matz and carried unanimously, the Court reconvened in Regular Session at 4:10 P. M.
