At this time, Mr. Kenneth Conway, Parks Director, explained that the 1992 Public Beach Access and Dune Protection Plan provided the incentives to private landowners to donate land for public beach access and added that the County was in the process of accepting a donation of land to meet the Plan's objectives. He stated that the donated land would afford an additional 401 public off-beach parking spaces and he proceeded to review the particulars of the donation as outlined in the following Proposal:

At this time, Judge Garza solicited public comments in opposition to the potential designation of said area as "Pedestrian Only", prohibiting motor vehicle operations, thereon.

No one spoke in opposition and Judge Garza noted that the "Notices" were duly published, pursuant to the National Resources Code and the Open Meetings Act.

At this time, Judge Garza solicited public comments in support of the land donation and the prohibition of vehicular traffic on said portion and noted that he had received the following "Letters" from Ms. Peggy Trahan, and Ms. T-Bird Sitgreaves, Mayor and Alderwoman of South Padre Island, respectively, supporting said designation:
