Mr. Andy Cueto, County Engineer, stated that although there were several Bridges that need to be replaced, the Engineering Department selected three (3) bridges that met the criteria for replacement as specified in the Forest Service Demonstration Grant. He stated that the bridges were located at Old Port Isabel Road in Brownsville, County Road 725, in the La Feria area, and Baurer Road, Northwest of Los Fresnos, and added that the local match would be in the amount of \$51,000.00, said funds within the Budget. Commissioner Matz moved that fifty percent (50%) local matching funds be provided towards a United States Department of Agriculture Forest Service Demonstration Bridge Grant to provide bridge replacements, said funds in the amount of \$51,000.00 to be allocated from the Road and Bridge Replacement Line Item.

The motion was seconded by Commissioner Valencia and carried unanimously.

Mr. Kenneth Conway, Parks Director, reviewed the proposed Rental Agreements for the Pavilions at Andy Bowie Park.

At this time, Commissioner Matz recommended that an additional amount be collected for "clean-up expenses", and the amount of \$50.00 was suggested.

Commissioner Matz moved that the Group Rental Policy Fee for the Picnic Pavilions at Andy Bowie Park be approved as outlined by the Parks Director, inclusive of the suggestions by Commissioner Matz.

Judge Garza reported that the Court had the opportunity to interview the candidates for the position of County Health Authority, that being 1) Lorenzo Pelly, M. D., 2) John Wells, M. D., and 3) Gustavo Stern, M.D. He stated the initial field of six (6) applicants had been narrowed to "three (3) very strong candidates, each bringing different perspectives or strengths to the position".

Commissioner Rosenbaum moved that Dr. Gustavo Stern, M.D. be appointed to the position of County Health Authority.

The motion was seconded by Commissioner Valencia and carried the following vote:

Judge Garza noted his abstention, adding that the Court interviewed "three (3) excellent candidates and have no doubts that Dr. Gustavo Stern would do a wonderful job; however, I would have made a different choice, and would like, not to vote against Dr. Stern, I think he would do a good job; but simply to reflect that it would not have been my first choice."

There being no further business to come before the Court, upon motion by Commissioner Matz, seconded by Commissioner Rosenbaum and carried unanimously, the meeting was adjourned.
