(5) APPROVAL OF LICENSE AGREEMENT BETWEEN U. S. ARMY AND CAMERON COUNTY TO USE AIRPORT FOR TRAINING PURPOSES

Upon motion by Commissioner Matz, seconded by Commissioner Rosenbaum, and carried unanimously, the License Agreement between the U. S. Army and Cameron County to use the County Airport for training was approved, subject to legal review.

#### (6) APPROVAL OF ABANDONMENT OF DIPPING VAT EASEMENT

Judge Garza explained that the County received the "dipping vat" easement in 1944 but had not utilized that easement in over twenty (20) years and the owners had requested clearance of title for their property.

Mr. Doug Wright, County Counsel, explained that a "Quick Claim" Deed had been prepared for the County Judge's signature, and added that the owners needed to present an "Evidence of Title" for the clearance.

Commissioner Rosenbaum moved that the abandonment of the "dipping vat" easement be approved, subject to the "Evidence of Title" by the owner.

The motion was seconded by Commissioner Matz and carried unanimously.

(7) CONSIDERATION AND ACTION EXTENDING
ARMORED CAR SERVICE CONTRACT WITH
ROCHESTER ARMORED CAR CO., INC., DBA
MAGIC VALLEY ARMORED CAR COMPANY,
FOR GATEWAY INTERNATIONAL BRIDGE

At this time, Mr. Joe Galvan, Bridge Systems Director, recommended that the Contract with Rochester Armored Company be extended for three (3) years, at an increase rate of four percent (4%), or a monthly rate of \$155.50 per month, and that the limits of liability insurance be increased from the current \$50,000.00 to \$75.000.00 on Mondays and any day following a Holiday and from \$15,000.00 to \$25,000.00 on Tuesdays through Fridays.

Upon motion by Commissioner Matz, seconded by Commissioner Rosenbaum, and carried unanimously, the Armored Car Service Contract was extended with Rochester Armored Car Co., Inc., d/b/a Magic Valley Armored Car Company, for the Gateway International Bridge.

Judge Garza clarified that the \$40,000.00 was toward the \$150,000.00 that would be collected from the four (4) County area, that being 1/3 from the private sector, 1/3 from Counties, and 1/3 from Cities, and would be strictly for the preparation of the Application and not for any advocacy efforts discussed.
