Judge Garza reported that after some discussion, it was the consensus of the Court as determined by polling, that the Court should provide Counsel on said matter.

Upon motion by Commissioner Cascos, seconded by Commissioner Matz and carried unanimously, County Counsel was provided for the independent defendant regarding Cause No. 91-02-00449-C. c)Action regarding evaluation for the Building Maintenance Superintendent.

Commissioner Cascos moved that the Building Maintenance Superintendent be granted an increase of \$3,500.00, post evaluation, said amount to be pro-rated for the balance of the year, said funds to be allocated from the Fund Balance.

a)Action regarding authorization for necessary action to initiate construction of temporary Adult Detention Center.

Judge Garza reported that after some discussion, it was the consensus of the Court as determined by polling, that County Counsel should be directed to proceed with the continued defense of said case as outlined in Executive Session.

Upon motion by Commissioner Rosenbaum, seconded by Commissioner Matz and carried unanimously, County Counsel was directed to proceed with the defense regarding the litigation relating to the construction of the temporary Adult Detention Center, as a possible settlement alternative.

(8) CONSIDERATION OF CAMERON COUNTY JAIL CONDITIONS AND POSSIBLE DECLARATION OF EMERGENCY CONDITIONS BECAUSE OF THE THREAT OF RIOT, PUBLIC CALAMITY AND EMERGENCY CONDITIONS

Commissioner Cascos moved that the competitive bidding be waived because of the threat of rioting, public calamity and emergency conditions, mainly jail overcrowding, and that the necessary Contracts for Housing and Jailing Inmates, be executed.

The motion was seconded by Commissioner Rosenbaum and carried unanimously.

(9) CONSIDERATION AND POSSIBLE APPROVAL OF TEMPORARY HOUSING AGREEMENT BETWEEN CAMERON COUNTY AND THE TEXAS DEPARTMENT OF CRIMINAL JUSTICE

At this time, Judge Garza commended Ms. Rosemary Martinez, Budget Officer, Sheriff Alex Perez, Chief Carlos Tapia, and Mr. Mark Yates, Budget Officer, for their efforts regarding the evaluation of the various Proposals received and asked for their recommendations.

Ms. Rosemary Martinez, Budget Officer, recommended that the Court execute the Contract with the Texas Department of Criminal Justice and added that the Contract had been reviewed by County Counsel.

Commissioner Cascos moved that the Temporary Housing Agreement between Cameron County and the Texas Department of Criminal Justice be approved as recommended by the Budget Officer.

The motion was seconded by Commissioner Matz and carried unanimously.

The Agreement is as follows:

(10) APPROVAL OF VENDOR CONTRACT FOR COMPLIANCE AND SATISFACTION OF TEMPORARY HOUSING AGREEMENT BETWEEN CAMERON COUNTY AND THE TEXAS DEPARTMENT OF CRIMINAL JUSTICE

Ms. Rosemary Martinez, Budget Officer, reported that five (5) different Contractors were contacted and their proposal reviewed and "of great concern was trying to maximize the investment statement totaling \$761,000.00 and to use it in a more permanent fashion, other than Temporary Housing." She stated that they were recommending the low bid by Sunrise Properties, Brownsville, Texas, in conjunction with Labunski Architects, Harlingen, Texas, and JAG Construction Inc., Brownsville, Texas, said proposal in the amount of \$761,000.00.

Judge Garza clarified that "on the face of the Proposal, it was the best proposal which provided for the construction in the most efficient and cost effective for the County". He stated that the Proposal allowed the County the flexibility needed with respect to the usage of the funds and the available Bond Funds, and added that it was the low bid.

Ms. Martinez stated that the next to the lowest bid received was in the amount of \$768,000.00, and did not include the permit costs. She added that the low bid of Sunrise Properties provided the best opportunity for expansion beyond the 192 beds that they were proposing to add.

Upon motion by Commissioner Rosenbaum, seconded by Commissioner Cascos, and carried unanimously, the Vendor Contract with Sunrise Properties, Brownsville, Texas, for the compliance and satisfaction of Temporary Housing Agreement between Cameron County and the Texas Department of Criminal Justice was approved, as recommended by the Budget Officer, in conjunction with the Sheriff and the County Auditor, subject to final approval by Legal Counsel.

# (7) PRESENTATION BY THE ELECTIONS ADMINISTRATOR OF AMENDED LAWS RELATING TO VOTER REGISTRATION AND ELECTIONS

At this time, Ms. Tencha de la Peña, Elections Administrator, reviewed the following letter to Commissioners, dated March 29, 1994, which highlighted changes in the Elections Laws that would be difficult for her Office to comply with because of the lack of staff and resources:

She explained that one of the changes required that the Elections Administrator furnish each entity of Cameron County a list of qualified voters for that particular entity's election and added that it would take several engineers to determine the boundary lines of the more than twenty (20) entities in the County.

There was some discussion concerning the burdens imposed on the County Elections Department due to the changes of the Elections Code and Commissioner Matz questioned whether the Elections Commission should address those concerns and Judge Garza responded that the matter could be discussed, but that ultimately, the Court had to consider the resources in order to comply with the Election Laws.

Commissioner Matz moved that the matter regarding the Election Code and related issues be referred to the Elections Commission for evaluation and recommendation.

The motion was seconded by Commissioner Cascos and carried unanimously.
