ACTION ON LAND USE AND LEASING POLICY FOR THE COUNTY OWNED PROPERTY AT THE FREE TRADE BRIDGE AT LOS INDIOS

Mr. Joe Galvan, Bridge Systems Director, stated that there were some concerns expressed regarding the leasing of parcels of County property without a leasing plan and the type of business development to be considered for the Free Trade Bridge area. He stated that the following "Land Use and Leasing Policy" was prepared to provide the Commissioners' Court with a guide for the proper and orderly development at the Free Trade Bridge:

He stated that there were approximately ten (10) acres of leasable land and he reviewed the proposed land uses for the four (4) areas in the "Land Use Plan" which could include Custom Brokers, a money exchange house, a restaurant, County Offices, and Constable Office.

There was some discussion concerning the type of structures that should be built, the landscaping and parking requirements and the suggestion was made to include the requirements in the "Leasing Policy" in order to maintain the esthetics of the area

At this time, Mr. Galvan reviewed the proposed "Leasing Policy" and Commissioner Matz remarked that the term of ten (10) years under Item No. 4 might be too long and suggested that the Bridge Director review the matter with the Parks Director in order that the County Leasing Policies be consistent.

Commissioner Matz moved that the "Land Use and Leasing Policy" for the County owned property at the Free Trade Bridge at Los Indios be adopted as recommended, subject to the changes and modifications as outlined.
