The meeting was called to order by Judge Antonio O. Garza Jr. He then asked Mr. Douglas Wright, County Counsel, to lead the Court and the audience in reciting the Pledge of Allegiance to the Flag.

The Court considered the following matters as posted and filed for Record in the Office of the County Clerk on August 19, 1994, at 12:40 P. M.:

(1) APPROVAL OF COUNTY CLAIMS

Mr. Mark Yates, County Auditor, presented the late claim as to Ms. Imelda Gracia, Juvenile Probation Department, Warrant No. 103706, in the amount of \$400.00, for approval.

Upon motion by Commissioner Valencia, seconded by Commissioner Rosenbaum and carried unanimously, the County Claims were approved as recommended by the County Auditor, inclusive of the late claim as to Warrant No. 103706, in the amount of \$400.00.

(2) APPROVAL OF BUDGET AMENDMENTS AND/OR SALARY SCHEDULES

Commissioner Matz moved that the Fiscal Year 1994 Budget Amendment No. 94-33 be approved as recommended by the Budget Officer.

The motion was seconded by Commissioner Valencia and carried unanimously.

The Budget Amendment is as follows:

AUGUST 18, 1994

Commissioner Matz moved that the Minutes of the Special Meeting held August 18, 1994, at 11:00 A. M. be approved.

The motion was seconded by Commissioner Valencia and carried the following vote:

AUGUST 9 AND AUGUST 16, 1994 (TABLED)

Upon motion by Commissioner Valencia, seconded by Commissioner Matz and carried unanimously, the Minutes of August 9, and August 16, 1994, were tabled.

(4) AUTHORIZATION TO HOLD A PUBLIC HEARING TO ADOPT AN ORDER FOR FLOOD CONTROL

Upon motion by Commissioner Matz, seconded by Commissioner Valencia and carried unanimously, the Hearing was open for Public comment.

At this time, Mr. Javier Mendez, County Building Official, stated that the local Flood Control Order had been amended to comply with the Federal Emergency Management Agency (FEMA) Regulations.

Mr. Andy Cueto, County Engineer, stated that the Amendments created uniform procedures, comparable to the major Cities in the County, and added that the County would now be able to enforce the Southern Building Codes.

Hearing and sensing no further comments, upon motion by Commissioner Matz, seconded by Commissioner Valencia and carried unanimously, the Public Hearing was closed.

Upon motion by Commissioner Matz, seconded by Commissioner Cascos and carried unanimously, the Order for Flood Control was adopted, on the recommendation of the County Counsel and the County Engineer.

The Order and Regulations are as follow:

Mr. Mark Yates, County Auditor, explained that the Court approved Certificates of Obligation in 1991, in the amount of \$2,500,000.00, intended for Road Improvements, the Health Clinic and Right-of-Way acquisitions. He stated that Fund No. 6 utilized \$955,000.00 for Right-Of-Way acquisitions, \$250,000.00 over budget, with the intention of having the Cities of Harlingen and San Benito reimburse the County for the cost of acquisitions.

Mr. Yates explained that the Interlocal Agreement with the City of Harlingen, executed in 1990, and the San Benito Interlocal Agreement, executed in April, 1991, had receivables in the amount of \$141,000.00. He indicated that the receivables were not cash, and cash was needed to pay the vendors for the Projects for Commissioner Precinct No. 4, and requested the loan until the issue of the receivables was resolved.

Commissioner Cascos questioned why the Road Improvement Funds were combined with the Right-of-Way acquisitions and Mr. Yates responded that the Budgets were distinctive and separate, but that the cash was used as the Projects proceeded.

Commissioner Valencia stated that there were no time limitations on the Projects funded by the Certificates of Obligation and he was shocked to learn that there was no money available, and he requested the loan in order to complete his Projects.

Mr. Yates remarked that the initial request was in the amount of \$52,000.00, but requested consideration to have the loan extended to cover the amount of the receivables in order to complete the funded Projects.

Commissioner Cascos questioned the likelihood of the collection of the receivables, and Judge Garza responded that the likelihood of collection was "high" but that it was a matter of "timing".

Mayor Chuck Weekly, San Benito, Texas, assured the Court that the City of San Benito would pay all of the amount due. He indicated that they were not aware of the expenditures until the invoice, in the amount of \$131,000.00, was received in July, 1994, and the amount was not budgeted. He added that the items on the invoice would be verified and payment submitted.

Ms. Rosemary Martinez, Budget Officer, stated that the 1991 Bond Issues were for Road Improvements for the Precincts, the Health Clinic and Right-Of-Way acquisitions, and added that some of the Projects were beyond the scope of the original Bond Issue and required that the Interlocal Agreements be executed.

Commissioner Cascos questioned what steps were being taken by the County Auditor's Office to ensure that similar situations not occur again because the County and the entities that executed the Interlocal Agreements had to budget for those expenditures.

Mr. Yates responded that the Auditor's Office was verifying the balances of the receivables and requiring the "back-up" for the receivables.

At this time, Commissioner Matz presented a check in the amount of \$10,077.00 from the City of Harlingen.

Commissioner Cascos questioned the amount needed to cover the Projects and Commissioner Valencia

responded that the amount of \$68,000.00 was needed in order to finish the Projects.

Commissioner Matz moved that the loan to Fund No. 6, 1991 Certificates of Obligation, in the amount of \$52,128.00 be authorized to cover the cash shortage and that the County Auditor be directed to meet with the City of San Benito to determine a time schedule.

The motion was seconded by Commissioner Rosenbaum and carried unanimously.
