The meeting was called to order by Judge Antonio O. Garza, Jr. He then asked Mr. Luis Saenz, District Attorney, to lead the Court and the audience in reciting the Pledge of Allegiance to the Flag.

At this time, Judge Garza recognized Judge A.G. Betancourt, County Court at Law No. 2, for the many years of public service to Cameron County and proclaimed December 14, 1994, as "A. G. Betancourt Day" in Cameron County.

Upon motion by Commissioner Rosenbaum, seconded by Commissioner Cascos and carried unanimously, the Resolution honoring the Honorable Judge A. G. Betancourt, Cameron County Court at Law No. 2, was adopted on the occasion of his retirement, and December 14, 1994, was proclaimed as "A. G. Betancourt Day" in Cameron County.

(15) AUTHORIZATION OF A NEW SLOT FOR A TRAINING OFFICER FOR THE SHERIFF'S DEPARTMENT

Captain Ronald Saenz, Sheriff's Department, explained that the State had mandated that the Department provide training for Deputies and Jail Guards, and added that the Department had a full time investigator who handled his regular duties and those of a full time instructor.

Commissioner Cascos questioned who was responsible for making sure that all the law enforcement officials were trained and Captain Saenz responded that the Sheriff was responsible for the training of the Court Bailiffs and the Sheriff's Deputies, and added that a full time instructor could provide training to other entities.

Judge Garza suggested that the Court be informed of the training provided in order to acknowledge those individuals that had received the proper and adequate training.

Mr. Doug Wright, County Counsel, expressed support for the training, and suggested that staff review the training being provided, in order to ensure the training compliance.

Commissioner Cascos moved that the new slot for a Training Officer for the Sheriff's Department be approved, said funds to be allocated from the Fund Balance and to be replaced with Lapsed Salaries.

The motion was seconded by Commissioner Matz and carried unanimously.

At this time, Captain Ronald Saenz, Sheriff's Department, stated that the Agenda Item should read "in the amount of \$2,500.00 each", instead of "\$1,500.00" each.

Captain Saenz explained that he had received approval for a Speed Ramp Grant and would need radar units in order to operate the Grant, and added that the Department of Public Safety was going to provide some used radar units, but that they could not seem to locate them.

Commissioner Cascos stated that the County had purchased radar units for the Department of Public Safety and that the units were County Property, but that apparently the units had been transferred, misplaced or lost. He added that he had requested the Purchasing Agent to attempt to locate the radar units.

At this time, Captain Saenz explained that the County had purchased an Intoxilizer Machine which was currently at the Port Isabel Police Department, and requested that the machine be moved back to the Jail, in order to process the Driving While Intoxicated cases (DWI's). He added that there would be a \$600.00 cost to move, reset and calibrate the machine.

Upon motion by Commissioner Valencia, seconded by Commissioner Rosenbaum and carried unanimously, the purchase of three (3) Radar Units, in the amount of \$2,500.00 each, for the Sheriff's Department was approved, said funds to be allocated from the Fund Balance and to be replaced by Lapsed Salaries.

There being no further business to come before the Court, upon motion by Commissioner Matz, seconded by Commissioner Cascos and carried unanimously, the meeting was **ADJOURNED**.
