He explained the functions of the Trappers and added that the fee for Cameron County had been \$1,250.00, but was being increased to \$1,400.00 effective January 1, 1995.

(15) AUTHORIZATION TO APPROVE THE PAYMENT FOR PARCEL NO. 7-023 OF FM/509 RIGHT-OF-WAY ACQUISITION PROJECT

Mr. Michael Martin, Acting County Engineer, explained that this Item had been previously discussed in Executive Session and that the counter offer was accepted, in the amount of \$113,983.42.

Mr. Doug Wright, County Counsel, stated that the Title Commitments needed review, noting that portions of the land were farmland, and if there were tenants, the County would then require a release from the individual property owner.

Commissioner Matz moved that Parcel No. 7-023 of FM/509 Right-of-Way Acquisition Project be approved for payment, subject to final review by County Counsel.

The motion was seconded by Commissioner Peña and carried unanimously.

(18) IN THE MATTER TO DISCUSS THE FUNDING SOURCE TO FINANCE THE JUDICIAL COURT SYSTEM AUTOMATION [TABLED]

At this time, Mr. Norio Nishiguchi, stated that the proposal specifications were ready and the one (1) time cost to the County for the purchase of the Judicial Court System Automation would be in the amount of \$300,000.00 to \$400,000.00. He stated that the yearly Maintenance Agreement would include upgrading and would be approximately \$150,000.00.

At this time, Judge Hinojosa requested that the Computer Director review the need for the purchase of a Judicial Court System Automation.

Mr. Mark Yates, County Auditor, noted that the County had used Lease Purchases extensively and stated that it was a very expensive form of financing, and suggested that the purchases should be projected annually, in order to have the funds available.

Judge Hinojosa suggested that the Computer Center Director determine the amount available from the various Departments to fund the System, and report to the Court the total amount available and the balance needed to finance the Judicial Court System Automation.

Upon motion by Commissioner Matz, seconded by Commissioner Peña and carried unanimously, this Item was TABLED.

Upon motion by Commissioner Matz, seconded by Commissioner Peña and carried unanimously, the Parks Director and the County Attorney were authorized to negotiate with the Port of Brownsville Officials regarding a possible future County Park on the Port of Brownsville Property.

(24) AUTHORIZATION OF A RESOLUTION AUTHORIZING CAMERON COUNTY TO APPLY FOR A SOLID WASTE ENFORCEMENT GRANT PROGRAM FROM THE TEXAS NATURAL RESOURCE CONSERVATION COMMISSION AND CERTIFYING THAT THE COUNTY WILL COMPLY WITH THE ASSURANCES LISTED ON THE SAID RESOLUTION

At this time, Commissioner Matz stated an article from the Valley Morning Star, dated February 16, 1991, reported that the County would begin a new Litter Abatement Program by May 1st, and noted that almost four (4) years had lapsed, and now the County had the opportunity to apply for a Grant Program.

Commissioner Matz added that the Program Development and Management Director had prepared two (2) budgets: for a four (4) Officer Program and a two (2) Officer Program, in the amount of \$145,267.00, and the County match would be \$72,633.50.

Commissioner Matz stated that he had received commitments from the Cities of Harlingen, Brownsville, La Feria, Los Fresnos, Palm Valley, Port Isabel, Rancho Viejo, San Benito, and had very positive responses from the Cameron County Drainage District No. 1, Brownsville Irrigation District, Cameron County Irrigation District No. 16, Harlingen Irrigation District No. 1, the Ports of Harlingen, Port Isabel, and the Port of Brownsville. Commissioner Matz added that there were firm commitments, in the amount of about \$34,000.00, and expected an additional \$5,600.00, which would increase the total commitments to approximately \$40,000.00.

Mr. Frank Bejerano, Program Development & Management Director, explained that the Grant Application would be for the term of one (1) year, and if it did not work, the County could withdraw the Program.

Commissioner Cascos suggested that the contributions should first be collected and placed in a Fund, adding that the matching monies should be allocated from the Road and Bridge Fund. Commissioner Cascos noted that he would like to see the County pursue the "Regional Collection Sites".

There was some discussion concerning the source of money for the local match and the County Auditor noted that if the source was the Road and Bridge Fund, then the County Engineering Department would have to oversee the Program, and not the Health Department as was planned.

Mr. Mark Yates, County Auditor, stated that the Health Department was scheduled to perform the functions regarding roadside dumping, and that the Engineering Department would assist with technical services. He stated that the balance needed could be allocated from the Fund Balance.

Commissioner Matz moved that the Resolution authorizing Cameron County to apply for the two (2) person Solid Waste Enforcement Grant Program from the Texas Natural Resource Conservation Commission be adopted, said funds to be allocated from the Surplus Fund, and that any remaining balance be budgeted in the next fiscal year, and that the Health Department provide the supervision and that the technical services be handled by the Engineering Department.

The motion was seconded by Commissioner Peña and carried unanimously.

(25) AUTHORIZATION TO APPLY FOR A CONTINUATION GRANT FUNDING FROM THE GOVERNOR'S OFFICE CRIMINAL JUSTICE DIVISION FOR THE PRECINCT NO. 8 CONSTABLE'S CRIME WATCH GRANT

Mr. Frank Bejerano, Program Development and Management Director, noted that the Continuation Project funded the Crime Watch Program currently under Constable Mendoza's Office, noting that it would be the second (2nd) year that the County would be applying for the Grant.

Upon motion by Commissioner Matz, seconded by Commissioner Peña and carried unanimously, the Application for the Continuation Grant Funding from the Governor's Office Criminal Justice Division, for the Precinct No. 8 Constable's Crime Watch Grant, was authorized.
