ABSENT:

The meeting was called to order by Judge Gilberto Hinojosa. He then asked Pastor Gayle Gardner, Church of the Good

Shepherd, for an invocation and the entire Court to lead the audience in reciting the Pledge of Allegiance to the Flag.

The Court considered the following matters as posted and filed for Record in the Office of the County Clerk on February

3, 1995, at 2:39 P. M.:

(15) POSSIBLE APPROVAL OF AN ORDER DECLARING THE RESULTS OF THE ELECTION OF THE CITY OF LOS INDIOS

At this time, Mr. Barry Jones, Attorney at Law, representing the Town of Los Indios, was directed by the Court

to canvass the results of the Los Indios Election held on January 21, 1995, in conjunction with the County Clerk's Office,

and that the results be presented prior to the end of the Meeting.

(10) APPROVAL OF A RESOLUTION HONORING MR. DANIEL CHAPA ON THE OCCASION OF HIS RETIREMENT AFTER SEVENTEEN (17) YEARS OF SERVICE TO THE VETERAN COMMUNITY OF CAMERON COUNTY

Commissioner Matz recognized Mr. Daniel Chapa, Veterans Service Officer, for the valuable contributions on

the occasion of his retirement after seventeen (17) years of service to the County, and for serving on numerous

Organizations and Committees.

Upon motion by Commissioner Matz, seconded by Commissioner Peña and carried unanimously, the Resolution

honoring Mr. Daniel Chapa, Veterans Service Officer, was adopted, on the occasion of his retirement.

The Resolution is as follows:

(1) APPROVAL OF THE COUNTY CLAIMS

Upon motion by Commissioner Rosenbaum, seconded by Commissioner Matz and carried unanimously, the

County Claims were approved as recommended by the County Auditor.

(2) APPROVAL OF THE BUDGET AMENDMENTS AND/OR SALARY SCHEDULES

Upon motion by Commissioner Rosenbaum, seconded by Commissioner Cascos and carried unanimously, the

Fiscal Year 1994 Budget Amendment No. 94-38, the Fiscal Year 1995 Budget Amendment No. 95-11 and the following

Salary Schedules were approved as recommended:

Drug Forfeiture-County Attorney, Fund No. 90-475;

County Court at Law No. 1, Fund No. 10-426;

A. G. Child Support - Sheriff, Fund No. 58-560; and

County Clerk, Fund No. 10-403.

The Budget Amendments and Salary Schedules are as follow:

(3) IN THE MATTER OF MINUTES OF JANUARY 31, 1995 [TABLED]

Upon motion by Commissioner Matz, seconded by Commissioner Cascos and carried unanimously, this Item was TABLED.

(4) APPROVAL OF A RESOLUTION IN SUPPORT OF A THIRD COUNTY COURT-AT-LAW IN CAMERON COUNTY

Judge Hinojosa noted that the "preference language" contained in the original Bill had been amended and that all three (3) Courts would now have equal jurisdiction and would allow the District Courts to transfer Juvenile, Family and Civil cases from the District Courts to the County Courts - at - Law.

Judge Hinojosa referred to a Program Summary and Fact Sheet of the County Courts and highlighted the revenues and costs of two the (2) County Courts - at - Law. He added that the fees collected in 1993 and 1994 would reflect what the Courts should be collecting and added that the backlog of cases was close to ten thousand (10,000).

Commissioner Cascos moved that the Resolution in support of a third County Court-at-Law in Cameron County be adopted.

The motion was seconded by Judge Hinojosa.

At this time, Mr. Joe G. Rivera, County Clerk, presented the following Court Activity Report for the year end which highlighted cases filed during the last five (5) years and added that there were over ten thousand (10,000) cases pending in both County Courts:

At this time, Commissioner Matz called on the County Auditor and asked "what is the need, what is the cost, and how are we going to pay for it?"

Mr. Mark Yates, County Auditor, responded that the costs would be approximately \$400,000.00 for the first year and \$325,000.00 for the second year, adding that additional Fees would be required from the District and County Clerks' Office to facilitate the additional Court.

Commissioner Matz expressed his concerns regarding the creation of another Court and added that it could cost the County more than it would generate.

Judge Hinojosa explained that the County Courts would support the District Courts and would allow the transfer of current Civil cases pending in the District Courts as well as the Family and Juvenile Cases in order for the District Courts to handle the felony dockets.

Commissioner Matz stated that "there was no argument between District Court versus County Court" and "that there is no argument that there is a need for swift and speedy justice for all", and added that what concerned him was that the decision to be made would have a significant impact on the Budget for next year. He added that he had heard nothing that would indicate that there would be significant revenue produced or the significant need to justify another County Court. He added that the information provided indicated that the cases being filed were on a downward trend, and that the backlog created had been increasing due to the fact that cases were not being processed as quickly as they should be.

At this time, the following individuals expressed their concerns regarding the creation of a County Court and recommended that a Criminal or Family District Court be created:

Mr. Rusty Faulk, Attorney at Law, and

Mr. A. G. Betancourt, former County Court at Law Judge.

There were some additional discussions concerning the revenues to be generated by a County Court and the cost associated by the creation of a County Court versus a District Court and the support provided by the State to the District Courts and Judge Hinojosa added that "I did not ask Senator Lucio to initiate this Legislation nor did I ask Representative Oliveira".

At this time, Pastor Gayle Gardner, Church of the Good Shepherd, expressed his support for a new County Court.

Upon motion duly made by Commissioner Cascos and seconded by Judge Hinojosa concerning the adoption of the Resolution supporting the creation of a third County Court - at - Law, the motion carried as follows:

- AYE: Commissioners Cascos, Peña and Judge Hinojosa
- NAY: Commissioners Rosenbaum and Matz
- ABSTAIN: None.

Upon motion by Commissioner Matz, seconded by Commissioner Peña and carried unanimously, the Service

Agreement between St. Francis Distributing Company and Cameron County was approved.

At this time, Commissioner Cascos questioned the process to confirm the Commissions received from the

vending machines, and suggested that a Report of Receipts be submitted by St. Francis Distributing Company, with the

Commission Check.

At this time, Mr. Mark Yates, County Auditor, stated that it was his understanding that the Original Contract

stipulated that Valley Interfaith would provide the transportation for the patients, and added that the Contract did not

obligate the County or the Hospital to cover the transportation costs.

At this time, Judge Hinojosa questioned whether the two (2) Contracts could be combined and Mr. Hanawa

responded in the affirmative.

Upon motion by Commissioner Matz, seconded by Commissioner Cascos and carried unanimously, the

the Texas Local Government Code, was acknowledged.
