(4) AUTHORIZATION TO ADOPT A RESOLUTION HONORING MS. MARIA VICTORIA AS MR. AMIGO 1994, FOR HER MANY ACCOMPLISHMENTS AND TRIUMPHS IN THE WORLD OF ENTERTAINMENT AND PRESENT MS. MARIA VICTORIA WITH THE STATUS OF HONORARY CITIZEN OF CAMERON COUNTY AND PROCLAIM THE WEEK OF FEBRUARY 20-25, 1995, AS "MARIA VICTORIA WEEK"

Upon motion by Commissioner Rosenbaum, seconded by Commissioner Matz and carried unanimously, the Resolution honoring Ms. Maria Victoria as Mr. Amigo 1994, for her many accomplishments and triumphs in the world of entertainment and to present Ms. Maria Victoria with the status of Honorary Citizen of Cameron County and proclaim the week of February 20-25, 1995, as "Maria Victoria Week", was adopted.

At this time, Mr. Joe G. Rivera, County Clerk, noted that the Resolution would be presented to Mr. Amigo on Friday, February 24, 1995, at 10:00 a.m. in the Central Jury Room.

Upon motion by Commissioner Peña, seconded by Commissioner Rosenbaum and carried unanimously, the Interlocal Agreement between Cameron County and the City of Combes was approved.

The Interlocal Agreement is as follows:

(10) AUTHORIZATION TO REQUEST ENGINEERING PROPOSALS FOR THE DESIGN OF ROAD IMPROVEMENTS IN CAMERON PARK

Mr. Frank Bejerano, Program Development and Management Director, noted that the County had \$600,000.00 in Grant Funds from the Texas Department of Housing and Community Affairs for Road Improvements in Cameron Park, and were advertising for the Request for Proposals with a due date of February 24, 1995, adding that the Engineering design of the proposed improvements was needed before the County could start construction.

At this time, there was some discussion concerning the size of the road and Right-of-Way required for the construction of the roads and the benefit of a twenty four foot (24') road versus a twenty foot (20') road in Cameron Park.

Judge Hinojosa suggested that the Request for Proposals should include a twenty four (24') road or any other options that the Engineers could provide.

At this time, Mr. Bejerano stated that a Bus Route would need to be negotiated with the School District, in order to prevent the school buses from tearing up the road, and the suggestion was made to attempt to negotiate with the School District to help maintain the roads at Cameron Park.

Commissioner Rosenbaum moved that the Program Development and Management Director be authorized to request for Engineering Proposals for the Design of Road Improvements in Cameron Park.

The motion was seconded by Commissioner Cascos and carried unanimously.
