The meeting was called to order by Judge Gilberto Hinojosa. He then asked Rev. Patrick Trobaugh, Portway Baptist Church, for the invocation, and Commissioner Cascos to lead the Court and the audience in reciting the Pledge of Allegiance to the Flag.

The Court considered the following matters as posted and filed for Record in the Office of the County Clerk on May 12, 1995, at 11:03 A. M.:

# **SUPPLEMENTAL ITEMS**

(1) CONSIDERATION TO ADOPT A PLAN OF FINANCE TO INCLUDE ISSUING CAMERON COUNTY, TEXAS, CERTIFICATES OF **OBLIGATION, SERIES 1995, AND CAMERON** COUNTY UNLIMITED TAX ROAD BONDS, SERIES 1995. THE SALE OF UNLIMITED TAX ROAD BONDS TO INCLUDE CONTINUED PURCHASE OF RIGHT-OF-WAY (ROW) AND ACQUISITION STUDIES FOR PROJECT ROAD APPROVAL FOR THE SALE OF MAP. CERTIFICATES OF OBLIGATION TO INCLUDE THE COMPLETION OF THE OSCAR DANCY **BUILDING'S RENOVATION**, AND **CONSOLIDATION OF ALL LEASE/PURCHASE** AGREEMENTS.

Mr. Noe Hinojosa, Financial Advisor, explained that about a month ago the County Treasurer and the County

Auditor requested that the current outstanding Leases be evaluated and that a "Plan of Finance" be developed to

address the Bond Issues relating to Project Road Map, Lease Purchase Agreements and the Dancy Building.

Mr. Hinojosa highlighted the following Analysis and added that refinancing the twenty-two (22) Leases would

result in a "marginal" savings in the amount of \$14,000.00, over a five (5) year period:

There was some discussion concerning the benefits of executing a "Master" Lease for the Lease Agreements and whether the Bond Company should continue to monitor the issues and the suggestion was made to disregard the matter.

Mr. Hinojosa reviewed the Project Road Map Bond Issue and the Construction Fund for the Dancy Building that are scheduled for the Second Phase.

Judge Hinojosa questioned whether the County could utilize Project Road Map monies to acquire the Rightof-Way (R-O-W) for the Los Tomates Bridge, should the Texas Department of Transportation (TxDOT) agree to reimburse the County, at cost plus interest, when the "Diplomatic Note" was issued.

Mr. Michael Martin, County Engineer, responded that monies were allocated for the acquisition of the Rightof-Way for the Los Tomates Bridge, and could possibly "borrow" from other Projects to be reimbursed later.

Mr. Mark Yates, County Auditor, responded that the Financial Plan being reviewed was doing nothing new. He stated that the voters approved Project Road Map, and that the timetables for the Projects were being realigned, and added that the Issue would include additional money for new equipment, in order to provide the money "up-front", instead of from the Fund Balance.

Mr. Hinojosa recommended that the Court adopt an Order of "Notice of Intent" to issue the amount of \$2,250,000.00 for Project Road Map Funds, and \$2,450,000.00 Certificates of Obligations for the completion of the Dancy Building, in order to sell the Debt by June 20, 1995.

Commissioner Cascos moved that the Plan of Finance, to include issuing Cameron County, Texas, Certificates of Obligation, Series 1995, and Cameron County Unlimited Tax Road Bonds, Series 1995, be adopted; and the sale of Unlimited Tax Road Bonds, to include continued purchase of Right-of-Way and acquisition studies for Project Road Map; and the sale of Certificates of Obligation, to include the completion of the Oscar Dancy Building's renovation, and consolidation of all Lease/Purchase Agreements, be approved.

The motion was seconded by Commissioner Rosenbaum and carried unanimously.

#### (2) IN THE MATTER TO DIRECT HIRING OF BOND COUNSEL [TABLED]

Commissioner Cascos moved that the Firm of Aiken, Gump, Strauss, Hauer and Feld, L.L.P, San Antonio,

Texas, be retained as Bond Counsel.

The motion was seconded by Judge Hinojosa and the vote was as follows:

Commissioner Cascos moved that the Item be TABLED.

The motion was seconded by Commissioner Peña and carried unanimously.

At this time, Mr. Noe Hinojosa, Financial Advisor, requested the Court's guidance as to the Bond Counsel and

questioned whether the Court would have any objections to the current Bond Counsel preparing the "Notice of Intent"

and Judge Hinojosa responded that it would not be "fair" for them to do so, and added that the Firm that applied could

prepare the "Notice".

## (4) PRESENTATION BY THE UNITED WAY OF SOUTHERN CAMERON COUNTY, RECOGNIZING THE EFFORTS AND CONTRIBUTIONS OF COUNTY EMPLOYEES DURING 1994

At this time, Mr. Alfonso Gutierrez, Executive Director of the United Way of Southern Cameron County,

recognized the Agency Board members in attendance and called on Mr. David Merrill, President of the United Way, to

make the presentation to the County.

Mr. David Merrill, President of the United Way, remarked that Cameron County employees were a source of

"great pride" to the United Way, because their contributions had increased from \$1,900.00 in 1990 to an excess of

\$32,000.00 in 1995.
