The meeting was called to order by Judge Gilberto Hinojosa. He then asked Mr. Bob Clark, Brownsville resident, for the invocation and Commissioner Cascos to lead the Court and the audience in reciting the Pledge of Allegiance.

The Court considered the following matters as posted and filed for Record in the Office of the County Clerk on March 29, 1996, at 2:34:

(9) AUTHORIZATION TO PURCHASE ONE (1) NEW VAN FOR THE PRISONERS AT WORK (PAW) PROGRAM

Commissioner Cascos moved that one (1) new van be purchased for the Prisoners at Work (PAW) Program.

The motion was seconded by Commissioner Rosenbaum and carried unanimously.

(10) AUTHORIZATION TO HIRE TWO (2) NEW DETENTION OFFICERS TO ASSIST IN THE PRISONERS AT WORK (PAW) PROGRAM

Upon motion by Commissioner Rosenbaum, seconded by Commissioner Peña and carried unanimously, two

(2) new Detention Officers were retained to assist in the Prisoners at Work (PAW) Program.

(1) APPROVAL OF COUNTY CLAIMS

At this time, the County Auditor presented the following late claims as to Warrant Nos. 10029 through 10313 for approval.

Upon motion by Commissioner Matz, seconded by Commissioner Rosenbaum and carried unanimously, the County Claims were approved as presented by the County Auditor, inclusive of the late claims as to Warrant No. 10029 through No. 10313.

The List is as follows:

(2) APPROVAL OF THE BUDGET AMENDMENTS AND/OR SALARY SCHEDULES

At this time, Commissioner Cascos questioned whether an evaluation had been performed in the Health Department and if the duties of the position had been enhanced concerning the Salary Schedules.

The County Auditor responded that all evaluations were performed prior to the Salary increases.

Commissioner Rosenbaum moved that the Fiscal Year 1996 Budget Amendment No. 96-09 and the following Salary Schedules be approved:

Health Department - Fund No. 10-630,

Pre-Trial Release - Fund No. 42-576, and

Pre-Sentence Investigation Unit - Fund No. 91-578.

The motion was seconded by Commissioner Peña and carried unanimously.

The Budget Amendment and Salary Schedules are as follow:

(3) APPROVAL OF THE MINUTES OF MARCH 19, 1996

Upon motion by Commissioner Matz, seconded by Commissioner Peña and carried unanimously, the Minutes of the Regular Meeting held March 19, 1996, at 1:30 P.M., were approved.

(4) APPROVAL OF A RESOLUTION PROCLAIMING THE MONTH OF APRIL AS FAIR HOUSING MONTH

Upon motion by Commissioner Cascos, seconded by Commissioner Rosenbaum and carried unanimously, the Resolution proclaiming the Month of April as Fair Housing Month, was adopted.

The Resolution is as follows:

(5) ACTION ON FEASIBILITY STUDY FOR THE MULTI STORY PARKING GARAGE IN PARTNERSHIP WITH THE CITY OF BROWNSVILLE

At this time, Mr. Remi Garza, Executive Assistant to the County Judge, explained that the action requested was for authority to enter into an Interlocal Agreement with the City of Brownsville, in order to determine the cost and the size of the Parking Garage, and noted that the cost of the Study had not been determined.

Commissioner Cascos expressed concern regarding the County's responsibility of funding the Project and questioned whether a temporary fund would be created for the up-front cost that would be required for the Project.

At this time, Judge Hinojosa stated that surveys would need to be performed to determine the parking needs, space availability, and the cost of the revenues based on the parking fees, and noted that the Project would cost an estimated amount of \$50,000.00.

The County Auditor suggested that the Project might qualify for funds from the Metropolitan Planning Organization, and Commissioner Cascos noted that the Metropolitan Planning Organization had numerous pending projects and that it might take several years for the process to be completed.

Mr. Mark Yates, County Auditor, recommended to form a Negotiation Team and the suggestion was made to include the Auditor's Office, County Judge's Office, Engineering Department, and County Counsel, in said Negotiation Team.

Commissioner Cascos moved that the Feasibility Study for the Multi Story Parking Garage, in partnership with the City of Brownsville, be approved.

The motion was seconded by Commissioner Rosenbaum and carried unanimously.

(6) AUTHORIZATION TO INCLUDE BUDGET OFFICER'S COMMENTS ON THE COMMISSIONERS' COURT REGULAR AND SPECIAL MEETING AGENDAS IN THE MINUTES OF THE COURT TO BE ATTACHED TO THE AGENDA INCLUDED WITH THE MINUTES OF EACH MEETING

There was a question as to whether the comments made by the Court would be in the Budget Officer's Comments Report and the County Auditor responded that comments regarding Specific Items would be included in the Minutes.

At this time, Commissioner Cascos expressed concern regarding the Tax Rates Projected on the Juvenile Boot Camp, since the Project would not be implemented until the next fiscal year and he suggested to encumber the amount of \$150,000.00 to avoid a large impact on the County.

The County Auditor stated that the Tax Rates were designed to elicit direction from the Court for next year's Budget and requested that the Court submit cost estimates for the Project.

Judge Hinojosa stated he was pursuing sources of funding for the Project and added that the County was in the process of negotiating with South Texas Independent School Districts regarding the Juvenile Justice Alternative Education Program.

At this time, Commissioner Matz expressed concern regarding the Tax Collections compared to the previous year and the amount of uncollectible taxes, and the County Auditor responded that the delinquent collections had decreased and that a program query would be conducted to determine the delinquent accounts.

Upon motion by Commissioner Matz, seconded by Commissioner Peña and carried unanimously, the Budget Officer's Comments on the Commissioners' Court Regular and Special Meeting Agendas in the Minutes of the Court were approved to be attached to the Agenda included with the Minutes of each Meeting.

The Budget Officer's Comments are as follow:

(7) APPROVAL TO HIRE A COMMUNITY MANAGER FOR PRECINCT NO. 4

Commissioner Peña moved that a Community Manager be retained for Precinct No. 4.

The motion was seconded by Commissioner Rosenbaum and carried unanimously.

(8) APPROVAL OF AGREEMENTS BETWEEN CAMERON COUNTY AND THE CITIES OF SOUTH PADRE ISLAND, LAGUNA VISTA, INDIAN LAKE, AND BAYVIEW FOR THE PROVISION OF SANITATION SERVICES

Upon motion by Commissioner Matz, seconded by Commissioner Peña and carried unanimously, the Agreements between Cameron County and the Cities of South Padre Island, Laguna Vista, Indian Lake, and Bayview for the Provision of Sanitation Services, were approved.

(11) APPROVAL FOR THE COUNTY TREASURER TO RELEASE WARRANTS, ON AN AS NEEDED BASIS, TO PURCHASE CERTIFICATES OF DEPOSIT OR TRANSFER FUNDS TO AUTHORIZED MONEY MARKET ACCOUNTS

Commissioner Matz moved that the County Treasurer be authorized to release Warrants, on an as needed basis, to purchase Certificates of Deposit or transfer funds to authorized Money Market Accounts.

The motion was seconded by Commissioner Peña and carried unanimously.

(12) INTERIM REPORT ON BANK AND INVESTMENT BALANCES WITH RELATED INTEREST EARNED REPORT FROM OCTOBER 1, 1995, THROUGH FEBRUARY 29, 1996

At this time, Mr. Eddie Gonzales, County Treasurer, reported that the interest earned as of the end of February 29, 1996, was sixty percent (60%), as opposed to the forty percent (40%) Budgeted, excluding the Reports from the District Clerk, the County Clerk, and the Tax Assessor-Collector and highlighted the interest earned on the Funds invested by the County.

Upon motion by Commissioner Cascos, seconded by Commissioner Peña and carried unanimously, the Interim Report on Bank and Investment Balances with related Interest Earned Report from October 1, 1995, through February 29, 1996, was acknowledged.

The Report is as follows:

(13) ADOPTION OF THE INVESTMENT POLICY AND PROCEDURES FOR CAMERON COUNTY, TEXAS

At this time, Mr. Eddie Gonzales, County Treasurer, reported that this Policy conformed with the State

Statutes and noted that the County Auditor had comments regarding the diversification of funds.

Mr. Mark Yates, County Auditor, noted that the Investment Officer would soon receive his Certification as

required by the Investment Policy and added that some complexity of staff was needed in order to diversify the

investments as required by the Public Funds Investment Act.

Judge Hinojosa questioned whether the County was maximizing the resources of investments with the limited

staff in the Treasurer's Office and questioned whether investing in staff would increase the County's Investments and

suggested that the County Treasurer's Office should budget additional staff in order to comply and gain profits form the

County's Investments.

At this time, the County Treasurer explained the differential gains acquired from a Treasury Bill Rate under

the Certificate of Deposit arrangement with the Bank and added that for every 100 basic points gained on one million

dollars, the total amount gained would be \$10,000.00.

The County Auditor stated that liquidity was a primary focus upon the County's Investments and noted that

the type of instruments that would comply under the Public Investments Policy would have a short margin range in

regards to legality and noted that in order to avoid any risk, the County had to keep short terms and liquidity.

At this time, Commissioner Matz expressed concerns regarding the appointment of the Investment Advisory

Committee by the Court.

The County Treasurer suggested that the Investment Advisory Committee should consist of an Investment

Banker, a Banker, a Private Citizen, the Auditor's Office, the County Attorney's Office, the County Treasurer, and

members from the Court.

Upon motion by Commissioner Rosenbaum, seconded by Commissioner Peña and carried unanimously, the

Investment Policy and Procedures for Cameron County, Texas, was adopted.

The Policy is as follows:

(14) AUTHORIZATION TO OPEN BANK ACCOUNT(S) WITH INTERNATIONAL BANK OF COMMERCE

Commissioner Rosenbaum moved to open Bank Account(s) with International Bank of Commerce.

The motion was seconded by Commissioner Matz and carried as follows:

AYE: Commissioners Rosenbaum, Cascos, Matz, and Peña

NAY: None

ABSTAINED: Judge Hinojosa.

(15) AUTHORIZATION TO SEPARATE THE PERSONNEL/INSURANCE COMMITTEE INTO TWO (2) INDIVIDUAL COMMITTEES

At this time, Mr. Mariano Ayala, Personnel/Safety Risk Coordinator, explained that the Committee workload was too much for one (1) group to handle and requested that the Committee be divided into two (2) groups.

Upon motion by Commissioner Matz, seconded by Commissioner Rosenbaum and carried unanimously, the Personnel/Insurance Committee was separated into the following two (2) Committees:

(16) ACTION CREATING CASHIER/TELLER POSITION FOR THE TAX ASSESSOR COLLECTOR'S RIO HONDO BRANCH OFFICE EFFECTIVE MARCH 29, 1996

At this time, Mr. Mariano Ayala, Personnel/Safety Risk Coordinator, stated that the Tax Assessor-Collector and the County Clerk requested that an employee and funds be transferred to the Rio Hondo Tax Office.

Commissioner Matz expressed some concern regarding the Budget Officer's Comments regarding the availability of funds in the Vehicle Maintenance Department, and the Personnel/Safety Risk Coordinator responded that the funds would be to hire part-time help.

Upon motion by Commissioner Matz, seconded by Commissioner Peña and carried unanimously, a Cashier/Teller Position was created for the Tax Assessor Collector's Rio Hondo Branch Office effective March 29, 1996.

(17) APPROVAL OF THE AMENDMENT TO CONTRACT WITH BARREDA APPRAISAL SERVICES FOR APPRAISAL OF A PARCEL OF LAND IN THE CAMERON PARK SUBDIVISION

Commissioner Rosenbaum moved that the Amendment to the Contract with Barreda Appraisal Services for the appraisal of a parcel of land in the Cameron Park Subdivision be approved.

The motion was seconded by Commissioner Cascos and carried unanimously.

(18) AUTHORIZATION TO ADVERTISE FOR BIDS FOR THE CONSTRUCTION OF THE SEA RANCH RESTAURANT AND ISLA BLANCA PARK REGISTRATION OFFICE, SUBJECT TO AND CONTINGENT UPON APPROVAL OF THE FINAL CONSTRUCTION PLANS AND SPECIFICATIONS BY COUNTY STAFF

Commissioner Matz moved that the advertisement for Bids for the Construction of the Sea Ranch Restaurant and the Isla Blanca Park Registration Office be approved, subject to and contingent upon approval of the final construction plans and specifications by the County Staff.

The motion was seconded by Commissioner Peña and carried unanimously.

(19) AUTHORIZATION TO ADVERTISE FOR BIDS TO CONSTRUCT THE LOS CUATES WASTEWATER PROJECT

Commissioner Rosenbaum moved to advertise for Bids to construct the Los Cuates Wastewater Project.

The motion was seconded by Commissioner Peña and carried unanimously.

(20) AUTHORIZATION TO AMEND THE TRAFFIC ENGINEERS, INC. CONTRACT ON THE LOS TOMATES INTERNATIONAL BRIDGE PROJECT TO INCLUDE ADDITIONAL SURVEYING FOR THE LEVEE RELOCATION BY HOLDAR-GOMEZ AND ASSOCIATES

At this time, Mr. Mark Yates, County Auditor, requested to amend the comments made on the Budget Officer's Comments Report concerning Items No. 20.

Mr. Michael Martin, County Engineer, explained that the additional work concerned the Villarreal Property where two (2) points needed to be assessed in order to provide roadway access to the Property.

Commissioner Cascos moved to amend the Traffic Engineers, Inc. Contract on the Los Tomates International Bridge Project, to include additional surveying for the Levee Relocation by Holdar-Gomez and Associates, as recommended by the County Engineer.

The motion was seconded by Commissioner Rosenbaum and carried unanimously.

At this time, Judge Hinojosa reported that he had notification on Friday, March 29, 1996, that the Chief Engineer from Mexico had approved the County's conceptional engineering plans and noted that it was the first step towards the construction of the Los Tomates International Bridge.

Judge Hinojosa added that he had met with the Regional Director of the Economic Development Administration regarding the Los Indios Bridge and reported that the County was in the process of applying for a Planning Grant in the amount \$75,000.00 for the Project.

There was some discussion regarding the financial status of the Los Tomates Project, and the costs incurred by the County and the reimbursements to be provided by the Bond issues.

(21) APPROVAL OF A PROFESSIONAL SERVICES CONTRACT WITH CROSLIN AND ASSOCIATES TO PREPARE A PROPOSAL FOR A JUVENILE BOOT CAMP AT THE ARMORY IN SAN BENITO AND TO DESIGNATE THE FUNDING SOURCE

At this time, Mr. Michael Martin, County Engineer, stated that final wording had been corrected on the Contract and sent to Croslin and Associates for signature.

Upon motion by Commissioner Rosenbaum, seconded by Commissioner Peña and carried unanimously, the Professional Services Contract with Croslin and Associates, Austin, Texas, was approved, in order to prepare a Proposal for a Juvenile Boot Camp at the Armory in San Benito, said funding to be allocated from Fund No. 5, Bond Fund.

The County Auditor stated that Fund No. 5, with the available amount of \$500,000.00 from Bond proceeds and remaining Interests would be utilized for the Project.

At this time, Judge Hinojosa questioned whether said funds could be utilized for the Parking Garage Project.

The County Auditor responded that the Bond Funds were specific as to the utilization and added that the funds could possibly assist in the smaller parking lot projects.

There was some discussion concerning the limited space available for parking around the Courthouse and the options available to utilize the area around the warehouse.

(22) APPROVAL OF THE TEXAS DEPARTMENT OF HEALTH DOCUMENT #7460004207 97; CONTRACT FOR PUBLIC HEALTH SERVICES FOR FISCAL YEAR 1997

Commissioner Peña moved that the Texas Department of Health Document No. 7460004207 97; Contract for

Public Health Services for Fiscal Year 1997, be approved.

The motion was seconded by Commissioner Rosenbaum and carried unanimously.

(28) EXECUTIVE SESSION

Upon motion by Commissioner Matz, seconded by Commissioner Peña and carried unanimously, the Court met in Executive Session at 2:30 P.M. to discuss the following matters:

The motion was seconded by Commissioner Peña and carried unanimously.

c) Confer with County Counsel concerning authorization to retain outside Counsel to represent former County employee concerning conduct while employed by the County.

Judge Hinojosa reported that after some discussion, it was the consensus of the Court as determined by polling that outside Counsel should be retained to represent a former County employee concerning conduct while employed by the County.

Upon motion by Commissioner Cascos, seconded by Commissioner Rosenbaum and carried unanimously, outside Counsel was retained to represent a former County employee concerning conduct while employed by the County, and County Counsel was directed to proceed along the terms and conditions as outlined in Executive Session.
