The meeting was called to order by Judge Gilberto Hinojosa. He then asked Mr. Bob Clark, Brownsville resident, for the invocation and Commissioner Cascos to lead the Court and the audience in reciting the Pledge of Allegiance.

LUCINO ROSENBAUM, JR.

The Court considered the following matters as posted and filed for Record in the Office of the County Clerk on April 4, 1996, at 2:10:

#### (1) APPROVAL OF COUNTY CLAIMS

At this time, Mr. Mark Yates, County Auditor, added the late claims as to Warrant Nos. 10598 through 10741 in the amount of \$23,373.00, for approval.

Upon motion by Commissioner Peña, seconded by Commissioner Cascos and carried unanimously, the County Claims were approved as presented by the County Auditor, inclusive of the late claims as to Warrant Nos. 10598 through 10741.

The Warrant List and the Budget Officer's Comments are as follow:

### (2) IN THE MATTER OF THE BUDGET AMENDMENTS AND/OR SALARY SCHEDULES (NO ACTION TAKEN)

The County Auditor reported that there were no Budget Amendments and/or Salary Schedules for approval at this time.

### (3) APPROVAL OF THE MINUTES OF MARCH 26, 1996

Upon motion by Commissioner Matz, seconded by Commissioner Peña and carried unanimously, the Minutes of the Regular Meeting held March 26, 1996, at 1:30 P.M., were approved.

## (5) IN THE MATTER TO IMPLEMENT A CAMERON COUNTY - PRODUCTS AND EQUIPMENT EVALUATION AND STANDARDIZATION COMMITTEE (TABLED)

At this time, Judge Hinojosa suggested that the Item be Tabled until a Policy Committee was created, in order to review and maintain consistency in the Policies submitted by the Departments, and recommended that the Policy Committee should consist of one (1) representative from the County Judge's Office, the County Attorney's Office, the Auditor's Office, the Personnel Department, and the County Clerk's Office.

Commissioner Cascos suggested that the Policies and other voluminous Agenda Requests Items be submitted to the Court one (1) week before the Meetings in order to accurately review the material.

Upon motion by Commissioner Cascos, seconded by Commissioner Peña and carried unanimously, this Item was **TABLED**.

# (4) PRESENTATION BY MR. BILL HAMMOND, CHAIRMAN, TEXAS WORKFORCE COMMISSION, REGARDING CERTIFICATION OF LOCAL WORKFORCE DEVELOPMENT BOARD

At this time, Judge Hinojosa reported that Cameron County was the first County in the State of Texas to have the local Workforce Development Board certified and introduced Mr. Bill Hammond, Chairman of the Texas Workforce Commission, and Mr. Rene Oliveira, State Representative, who was responsible for the Legislation.

Mr. Bill Hammond, Chairman of the Texas Workforce Commission, presented the Court with a certification of the Cameron County Local Workforce Development Board and highlighted the responsibilities involved in serving on the Board.

At this time, Judge Hinojosa recognized Mr. Raul Garcia, Private Industry Council, and Ms. Liz Maldonado, Texas Employment Commission, and highlighted the work to be performed in order to meet the demands of the Legislation.

Commissioner Peña moved that the Presentation by Mr. Bill Hammond, Chairman of the Texas Workforce Commission, regarding certification of the Cameron County Local Workforce Development Board, be acknowledged.

The motion was seconded by Commissioner Matz and carried unanimously.
