The meeting was called to order by Judge Gilberto Hinojosa. He then asked Mr. Bob Clark, Brownsville resident, for

the invocation and Commissioner Cascos to lead the Court and the audience in reciting the Pledge of Allegiance.

The Court considered the following matters as posted and filed for Record in the Office of the County Clerk on June 28, 1996, at 11:39 A.M.:

(3) IN THE MATTER OF THE MINUTES OF JUNE 11, 1996, AND JUNE 18, 1996 (TABLED)

Upon motion by Commissioner Matz, seconded by Commissioner Rosenbaum and carried unanimously, this

Item was TABLED.

(4) PRESENTATION BY MR. GORDON HILL, MANAGER OF BAYVIEW IRRIGATION DISTRICT, CONCERNING WATER CONSERVATION PRACTICES ADOPTED IN THE BAYVIEW AREA

At this time, Mr. Gordon Hill, Manager of Bayview Irrigation District, highlighted the conservation measures

taken by the Irrigation District, the reduced water consumption, and the rates as presented in Exhibit "A" and "B".

Commissioner Matz moved that the presentation by Mr. Gordon Hill, Bayview Irrigation District Manager, be

acknowledged concerning the Water Conservation Practices adopted in the Bayview area.

The motion was seconded by Commissioner Peña and carried unanimously.

The Exhibits are as follow:

(1) APPROVAL OF COUNTY CLAIMS

At this time, Mr. Mark Yates, County Auditor, highlighted the Tax Rates as displayed in the Budget Officer's

Comments Report and presented the following late claims for approval:

Warrant No. 69290, Mr. Juan Murillo, Deputy Constable Precinct No. 8, in the amount of \$570.00,

Warrant No. 77310, Davis Office, in the amount of \$4,700.00,

Warrant No. 77311, Davis Office, in the amount of \$282.00, and

Warrant No. 77312, Davis Office, in the amount of \$564.00.

Upon motion by Commissioner Rosenbaum, seconded by Commissioner Peña and carried unanimously, the County Claims were approved as presented by the County Auditor, inclusive of the late claims as to Warrant No. 69290, in the amount of \$570.00, Warrant No. 77310, in the amount of \$4,700.00, Warrant No. 77311, in the amount of \$282.00, and Warrant No. 77312, in the amount of \$564.00.

The Budget Officer's Comments are as follow:

(2) APPROVAL OF BUDGET AMENDMENTS AND/OR SALARY SCHEDULES

Commissioner Rosenbaum moved that the Fiscal Year 1996 Budget Amendment No. 96-14 and the following

Salary Schedules, be approved:

Computer Center - Fund No. 10-408;

Maintenance and Operation Precinct No. 4 - Fund No. 15-620;

Maintenance and Operation Precinct No. 1 - Fund No. 15-617;

District Attorney/Impact Court - Fund No. 21-478;

District Attorney/Impact Court - Fund No. 21-477;

District Attorney/High Intensity Drug Trafficking Areas (HIDTA) Task Force - Fund No. 22-471;

District Attorney/Drug Enforcement - Fund No. 50-476; and

District Attorney/Drug Enforcement - Fund No. 50-474.

The motion was seconded by Commissioner Peña and carried unanimously.

The Budget Amendment and Salary Schedules are as follow:

(8) AUTHORIZATION TO FUND THE CAMERON COUNTY'S PRO-RATA SHARE OF THE REGIONAL MOBILITY TASK FORCE BUDGET, IN THE AMOUNT OF \$26,002.00

At this time, Mr. Alan Johnson, Rio Grande Valley Mobility Task Force, requested that Cameron County contribute and participate in the Regional Mobility Plan developed by the Rio Grande Valley Partnership. He briefly explained the significant data and effectiveness of the Program and noted that the return on the investments per citizen would be the estimated amount of \$1,000.00 over the next year. Mr. Johnson stated that the one time contribution would be allocated in a general pool which would also fund the Interstate 69 Project.

Judge Hinojosa stated that the Texas Department of Transportation would resolve matters which would affect

the Transportation funding issues for the County and added that the benefits would greatly impact the County.

There was some discussion concerning the County employees traveling as representatives of said Project and whether the County would be funded by the Rio Grande Valley Partnership and the suggestion was made to review said issue and create a policy in order to clarify the County's contribution to the Project.

Commissioner Cascos moved that Cameron County's Pro-rata Share of the Regional Mobility Task Force Budget be funded in the amount of \$26,002.00.

The motion was seconded by Commissioner Peña and carried unanimously.

(5) REPORT TO THE COMMISSIONERS' COURT ON THE REVISIONS TO THE PARKS SYSTEM OPERATIONS PROCEDURES REGARDING TRAFFIC/PARKING MANAGEMENT IN COUNTY PARKS

At this time, Mr. Kenneth Conway, Parks System Director, reported that a Towing Fee limit had been implemented with a maximum amount of \$75.00 for towing and \$10.00 for storage, per night; signage had been replaced for clarity, and a six (6) weeks summary of the towed and ticketed vehicles had been conducted.

Commissioner Cascos expressed concern regarding the actions to be taken in the future regarding the public

concerns of excess towing and questioned whether the policies had changed with respect to the towing situation.

Mr. Conway responded that the Parking Laws would still be enforced resulting in the issuance of tickets and

vehicles being towed under hazardous conditions.

Judge Hinojosa recommended that the vehicles should not be ticketed and towed unless proper signage was displayed and suggested that the citizens should be notified as to the location of their vehicles for retrieval.

Commissioner Cascos suggested that a policy should be adopted with the modified rules and regulations in order to cover the County and the suggestion was made that the decisions of ticketing and towing of the vehicles should be determined by management.

Judge Hinojosa noted that the parking shortage and funding at the Isla Blanca Park was still a problem in regards to the pavilion being demolished for additional parking and stated that the Bond covenants should be eliminated with respect to utilizing funds outside the Parks System as recommended by the State Comptroller's Office. He suggested that the bonds be refinanced while the Bond Market was favorable and noted that additional funds needed to be generated for the demolition of the pavilion, and recommended that the Parks System Director review and submit a proposed Capital Improvement Plan for the Parks System.

Upon motion by Commissioner Matz, seconded by Commissioner Rosenbaum and carried unanimously, the Report to the Commissioners' Court on the revisions to the Parks System Operations Procedures regarding the Traffic/Parking Management in County Parks, was acknowledged.

(6) ADOPTION OF A PROCLAMATION DECLARING JULY 4, 1996, AS "BETTY PACE DODD DAY" IN CAMERON COUNTY

Commissioner Cascos moved that the Proclamation declaring July 4, 1996, as "Betty Pace Dodd Day" in Cameron County be adopted.

The motion was seconded by Commissioner Rosenbaum and carried unanimously.

The Proclamation is as follows:

(7) AUTHORIZATION TO CREATE A STRATEGIC PLANNING AND BUDGET REVIEW COMMITTEE

At this time, Ms. Graciela Salinas, Director of Management, stated that the Budget Review Committee was

being created, in order to review the expanded levels of funding and department goals and suggested that the following

individuals be appointed to the Committee:

Mr. Frank Bejarano, Program Development and Management Director.

Judge Hinojosa noted that significant recommendations would be made by the State Comptroller's Office with

respect to the structure of the County's government which would affect funding and added that the Budget should

include future funding for the structural changes.

Upon motion by Commissioner Cascos, seconded by Commissioner Rosenbaum and carried unanimously, the

Budget Review Committee was created as outlined.

(9) AUTHORIZATION TO FUND REPAIRS FOR COMMUNITY PARKS AND POOLS

At this time, Commissioner Peña requested funding in the amount of \$5,000.00 to \$6,000.00, for electrical

lines and proper signage as recommended by the surveyors, in order for the County Parks to appear favorable when

reviewed for Grant Funds.

Commissioner Peña moved that the Community Parks and Pools be funded in the amount up to \$6,000.00 for

repairs.

The motion was seconded by Commissioner Rosenbaum and carried unanimously.

(10) APPROVAL TO ACCEPT THE FEDERAL ALLOCATION OF FUNDS IN THE AMOUNT OF \$23,773.00, FOR THE COUNTY'S PARTICIPATION IN THE STATE AND LOCAL ASSISTANCE-EMERGENCY MANAGEMENT PROGRAM (SLA-EMA) FOR THE FISCAL YEAR 1996, EFFECTIVE OCTOBER 1, 1995, THROUGH SEPTEMBER 30, 1996

Upon motion by Commissioner Cascos, seconded by Commissioner Rosenbaum and carried unanimously, the

Federal Allocation of funds in the amount of \$23,773.00, was accepted for the County's participation in the State and

Local Assistance-Emergency Management Program (SLA-EMA) for the Fiscal Year 1996, effective October 1, 1995,

through September 30, 1996.

(11) APPROVAL OF A MUTUAL AID AGREEMENT BETWEEN THE COUNTY OF CAMERON AND THE CITIES WITHIN CAMERON COUNTY

Commissioner Matz moved that the Mutual Aid Agreement between the County of Cameron and the Cities

within Cameron County be approved.

The motion was seconded by Commissioner Peña and carried unanimously.

The Agreement is as follows:

(12) AUTHORIZATION TO PURCHASE MOBILE AND PORTABLE COMMUNICATIONS EQUIPMENT (TRANSPORTABLE SATELLITE TELEPHONE AND SERVICE AND OTHER RELATED EMERGENCY MANAGEMENT SUPPLIES) FOR THE COUNTY'S EMERGENCY OPERATING CENTER (EOC)

At this time, Judge Hinojosa stated that the communications equipment was needed for emergency situations as recommended by the State Comptroller's Office. He noted that the one time funding would be obtained from the position of the Emergency Management Coordinator that had not been filled and suggested that each Precinct and Law Enforcement purchase a transportable satellite telephone in order to negotiate a reduced cost for each individual phone.

Commissioner Rosenbaum moved that the mobile and portable communications equipment; that being

transportable satellite telephone and service and other related emergency management supplies, be purchased for the

County's Emergency Operating Center (EOC).

The motion was seconded by Commissioner Peña and carried unanimously.

(13) AUTHORIZATION AND ACKNOWLEDGMENT TO SUBSTITUTE PLEDGE SECURITIES

Commissioner Cascos moved that the Pledge Securities be substituted by the International Bank of
