The meeting was called to order by Judge Gilberto Hinojosa. He then asked Mr. Bob Clark, Brownsville resident, for the invocation and Commissioner Cascos to lead the Court and the audience in reciting the Pledge of Allegiance.

The Court considered the following matters as posted and filed for Record in the Office of the County Clerk on July 5, 1996, at 11:23 A.M.:

#### (1) APPROVAL OF COUNTY CLAIMS

Upon motion by Commissioner Matz, seconded by Commissioner Cascos and carried unanimously, the County claims were approved as presented by the County Auditor.

The Budget Officer's Comments Report is as follows:

### (2) IN THE MATTER OF THE BUDGET AMENDMENTS AND/OR SALARY SCHEDULES (NO ACTION TAKEN)

At this time, the County Auditor reported that there were no Budget Amendments and/or Salary Schedules for approval.

#### (3) APPROVAL OF THE MINUTES OF JUNE 11, 1996 AND JUNE 18, 1996 (TABLED)

Upon motion by Commissioner Matz, seconded by Commissioner Cascos and carried unanimously, the Minutes of the Regular Meeting held June 11, 1996, at 1:30 P.M., were approved, subject to the correction on the Supplemental Agenda, Item No. 1, and the Minutes of June 18, 1996, were TABLED.

At this time, Judge Hinojosa recognized Mr. Joe G. Rivera, County Clerk, who was designated "County Clerk of the Year" by the County and District Clerks' Association and noted that the County Clerk's Office was one of the most efficient and effective Offices in the State.

Mr. Joe G. Rivera, County Clerk, expressed his gratitude to the Court, Department Heads and employees.

## (4) APPROVAL TO UTILIZE SLOT NO. 10, FOR TEMPORARY PART-TIME HELP IN THE COUNTY CLERK'S OFFICE EFFECTIVE JULY 8, 1996, THROUGH SEPTEMBER 30, 1996

Commissioner Matz moved that Slot No. 10 be utilized for temporary part-time help in the County Clerk's Office, effective July 8, 1996, through September 30, 1996.

At this time, Mr. Michael Martin, County Engineer, highlighted the Request for Proposals Report on the Roadway Route Studies, Environmental Reviews, and Strip Map Development Services, and noted that the County had saved funds through Right-of-Way Acquisitions.

There was some discussion regarding the allocation of the Project Roadmap funds for Right-of-Way acquisitions for a portion of the Railroad Relocation Project, and the suggestion was made for the County Attorney to contact Bond Council for direction regarding said matter.

Upon motion by Commissioner Matz, seconded by Commissioner Cascos and carried unanimously, the Advertisement of Proposals for Route Studies, Environmental Reviews and Strip Map Development Services, were authorized as part of Project Roadmap.

#### **SUPPLEMENTAL AGENDA**

(1) AUTHORIZATION TO SUPPORT A COASTAL MANAGEMENT PROGRAM GRANT APPLICATION TO CREATE YOUTH CAMP FACILITIES IN ISLA BLANCA PARK IN CONJUNCTION WITH THE BOYS SCOUTS

At this time, Judge Hinojosa explained that the Rio Grande Valley Boys Scouts Council's intention was to create a permanent facility in South Padre Island, Texas, to be utilized for Youth Programs in the County. He noted that an informal Agreement was to be formalized specifying that any structure or facility removed at the proposed site would be at the Boys Scouts' expense and that the County would not be liable if the Lease was terminated, and added that the County needed additional information from the Texas General Land Office in order to clarify the terms of the Lease.

Mr. Glenn Harrison, Laguna Station Camp Director, stated that there were time constraints for the submission of the Application and noted that the support from the County would be the basis of discussions between all entities involved. He requested that a County Official assist the Boys Scouts in presenting the Program to the Texas General Land Office, and Judge Hinojosa remarked that his Administrative Assistant would represent the County and suggested that a Fee be implemented for the use of the proposed facility for maintenance expenses and revenues for the County.

Commissioner Matz moved that the Coastal Management Program Grant Application be supported to create the Youth Camp Facilities in Isla Blanca Park in conjunction with the Boys Scouts, subject to the Resolution containing language that the Application be approved and that negotiations be made with the Rio Grande Valley Boys Scouts Council and the Texas General Land Office.

The motion was seconded by Commissioner Cascos and carried unanimously.
