ABSENT:

The meeting was called to order by Judge Gilberto Hinojosa. He then asked Pastor Gayle Gardner, Good Shepherd Church, for the invocation and Commissioner Cascos to lead the Court and the audience in reciting the Pledge of Allegiance.

The Court considered the following matters as posted and filed for Record in the Office of the County Clerk on October 18, 1996, at 1:30 P.M.:

(3) ADOPTION OF THE RESOLUTION HONORING MS. BLANCA S. VELA

At this time, Judge Hinojosa presented a Resolution to Ms. Blanca S. Vela, Brownsville, Texas, and briefly

highlighted her accomplishments and her humanitarian efforts toward the community.

Ms. Blanca Vela, Brownsville, Texas, expressed her gratitude to the Court and audience.

Upon motion by the Commissioners' Court, and carried unanimously, the Resolution honoring Ms. Blanca S.

Vela, Brownsville, Texas, was adopted.

The Resolution is as follows:

(11) ADOPTION OF AN ORDER ALLOCATING INDEBTEDNESS ON APPROXIMATELY 320 ACRES OF TERRITORY, DETACHED FROM SAN BENITO CONSOLIDATED INDEPENDENT SCHOOL DISTRICT, AND ANNEXED TO THE HARLINGEN CONSOLIDATED INDEPENDENT SCHOOL DISTRICT 1994

At this time, Mr. Ramiro T. Flores, Harlingen Consolidated Independent School District, explained that the Order was necessary in order to comply with the Texas Education Board's requirement to allocate the debt, due to the annexation that occurred in 1994.

Commissioner Cascos moved that the Order be adopted allocating indebtedness on approximately 320 acres of territory detached from the San Benito Consolidated Independent School District, and annexed to the Harlingen Consolidated Independent School District in 1994.

The motion was seconded by Commissioner Matz and carried unanimously.

(1) APPROVAL OF COUNTY CLAIMS

At this time, Mr. Mark Yates, County Auditor, noted that the Auditor's office would present adjustments on the subsequent Agenda to the County Retirement System which would determine the Retirement Age and would change the County contribution to 7.42%. He presented a late claim as to Warrant No. 22704, Atwood Park Construction Fund, in the amount of \$41,500.00, for approval.

Upon motion by Commissioner Peña, seconded by Commissioner Rosenbaum and carried unanimously, the County Claims were approved as presented by the County Auditor, inclusive of the late claim as to Warrant No. 22704, in the amount of \$41,500.00.

The Budget Officer's Comments Report is as follows:

(2) APPROVAL OF BUDGET AMENDMENTS AND/OR SALARY SCHEDULES

At this time, Mr. Mark Yates, County Auditor, stated that a new Juvenile Court Bailiff position had been requested by the District Judges and suggested that the funding be allocated from the Lapsed Salaries in the Sheriff's Department.

Commissioner Cascos questioned whether the Lapsed Salary would be transferred back to the Fund Balance once the obligation for the Juvenile Court Bailiff position was met, and the County Auditor responded that the Lapsed Salaries would automatically transfer to the Fund Balance.

Commissioner Peña moved that the Fiscal Year 1997 Budget Amendment No. 97-03 and the following Salary

Schedules be approved:

Commissioner Peña moved that the Contract for Residential Child Care Services under the Cameron County

At this time, Mr. Mariano Ayala, Personnel/Safety Risk Coordinator, explained that the Enrollment Procedure would allow the Personnel Office to be aware of the vacancies, review the applications and set up interviews at the Department's request and added that the information would also be cleared through the Auditor's Office, in order to determine available funding.

Judge Hinojosa stated that the applicants would be required to be cleared by the Personnel Department and the Auditor's Office, in order to be funded, and added the procedure would eliminate the hiring of individuals without the authorization for funding. He noted that the Project was a positive move for the unified Personnel Policy System in the County and suggested that the Personnel Director should schedule a Workshop with the Auditor and the Department Heads, in order to clarify the regulations and procedures of the Project.

Upon motion by Commissioner Matz, seconded by Commissioner Cascos and carried unanimously, County Counsel was directed to negotiated the terms of the Contract regarding the Development of the property located at Isla Blanca Park.

f) Discuss with County Counsel for the potential litigation regarding the Adult Probation Office Project, concerning the Termination of the Contract with Richard Mycue, Architect, and the authority to settle the dispute with Mr. Mycue, and to bring suit if the settlement cannot be effected;

- g) Discuss with County Counsel for the potential litigation regarding the Dancy Building, concerning the Termination of the Contract with Richard Mycue, Architect, and the authority to bring suit if settlement cannot be effected; and
- h) Confer with County Counsel for the authority to retain Employment Law Attorney on the potential litigation under the Fair Labor Standards Act concerning the overtime compensation of Jailers/Deputies.

Mr. Doug Wright, Cameron County Counsel, recommended that the Status Reports by County Counsel should

be acknowledged regarding said matters and that the employment of the recommended Counsel by Mr. Richard Burst, County Counsel, should be authorized for the Training Seminar concerning the Fair Labor Standards Act regarding Item "h".

Upon by Commissioner Matz, seconded by Commissioner Peña and carried unanimously, the Status Reports by County Counsel were acknowledged regarding the potential litigation pertaining to the Adult Probation Office Project and the Dancy Building, concerning the Termination of the Contract with Richard Mycue, Architect, and the authority to settle the dispute with Mr. Mycue and to bring suit if the settlement cannot be effected; and the Employment of Counsel was authorized, as recommend by Mr. Richard Burst, County Counsel, regarding the retainment of the Employment Law Attorney, regarding the potential litigation under the Fair Labor Standards Act concerning overtime compensation of Jailers/Deputies.

I) In the matter of conferring with County Counsel on the possible litigation of the Darrell Hester Juvenile Center. **(TABLED)**

Upon motion by Commissioner Cascos, seconded by Commissioner Peña and carried unanimously, this Item

was TABLED.

 j) Confer with County Counsel regarding the Proposal submitted in response to the Request for Proposal No. 960708, to Lease and develop a 14.9 acre land tract in Isla Blanca Park.

Mr. Doug Wright, Cameron County Counsel, recommended that the Parks Advisory Board should review and

report to the Court regarding said matter.

Upon motion by Commissioner Matz, seconded by Commissioner Rosenbaum and carried unanimously, the

Parks Advisory Board was directed to review and report to the Court regarding the Proposal submitted in response to

the Request for Proposal No. 960708, to lease and develop a 14.9 acre land tract in Isla Blanca Park.

- k) In the matter of conferring with County Counsel regarding the Evaluation of Ms. Alicia Guerrero, in the capacity of Law Library Supervisor;
- In the matter of conferring with County Counsel regarding the Evaluation of Mr. Salvador Salinas, in the capacity of Veterans Service Officer; and

m) In the matter of conferring with County Counsel regarding the Evaluation of Mr. Leobardo Pompa, in the capacity of Reproductive Supervisor.

Upon motion by Commissioner Cascos, seconded by Commissioner Matz and carried unanimously, these Items were **TABLED**.

There being no further business to come before the Court, upon motion by Commissioner Matz, seconded by

Commissioner Peña and carried unanimously, the meeting was ADJOURNED.
