The meeting was called to order by Judge Gilberto Hinojosa. He then asked Mr. Bob Clark, Brownsville resident, for the invocation and Commissioner Benavides to lead the Court and the audience in reciting the Pledge of Allegiance.

The Court considered the following matters as posted and filed for Record in the Office of the County Clerk on January 3, 1997, at 10:09 A.M.:

At this time, Mr. Mark Yates, County Auditor, presented an additional late claim as to Quest Software Systems, Warrant No. 27109, in the amount of \$5,800.00.

Upon motion by Commissioner Matz, seconded by Commissioner Peña and carried unanimously, the County Claims were approved as presented by the County Auditor, inclusive of the additional late claim, as to Warrant No. 27109, in the amount of $\$ 5,800.00$, for approval.

## (2) APPROVAL OF BUDGET AMENDMENTS AND/OR SALARY SCHEDULES

Garza, City of Brownsville Heritage Officer, explained that the Resolution was reviewed and adopted annually by all the participating taxing entities and noted that the City of Brownsville had adopted the 1996 Brownsville Heritage Plan with amendments to the Resolution, which allowed the Alonso Building to receive a one hundred percent (100\%) ad valorem tax abatements.

He added that the cost of the Project would be $\$ 5,000.00$. and noted that half of the cost would be allocated from the Gateway Bridge Fund.
