The meeting was called to order by Judge Gilberto Hinojosa. He then asked Mr. Bob Clark, Brownsville resident, for the invocation and Commissioner Cascos to lead the Court and the audience in reciting the Pledge of Allegiance.

The Court considered the following matters as posted and filed for Record in the Office of the County Clerk on January 24, 1997, at 9:33 A.M.:

At this time, Judge Hinojosa reported that a Deputy Constable would patrol the Courthouse Parking Lot during the Commissioners= Court Meetings, due to the vandalism of vehicles and added that lighting would be installed in the parking areas of the Courthouse by the Public Utilities Board.

## (1) APPROVAL OF COUNTY CLAIMS

At this time, Mr. Mark Yates, County Auditor, presented the Budget Time Table for the Fiscal Year 1998 and requested input from the Court regarding the Five (5) Year Capital Improvement Projects.

There was some discussion regarding the Law Enforcement Satellite Stations throughout the County, the Consolidation of the County Clerk, the Tax Assessor-Collector and the Justice of the Peace Offices and Judge Hinojosa suggested that Request for Proposals be advertised for Architectural Services to design the same set of plans for each Satellite Station in the County.

Mr. Omar Lucio, Cameron County Sheriff, stated that several entities within the County had offered office space, buildings and telephone service for temporary Satellite Stations, at no cost to the County, and added that the Brownsville Independent School District offered the Vela Middle School Gymnasium for the Deputy Sheriffs.

Mr. Yates reported that the Construction Manager position had been advertised and recommended that said individual should examine locations and a prototype building for the Satellite Station Project; noting that the Project could be performed in-house.

Upon motion by Commissioner Cascos, seconded by Commissioner Peña and carried unanimously, the County Claims were approved as presented by the County Auditor.
