The meeting was called to order by Judge Gilberto Hinojosa. He then asked Mr. Bob Clark, Brownsville resident, for the invocation and Commissioner Cascos to lead the Court and the audience in reciting the Pledge of Allegiance.

The Court considered the following matters as posted and filed for Record in the Office of the County Clerk on January 31, 1997, at 2:15 P.M., and the Supplemental Agenda posted and filed for Record on January 31, 1997, at 3:23 P.M.:

(1) APPROVAL OF COUNTY CLAIMS

At this time, Mr. Mark Yates, County Auditor, highlighted the Tax Collection as referenced in the Budget Officer-s Comments Report and presented an additional late claim as to the Texas Recreation and Parks System (T.R.A.P.S), Warrant No. 28855, in the amount of \$1,092.50, for approval.

Upon motion by Commissioner Matz, seconded by Commissioner Cascos and carried unanimously, the County Claims were approved as presented by the County Auditor, inclusive of the additional late claim, as to Warrant No. 28855, in the amount of \$1,092.50.

(2) APPROVAL OF BUDGET AMENDMENTS AND/OR SALARY SCHEDULES

At this time, Commissioner Cascos questioned whether the amount of the District Attorney-s Hot Check Fund was an increase or an offset and the County Auditor responded that the Budget was set up yearly for said Fund, which was an offset to the Budget.

(5) ADOPTION OF A RESOLUTION AUTHORIZING THE SUBMITTAL OF A GRANT APPLICATION TO THE TEXAS DEPARTMENT OF HOUSING AND COMMUNITY AFFAIRS, UNDER THE TEXAS COMMUNITY DEVELOPMENT DISASTER RELIEF FUND

Upon motion by Commissioner Cascos, seconded by Commissioner Matz and carried unanimously, the

Resolution authorizing the submittal of a Grant Application to the Texas Department of Housing and Community

Affairs, under the Texas Community Development Disaster Relief Fund, was adopted.

(8) ADOPTION OF A CHANGE IN THE HOUR OF DAY FOR THE REGULAR COMMISSIONERS= COURT MEETINGS FROM 5:05 P.M. TO 4:00 P.M. AND LEAVING TUESDAY AS THE DESIGNATED DAY OF THE WEEK FOR THE MEETING

At this time, Commissioner Cascos expressed his support for the hour change of the Meetings, with the condition that the Executive Session be held at 4:00 P.M. and that the Regular Meeting begin after 5:00 P.M. to allow public participation, but noted that his preference was to retain the hour of 5:05 P.M.

Judge Hinojosa expressed his opposition to the hour change and added that the Commissioner-s Court was the

only Governmental Entity in the County that held the public meetings during the day, which was unfair to the public.

The County Auditor suggested that the Bid Openings be read for the record before 5:00 P.M. and added that

the hour change of 5:00 P.M. caused conflicts with certain County Officials= participation at City Commission

Meetings held throughout the County.

Commissioner Cascos moved that the change in the hour of the day for the Regular Commissioners=Court

Meetings from 5:05 P.M. to 4:00 P.M. be adopted, and that Tuesday be retained as the designated day of the week for

the Meetings; with the caveat that the Executive Session Items be held at 4:00 P.M. and that the Regular Meeting begin

after 5:00 P.M. to ensure public participation.

The motion was seconded by Commissioner Matz and carried as follows:

NAY: Judge Hinojosa.

(9) IN THE MATTER OF IMPROVEMENTS TO A CERTAIN ROAD PROVIDING ACCESS TO THE LEAL SUBDIVISION, RANGERVILLE, TEXAS, CAMERON COUNTY PRECINCT NO. 4 (TABLED)

(10) IN THE MATTER OF PROVIDING EGRESS AND INGRESS ON HERNANDEZ ROAD (TABLED)

There was some discussion regarding the maintenance of said road by the County, and whether the road was

out of the city limits, and the suggestion was made that this Item be Tabled for further evaluation and research.

Upon motion by Commissioner Peña, seconded by Commissioner Cascos and carried unanimously, these

Items were (TABLED) for one (1) week.

(11) ACTION ON THE RELOCATION OF THE PERSONNEL DEPARTMENT AND THE COMMISSIONERS= COURT LEGAL DIVISION AND AUTHORIZATION FOR THE NECESSARY CONSTRUCTION TO IMPLEMENT THE RELOCATION

At this time, Mr. Doug Wright, Cameron County Counsel, stated that the cost of said Project would be the

amount of \$500.00 to \$1,000.00, noting that said funding would be allocated from the Courthouse Maintenance and

Operation Fund.

Upon motion by Commissioner Cascos, seconded by Commissioner Peña and carried unanimously, the

relocation of the Personnel Department and the Commissioners=Court Legal Division, and the necessary construction

to implement the relocation were approved.

(12) IN THE MATTER OF THE CONTRACT FOR JANITORIAL/CUSTODIAL SERVICES AT THE LA FERIA BRANCH-TAX OFFICE BETWEEN IRMA C. FLORES AND CAMERON COUNTY (TABLED)

At this time, there was some discussion concerning the Contract being reviewed by County Counsel and the

Tax Assessor-Collector prior to the Meeting and the suggestion was made to Table the Item for further review.

Upon motion by Commissioner Peña, seconded by Commissioner Cascos and carried unanimously, this Item

was (TABLED) for one (1) week, subject to Legal review of the Contract.

(13) APPROVAL TO REVISE AND UPDATE ANY AND ALL SIGNATURE CARDS, WHERE APPLICABLE UNDER THE SUPERVISION OF MS. YOLANDA DE LEON/COUNTY (CRIMINAL DISTRICT) ATTORNEY WITH THE INTERNATIONAL BANK OF COMMERCE

Commissioner Matz moved that the Signature Cards be revised and updated, where applicable, under the

Supervision of Ms. Yolanda de Leon/County (Criminal District) Attorney with the International Bank of Commerce.

Commissioner Matz moved that Bids be solicited for the Annual Rental of a Commercial Brochure Rack at

the new Isla Blanca Park Registration Office.

The motion was seconded by Commissioner Cascos and carried unanimously.

(15) ACTION ON THE POSSIBLE CONSTRUCTION OF A WAREHOUSE FOR THE STORAGE OF SEIZED VEHICLES

At this time, Mr. Lee Lozano, Fleet Maintenance Director, reported that the space for the storage of vehicles

was costly and suggested that a storage warehouse be built to store the County vehicles.

Judge Hinojosa stated that once the Road Consolidation was in effect, all the equipment would be

consolidated into the Precinct No. 3 Warehouse and added that a Security Guard would be hired to protect the assets at

the facility. He suggested that the best approach would be to secure the existing fence, which would save the County

the cost of obtaining an additional warehouse.

Upon motion by Commissioner Cascos, seconded by Commissioner Matz and carried unanimously, the

possible construction of a warehouse for the storage of seized vehicles was acknowledged.

(16) AUTHORIZATION TO OPEN A NEW CELLULAR SERVICE LINE FOR THE CAMERON PARK INSPECTOR

Commissioner Cascos moved that a new Cellular Service Line be opened for the Cameron Park Inspector.

The motion was seconded by Commissioner Peña and carried unanimously.

(17) IN THE MATTER OF AWARDING THE CONTRACT TO DANNEBAUM ENGINEERING FOR THE UNIT ROAD CONSOLIDATION PROJECT (TABLED)

At this time, Judge Hinojosa recommended that a Proposal be submitted to the Court within ninety (90) days

by the Road Consolidation Committee.

Commissioner Matz suggested that the Committee should evaluate the two (2) Proposals submitted in 1994,

noting that the Proposals contained a former County Engineer which could provide insights to said Project and

suggested that the Committee consult with other Counties utilizing the Road Consolidation System.

Judge Hinojosa recommended that the member of the Committee should tour Collins County and all the different Counties in the State that had good Consolidated Programs, noting that the expenses incurred by the Committee should be allocated from the Road and Bridge Budget.

Commissioner Matz stated that numerous information was submitted to the State Comptroller-s Office by the Precincts and suggested that the State Comptroller-s Audit be obtained to retrieve the information available, which would be useful for the Project.

Judge Hinojosa moved that this Item be (TABLED).

The motion was seconded by Commissioner Cascos.

At this time, Mr. Doug Wright, Cameron County Counsel, recommended that this item be finalized as opposed to being Tabled, by taking action to reject the negotiations and added that the Court had previously directed the Engineering Department to negotiated with Dannebaum to enter into the Contract.

Commissioner Cascos expressed concern regarding whether the Committee had the background to perform the work that an Engineer would do and added that there were two (2) members of the Committee that were not advocates of road consolidation.

Judge Hinojosa stated that the two (2) individuals had publicly announced their support for the Road Consolidation and added that they would do what was in the best interest of the County.

Upon motion duly made to Table this Item by Judge Hinojosa, seconded by Commissioner Cascos; the motion carried as follows:
